# CN/13/07 Establishment of the Health and Wellbeing Board and Consequential changes to the constitution

A report of the City Solicitor was submitted which sought to establish a Health and Wellbeing Board under the Health and Social Care Act 2012 and to make consequential changes to the constitution.

The Health and Social Care Act places duties on local authorities to establish a health and wellbeing board for its area to discharge a number of core functions. The Act also requires local authorities to appoint a Director of Public Health to have responsibility for carrying out the Council's statutory functions relation to public health. The purpose of this report was to ask the Council to amend the constitution to make provisions for the Health and Wellbeing Board, to appoint members of the Health and Wellbeing Board and to make delegations to the Director of Public Health.

#### Decision

To recommend that the Council:

- 1. Establish a Health and Wellbeing Board pursuant to section 194 of the Health and Social Care Act 2012 with the terms of reference set out in Appendix 1 of the report.
- 2. Agree the changes to the Constitution of the Council set out in Appendix 2 of the report.
- 3. Approve the delegations to the Director of Public Health sent out in Appendix 3 of the report.
