#### CN/16/11 Draft submission on Council size for the Local Government Boundary Commission for England's Electoral Review of Manchester City Council

The Committee considered a report of the Chief Executive which presented the Council's draft submission on Council size to the Local Government Boundary Commission (LGBCE). The LGBCE had undertaken a review of the City Council's electoral arrangements and would make recommendations to Parliament on the total number of councillors that should be elected to the authority in the future in conjunction with the boundaries, names and number of councillors that represent each ward. The Committee was invited to approve the draft submission.

The Committee noted that since the last review had been conducted, the size of the electorate had increased and it was acknowledged that this trend was set to continue. However it was also acknowledged that, despite the associated impact on workloads, there was no appetite to increase the Authority's number of politicians. The Committee therefore approved the draft submission, as presented, in full.

# CN/16/12 Constitution of the Council

The Committee considered a report of the City Solicitor which presented amendments to the Council's Constitution in line with Section 9P of the Local Government Act (2000) which requires a local authority that operates executive arrangements to prepare and keep an up-to-date Constitution. - Part 6 Codes and Protocols (Sections A, D, E and G)
- Part 7 Members Allowances Scheme
- Part 8 Management Structure
