CC/14/65 Former Councillor Joyce Keller and Honorary Alderman, Dame Kathleen Ollerenshaw

The Lord Mayor reported the deaths of former Councillor Joyce Keller and Honorary Alderman Dame Kathleen Ollerenshaw.

Joyce Keller served as member for Sharston ward for 23 years and was Lord Mayor during 1995 and 1996. A retired headteacher, she made valuable contributions to the Education Committee and the Young People and Children Scrutiny Committee. She was a strong advocate of ensuring that pupils enjoyed the school experience.

Honorary Alderman, Dame Kathleen Ollerenshaw, served as a Manchester councillor for many years and was Lord Mayor between 1975 and 1976. She was an eminent mathematician, was passionate about education and contributed to this at a city, national and international level.

The Council and those present at its meeting then observed a period of silence in their memory.

CC/14/75 Motion – Legal Highs

Motion made and seconded:

Council notes the increase in use as a popular recreational drug of nitrous oxide commonly known as "Laughing Gas", the taking of which is not illegal.

The recreational use of "Laughing Gas" does have a detrimental effect on users health and can lead to oxygen deprivation, causing loss of blood pressure, fainting and heart attacks and prolonged use can cause anaemia, bone marrow suppression and poisoning of the nervous system.

The misuse of "laughing gas" coincides with an increasing use of legal highs which has seen deaths more than double in the last four years, resent figures reveal they killed more people in 2013 than ecstasy.

This council calls on the Chief Executive

- To initiate a public awareness campaign on the harmful effects of 'Laughing Gas' and other legal highs, funded from the public health budget.
- To lobby Government to introduce legislation that bans the sale of all 'psychoative' (brain altering) drugs and then exempts some, such as alcohol and tobacco.

Amendment made and seconded:

Leave in all up to second bullet point then replace second bullet point with the following –

"The Council will enforce all existing legislation that deals with nitrous oxide and set out clear policies that all licensed premises will restrict the sale of nitrous oxide. This will help licensed premises staff and licensees to promote the licensing objective of "Public Safety".

It is illegal to sell nitrous oxide for recreational purposes. Furthermore, that we will lobby the government to restrict the wording "Legal High" as any combination or concoction of substances that alter the physical and mental state are in fact "illegal" and we must attempt to stop the apathetic acceptance of the phrase "legal highs" which lends weight to the credibility of these dangerous mixes of substances."

Resolution
