CC/16/67 Draft Submission to the Local Government Boundary Commission

The Council considered the report of the Chief Executive which set out the Council's draft response to the Local Government Boundary Commission for England's (LGBCE) Review of Manchester's electoral ward boundaries.

The report set out the Council's draft response to the first stage of the consultation on the ward patterns for Manchester. The consultation asks the Council, councillors, local groups, stakeholders and residents to provide evidence about community interactions, geographical features and local circumstances to help draw up new ward boundaries which will accommodate the 96 councillors. The Council is requested to approve the draft submission.

The LGBCE will consider the proposals and will publish draft ward boundary proposals in November. The Council will consider its response to these proposals at its meeting in January. The Commission's final decision on the ward boundaries is expected in April 2017.
