CC/17/75 Recognising Outstanding and Exceptional Contributions to Manchester

The Council considered a report of the Chief Executive which proposed a new honours system to recognise outstanding and exceptional contributions to Manchester and for this to include honorary citizenship for those who live and work outside Greater Manchester.

The report included the following amendments required to be made to the Council Constitution:

At the end of Part 4, Section A of Manchester City Council's Constitution insert:

- 31. Honorary Titles and Awards
- 31.1 The Council may, by a resolution passed by not less than two thirds of the members voting thereon at a meeting of the Council specially convened for the purpose with notice of the object given, confer the title of honorary

- aldermen or alderwomen on persons who have, in the opinion of the Council, rendered eminent services to the Council as past members of the Council, but who are not then members of the Council.
- 31.2 The Council may, by a resolution passed by not less than two thirds of the members voting thereon at a meeting of the Council specially convened for the purpose with notice of the object given, admit to be honorary freemen or honorary freewomen of the city, persons of distinction and persons who have, in the opinion of the Council, rendered eminent services to the city.
- 31.3 The Council may, by resolution at a meeting of the Council specially convened for the purpose with notice of the object given, formally recognise the outstanding contributions and achievements of individuals and organisations whatever their field or expertise under either of the categories described in Rules 31.4 and 31.5 below (the making of such a resolution to be known as "The City of Manchester Award").
- 31.4 The first category referred to in Rule 31.3 (to be known as "Outstanding Contribution to Manchester") shall relate to an individual or organisation who lives, works or studies in the city and who has, in the opinion of the Council, made such an exceptional contribution to Manchester that it should be formally recognised and recorded in the city's history. Outstanding Contributions may arise from a one off event or specific achievement, or consistent excellence, which has had a positive impact on Manchester, its people or the city's reputation nationally or internationally.
- 31.5 The second category referred to in Rule 31.3 (to be known as "Honorary Mancunian") shall relate to an individual who does not live or work in the city but who by their actions has, in the opinion of the Council, made an exceptional contribution to the city, its people or the city's reputation nationally or internationally.

Amendment to the Constitutional and Nomination Committee Terms of Reference

At the end of the entry for the Constitutional and Nomination Committee in Part 3, Section C of Manchester City Council's Constitution insert:

4.16 the formal recognition of the outstanding contributions and achievements of individuals and organisations under Rule 31.3 of the Council Procedures Rules ("The City of Manchester Award").

CC/17/76 Motion – Public Pay Sector Gap

Motion proposed and seconded.

The Public Sector Pay Cap

This council notes that:

Pay freezes and pay caps for public sector workers have now been in place since 2010, with the real terms impact on workers running into thousands of pounds.

The squeeze on pay has had a disproportionate impact on women, with women making up two thirds of the public sector workforce.

The public supports an end to the pay squeeze. Recent independent polling carried out by Survation found that 75% of all voters support above inflation increases in public sector pay.

In particular, local government and school support staff receive the lowest pay in the public sector and Local terms and conditions of many NJC employees have been cut, impacting on their overall earnings.

This council believes that:

Public services and the people who deliver them are important.

Pay for public sector workers should not be set by arbitrary government pay caps, but by collective bargaining and Pay Review bodies.

The government needs to take responsibility and fully fund increases in pay; it should not put the burden on public sector employers such as local authorities whose funding has been cut to the bone.

This Council therefore resolves to:

Call on the Local Government Association to make urgent representations to the government to fund the NJC claim and pay spine review and to notify us of their action in this regard.

Write to the Prime Minister and Chancellor supporting the NJC claim and seeking additional funding to fund a decent pay rise and the pay spine review.

Meet with the local NJC union representatives (UNISON, GMB and Unite) to convey support for the pay claim and pay spine review.

Resolution

The motion was put to Council and voted on, and the Lord Mayor declared that it was carried.

The Local Government Association be called upon to make urgent representations to the government to fund the NJC claim and pay spine review and to notify the Council of their action in this regard.

A letter be sent to the Prime Minister and Chancellor supporting the NJC claim and seeking additional funding to fund a decent pay rise and the pay spine review.

A meeting take place with the local NJC union representatives (UNISON, GMB and Unite) to convey support for the pay claim and pay spine review.

CC/17/77 Motion – Policing Cuts – The Impact on Manchester

This Council recognises and greatly respects the hard work of Greater Manchester Police (GMP) in seeking to keep Manchester residents safe. This was especially evident in the aftermath of the Manchester Arena attack in May 2017, when GMP were not only involved in operations to bring to justice those involved in the attack, but also played a central role in the city's recovery efforts.

This Council notes that:

- the Chief Constable of GMP highlighted how GMP had 8,148 officers in March 2010, but that by March 2016 this had dropped to 6,297 officers;
- over the same period, Police Officers saw a fall in their median real earnings from £20 per hour to £18 per hour;
- the Government's recent announcement of an end to the public sector pay cap would mean a 1% pay increase and 1% "bonus" for police officers, which would still fall well short of the 2.9% rate of inflation;
- GMP have seen the number of crimes reported in the last 12 months increase by nearly a quarter on the previous 12 months;
- Greater Manchester Police Authority have been affected by cuts to funding, facing a cut in cash terms of approximately 1.4% for 2017/18, and that coupled with increasing costs this is a cuts budget with an estimated savings requirement of £21m;
- as with local authorities, police forces in cities such as Manchester have been disproportionately hit by funding cuts.

This Council fears that, in the words of PC Joseph Torkington, whose heart-breaking resignation letter was published in the Manchester Evening News, the police service is in danger of being "at breaking point".

This Council is further concerned that GMP, hampered by these cuts, leading in particular to a lack of "bobbies on the beat", are not always able to be as responsive as required. The need to prioritise the most serious crimes, means that an overstretched force cannot respond as quickly as they would like to crimes which may be deemed less serious, or to antisocial behaviour such as street drinking. But these are problems that impact greatly on local communities, and residents and business owners in those communities can be left feeling frustrated and undervalued.

This Council therefore resolves to:

Call for an urgent meeting with the Home Secretary to ask for fairer funding, and more staffing, for Greater Manchester Police.

Call on the Greater Manchester Mayor to use their position to call for fairer funding and more police officers, so that crime and community safety can be tackled more effectively.
