10. Notice of Motion – Ending indefinite immigration detention

The UK remains the only country in Europe with no time on detention. Each year over 30,000 people enter immigration detention centres in the UK. Nearly 50% of those entering detention centres have sought asylum in the UK and many are fleeing from conflict and persecution. At anytime, 3000 people are detained indefinitely. Although detention is not a criminal process, detention centres are just like prisons. Detention negatively impacts individual's physical and mental health wellbeing. Suicide attempts in detention centres is at an all-time high according to Home Office figures, up 11% on the previous year. There has been widespread abuse in detention centres.

As over half of those detained are eventually released into the community, the huge cost to the tax payer of almost £125 million a year has proven to be both expensive and ineffective.

The All-Party Parliamentary Group on Refugees and the All-Party Parliamentary Group on Migration published a report on a joint inquiry into the use of immigration detention centres in the UK and concluded that the UK uses this sanction "disproportionately and inappropriately." The inquiry recommended a 28 days limit for the length of time anyone can be held in an immigration detention centre.

The coalition government refused to accept the 28 days' time limit and people are still held in detention centres indefinitely. Instead, the previous government have asked former prison and probation ombudsman Stephen Shaw to review the policy. The Shaw review agreed with many of the findings of the joint cross-party report.

We cannot let the government get away with this and hold people indefinitely. The UK detains more than most other European countries and for longer periods. Given the uncertainty around Brexit, our immigration detention system must be fit for purpose and the government must undertake the necessary reforms.

This Council:

- Respects the right to liberty, justice and dignity for all and believes that indefinite immigration detention is a breach of basic human rights.
- Endorses the These Walls Must Fall campaign and the declaration.
- Acknowledges the negative impact that indefinite detention has on individuals' mental and physical wellbeing.
- Calls on the government to implement the recommendations of the All Party Parliamentary Inquiry into detention.
- Asks our local MPs to support the spirit of the motion, to raise the matter in the House of Commons, and to support changes in current laws and procedures to introduce alternatives to detention
- Seeks further support for the motion via the Local Government Association, and by encouraging other Councils in the UK to show their support on this issue.

11. Notice of Motion – Universal Credit

We call on the Prime Minister, Theresa May, to intervene and stop the roll out of the government's Universal Credit programme.

We believe that this disastrous policy is driving millions of people in our country into misery and poverty.

Universal Credit forces people to make a choice between buying food and paying rent and causes them further debt problems. If they fail to pay their rent, this will inevitably lead to eviction from their property and homelessness.

It's time for the government to stop the roll out of Universal Credit, re-evaluate their policy and stop driving millions of people into further poverty.
