# 2. Key Decisions

The Council Constitution defines 'significant' as being expenditure or savings (including the loss of income or capital receipts) in excess of £500k, providing that is not more than 10% of the gross operating expenditure for any budget heading in the in the Council's Revenue Budget Book, and subject to other defined exceptions.

#### Purpose of report

Attached at Annex A is the latest edition of the Greater Manchester Brexit Monitor which is produced on a monthly basis to provide a real-time snap shot of the economic and policy impact of Brexit. The purpose of this report is to highlight key issues for consideration by the Executive.

#### Recommendations

- to note the contents of the September Brexit Monitor and the cautious optimism in business and consumer sentiment, acknowledging that the full impact of the decision to leave the EU is yet to be felt and that no detailed decisions have been made in relation to terms of trade and rules and regulations;
- 2. to note the headline announcements on Brexit covered by the Prime Minister in her main speech at the Conservative Party Conference, which add impetus to the requirement for Government to undertake a detailed analysis of the sectoral and spatial impacts of options for forging new trading relationships as part of the withdrawal strategy from the EU based. Greater Manchester has called for this analysis to be undertaken through the GM submission to the Autumn Statement process;
- 3. to note that a letter has been sent to the Chancellor of the Exchequer and the Secretary of State for Transport from the Leaders of the Northern Core Cities stressing the importance of committing to transport investment in the North.

A thriving and sustainable city: supporting a diverse and distinctive economy that creates jobs and opportunities	The decision to withdraw from the European Union has had a negative impact on investor and business confidence. It is critical that Manchester is able to provide support and advice during the challenging and uncertain times ahead and the ability to support businesses to drive productivity, innovate and export will become more important than ever.
A highly skilled city: world class and home grown talent sustaining the city's economic success	Withdrawal from the EU will significantly affect the higher education sector and as such will have a disproportionate impact on cities with a strong university presence such as Manchester. Whilst there will be no short-term change to the status of students and university staff the longer term implications depend on the terms of withdrawal. Ongoing access to transnational research funding is likely to be dependent on the UK's willingness to sign up to the free movement of people.
A progressive and equitable city: making a positive contribution by unlocking the potential of our communities	Post-Brexit, unemployment is expected to rise and real earnings are set to be hit by both higher inflation and slower nominal growth in wages. Combined with a freeze in working age benefits the fall in lower incomes is now likely to be sharper than previously predicted. If we are to reverse the decline in living standards across all levels of the income distribution we need to radically change our approach.
A liveable and low carbon city: a destination of choice to live, visit, work	A fall in share values and a loss of confidence amongst housing developers means that housing completion rates are likely to decline at a time when current demographic projections indicate that a significant uplift in new housing provision will be required. Urgent work is now underway to maximise levels of housing development and investment. The ability of Manchester to continue to attract visitors and workers will be affected by any restriction to the free movement of people. Britain's exit from the EU will have significant social implications and an analysis is underway to provide a better understanding of social inclusion and community cohesion issues within the city.

infrastructure and connectivity to drive growth	Central to any strategy for creating a stable economic environment will be a re-statement and reinforcement by Government of support for longstanding commitments that are of fundamental importance to the national economy, including investment in critical infrastructure such as HS2 and the Northern Hub.

#### 1. Background

- 1.1 On behalf of all Greater Manchester authorities New Economy is monitoring the economic and social trends and policy developments arising from the decision to leave the EU on a monthly basis.
- 1.2 The latest iteration of the Greater Manchester Brexit Monitor is attached. The impact of Brexit is being tracked across the key themes below:
  - Macro-economy trends and developments
  - Key sectors (including business investment)
  - Rules, regulations and terms of trade & access to European Funding
  - Property investment, housing and planning

• Economic inclusion

# 2. Key messages

- 2.1 The key message arising from this month's Brexit Monitor is one of cautious optimism in business and consumer sentiment. For businesses, rising optimism is seen across the service and manufacturing sectors, albeit that the latest overall rise in the production of goods has been led by a rise in oil and gas production, masking a fall in manufacturing output.
- 2.2 Rising consumer confidence is backed by members of the Royal Institute of Chartered Surveyors who have predicted in September an average 3.3% rise in house prices over the next 5 years.
- 2.3 It is important to note that the full impact of the decision to leave the EU remains to be felt, particularly within the labour market, which tends to lag behind other indicators. There also remain no substantive decisions related to specific trade relations and rules and regulations.
- 2.4 Additional important context is the announcement of two things by the UK Prime Minister Theresa May at the Conservative party conference at the start of October:
  - a "Great Repeal Bill" will be brought forward in the next Queen's Speech, expected next April. Leaving the EU requires the repeal or at least substantial amendment of the 1972 legislation, as well as other statutes implementing EU law. The Queen's Speech will repeal the European Communities Act 1972 as and when the UK leaves the European Union;
  - a deadline for invoking Article 50. This will be done, the PM said, before the end of March next year. Unless there is some agreement to extend the timeframe of withdrawal, this would mean that the UK would cease to be a member of the EU by 2019.
- 2.5 The announcements made by the PM add impetus to the requirement for a detailed analysis of the options for forging new trading relationships as part of the withdrawal strategy from the EU based on evidence, rather than adopting a policy based upon assertion and intuition. IAs part of Greater Manchester's submission to the 2016 Autumn Statement process we have urged Government to undertake this analysis in partnership with Core Cities to provide an economic assessment focusing on the impacts on business and productivity, sectors of employment, the implications for supply chains, and a spatial analysis of where the impacts will be greatest, which could then be used to inform the Government's emerging Industrial Strategy.
- 2.6 In addition, whilst the speech by the Chancellor of the Exchequer at the Conservative Party Conference re-affirmed that the economy remains "robust" and highlighted the "better than expected" recent data (most recent of which was this morning's PMI manufacturing data) he repeatedly signalled the likelihood of difficult times ahead in the face of Brexit.

- 2.7 The Chancellor highlighted that there will not be a direct copy of Labour's plan for large-scale public investment, in the face of Brexit, but he is expected to introduce a new "mechanism" to scrutinise "targeted, high-value" infrastructure spending.
- 2.8 The Chancellor made a restatement of prior commitments to invest in the UK's infrastructure: for HS2 to go ahead; for significant investment in housing; backing for the Northern Powerhouse alongside the Midlands Engine; and that all decisions on rail and road investment will be taken through the lens of regional development.
- 2.9 Given the content of this speech, and the importance of continued investment in Northern transport infrastructure for national growth and rebalancing, it will be essential for the Autumn Statement to confirm the route of HS2, the completion of the Northern Hub and to give support the priorities of Transport for the North at the earliest opportunity.
- 2.10 A letter has been sent to the Chancellor from the Leaders of the five Northern Powerhouse Core Cities urging the Government to make an announcement at the time of the Autumn Statement regarding the route of phase 2b of HS2, and of the Government's commitment to Northern Transport Strategy priorities for transformational rail journey times between Manchester, Manchester Airport and other principal northern cities.
