- This report provide an update on the specialist resourced mainstream provisions for pupils with Specific Language Impairment (SLI) and/or Autistic Spectrum Disorder (ASD) which are a key part of the continuum of education provision for children in Manchester. - This report proposes a provisional budget for 2015/16 based on the outcome of the provisional Financial Settlement and the issues which need to be taken into account prior to the Council finalising the budget and setting the Council Tax for 2015/16. It also sets out the estimated budget position for 2016/17 and the impact decisions made as part of the 2015/16 budget setting process will have on that year. The Strategic Response Report elsewhere on the agenda sets out the process for the 2015/17 budget. The proposals in this budget form part of the consultation process. An updated report will go to Executive in February and the budget setting Council in March taking into account the outcome of the consultation process, the final Financial Settlement and any views of the Finance Scrutiny Committee following its review of the overall budget at its meeting on 23 February.
