#### 1. Introduction

- 1.1 This is a health update paper produced by North, Central and South Manchester Clinical Commissioning Groups (CCGs) for the Health and Wellbeing Overview and Scrutiny Committee. It provides a brief summary of issues or news items that may be of interest to the Committee.

## 2. New Models of Care Programme

- 2.1 In October, NHS England published their Five Year Forward View. This set out how the health service needs to change over the coming years to improve the quality and accessibility of health services and meet the financial challenges we face as a result of increasing costs and an ageing population. Amongst other things, it recognised that England is too diverse for a 'one size fits all' health service. It explained how local health communities will be supported to choose from a number of 'radical new care delivery' options. These include Multispecialty Community Providers and Integrated Primary and Acute Systems.
- 2.2 As a result of this, NHS England, and its national partners, have announced the New Models of Care Programme, focusing on accelerating the design and implementation of these new models of care in the NHS. Through the programme, individual organisations and partnerships are invited to apply to be 'vanguard' sites and have the opportunity to work with national partners to co-design and establish new care models, tackling national challenges in the process. The deadline for submitting expressions of interest is Monday, 9 February 2015.
- 2.3 A Manchester application is being developed by the Living Longer Living Better programme team. If successful, further information will be brought to a future meeting.

#### 3. Prioritising specialised services

- 3.1 NHS England directly commissions around 145 specialised services. In order to ensure the maximum number of patients benefit from new innovative treatments, choices need to be made about which of these to fund. To address this issue, NHS England has launched a new consultation about how it will prioritise which specialised services and treatments to invest in.

- 7.1 NHS continuing healthcare is the name given to a package of care that is arranged and funded solely by the NHS for individuals who are not in hospital but have complex on-going healthcare needs.
