The consultation, which commenced on 1<sup>st</sup> December 2014 and ended 1<sup>st</sup> February 2015, was devised along eight key themes. The results of the consultation has fed into the decision making process. Each of the eight areas is covered by an individual report which sets out an analysis of the responses from the public as well as the key themes emerging from the consultation. Each report describes the adjustments that have been made to the budget options as a result of the consultation. This report focuses on housing related support and homelessness.

The consultation had been extended for a week as a result of the development of changes to the budget options after the announcement of the airport dividend. The savings proposals included in this report are informed by the outcome of the consultation, equality impact assessments and the options reported to the Executive on 21<sup>st</sup> January as part of the initial draft budget proposals. Subject to decisions on the Council's budget the proposals in this report will be built into the business plan for the Children and Families

Directorate.
