1.0 Update on the Joint Strategic Needs Assessment (JSNA)

Work has been underway over the course of 2017 to develop and populate the Adults and Older People's Joint Strategic Needs Assessment (JSNA) to sit alongside the Children and Young People's JSNA that has already been produced. This update provides members of the Health Scrutiny Committee information on the progress of this work, together with a summary of the discussions that have been taken place to explore how best to embed the JSNA within the ongoing work of Manchester Health and Care Commissioning (MHCC).

2.0 Content

The following JSNA chapters have already been published on the Adults and Older People's section of the Manchester JSNA website (www.manchester.gov.uk/jsna):

- BME Groups
- Cancer
- Diabetes
- End of Life Care
- Falls
- Fuel Poverty
- Lesbian, Gay, Bisexual and Trans (LGBT) people
- Sexual Health
- Suicide Prevention
- Work and Health

The following chapters are <u>nearing completion</u> and are expected to be published shortly:

- Adults with Complex Lives
- Air Quality and Health
- Homelessness
- New Psychoactive Substances

- Suicide Prevention (Children and Young People)
- Smoking and Tobacco Control

Work has also been taking place to update the Children and Young People's JSNA so that it continues to support the commissioning of services and programmes of work for children and young people in Manchester

The work to develop the chapters listed above has been done with the close involvement of a range of different partners, including the Reform and Innovation Team within Manchester City Council (Adults with Complex Lives), the Air Quality Officers Steering Group (Air Quality), Black Heath Agency (BME Groups), the Health and Homelessness Task Group (Homelessness) and the Health and Care Workstream of the Manchester Disability Plan Partnership Board (Disability).

Heathwatch Manchester and the Citywide Patient and Public Advisory Group (PPAG) are both routinely invited to comment on individual JSNA chapters as part of the formal quality assurance process. We are also in discussion with Manchester Alliance for Community Care (MACC) in order to agree a process for the ongoing engagement of voluntary and community sector organisations in the JSNA work.

3.0 JSNA and MHCC

In parallel with the development of content for the JSNA, discussions have been taking place with a range of colleagues within MHCC to explore how the JSNA can be embedded within the governance structures and operational processes of MHCC so that the data, evidence and insight contained in the JSNA better informs the development and prioritisation of commissioning plans and investment proposals for health and care in Manchester.

A clearer process is being established for feeding information about newly published JSNA chapters to the MHCC Executive Team. This will ensure that members of the Executive Team and the wider organisation (MHCC Board, Directorates) are sighted on the intelligence arising from the JSNA and are able to consider and act upon the opportunities for action highlighted in a more consistent and timely manner.

Each of the proposed work programmes for the MHCC Operational Plan 2018-19 will be required to demonstrate how they have had due regard to the evidence of population need and inequalities contained in the JSNA and, if the work programme has not been sufficiently covered within the JSNA, to outline the plans that are in place to collate the evidence base required and produce a JSNA chapter for publication on the website. This will help to show in a clearer fashion how the MHCC Operational Plan priorities link back to the JSNA (and vice versa). The Public Health Knowledge and Intelligence Team will support Operational Plan leads to develop and use the JSNA as part of their work programme.
