Re: General Practice Representation on the Health and Wellbeing Board

I am writing with reference to the previous attempts Manchester LMC has made to establish representation on the Health and Wellbeing Board for the largest provider of NHS Healthcare in Manchester, namely General Practice and General Practitioners. 90% of patient contacts are with GPs, who undertake both the role of gatekeeper and holistic co-ordinator of care for patient pathways, therefore our involvement at a planning and a strategic level is vital.

The LMC has made contact several times dating back from 2010 to ensure we were involved in the early planning stages for the Board to represent GPs. Having recently had sight of the Work Programme for 2013/14, much of the success of many of the items listed in programme would depend on the cooperation and input from General Practice.
