Summary

The Health and Wellbeing Board is asked to receive the Draft Prospectus for commissioning community based out of hospital services in the city of Manchester.

The Prospectus details our ambition for the delivery of community based out of hospital care through a Local Care Organisation (LCO). Commissioners see many benefits for the people of the city in bringing together and integrating health and care, and its contribution to, the financial and clinical sustainability of our health and care system, as detailed with the city's Locality Plan. The Health and Wellbeing Board is asked to note the contributions made to date in developing the prospectus. A proposal for the provider selection process will be shared with members of the Health and Wellbeing Board at the meeting scheduled for the 18 January 2017.

This LCO Prospectus outlines a major opportunity for our system, the scale and magnitude of which are significant.

1. Introduction:

This report seeks to advise the Health and Wellbeing Board of the Manchester Commissioners intentions with regards to commissioning community based out of hospital care. Attached to this report is a Draft Prospectus for commissioning community based out of hospital care from a Local Care Organisation.

2. Background:

The Locality Plan clearly sets out the scale of the challenges we face during the next 5 years. Included within the plan are the steps we will be taking to ensure we are clinically and financially stable during that timeframe.

The Health and Wellbeing Board will be aware of the journey we have been undertaking since 2014, through the work of the Living Longer Living Better Programme, when we embarked on defining how we will change the face of how care is delivered in this city.

We have tested new ways of working and can clearly see some of the benefits for people, and for our system, by having a better coordinated approach to how health and care is delivered.

In meeting the challenges outlined in the Locality Plan we have clearly stipulated we will change the way that our system delivers community based out of hospital care, through a Local Care Organisation.

3. Progress:

Commissioners have been taking the necessary steps to prepare a commissioning Prospectus that details the expectations of a Local Care Organisation in the delivery of community based out of hospital care. We are now in a position to share with the Health and Well Being Board, the **Draft Prospectus for Manchester Local Care Organisation**.

The Prospectus describes what commissioners will commission through a single contract over a 10 year period. The services covered within the prospectus will be for Adults, Children and Young People and Families. Due to the complexity of the task we aim to implement a phased approach with a focus on Adults in the first year. We should not underestimate the scale, complexity and expectations, which will be required of the LCO.

In developing the Prospectus we have received vital and valuable contributions from Commissioning staff across the CCGs and MCC, CCG Boards, MCC Senior Management Team. More importantly we have reflected and incorporated what people in the city have told us about how we can improve their experience in accessing and receiving care.

4. Provider Selection Exercise

As commissioners we are bound by the current regulatory framework:

- Public Contracts Regulations 2015 (“PCR15”)
- NHS (Procurement, Patient Choice and Competition) (No 2) Regulations 2013 (“PPCCR”)

Working alongside commissioners we have strong legal support providing the necessary advice, to ensure that the Manchester system secures the provision of community-based services through an LCO, within the regulatory frameworks detailed above.

5. Assurance processes

We have been advised that the GM Health and Social Care Partnership will assume overall responsibility for assuring the Manchester system readiness to proceed with the process for selecting a provider.

6. Timeframes

Recognising the complexity surrounding the scale of the services to be commissioned, in the first instance it is the intention of commissioners to put in place, an Alliance Agreement during 17/18, with the overall aim of awarding a full contract to operate from April 2018.

7. Next Steps:

To ensure that the Manchester system is sufficiently prepared and able to meet the timeframes stipulated above, the Manchester CCGs and Manchester City Council will be asking for feedback from partner organisations, stakeholders and staff about the LCO prospectus. This will begin after the Health and Wellbeing Board on the 2 November 2016 and run until 2 January 2017. This will include face-to-face briefings with staff, with trade union involvement. All feedback will be considered and then the final version of the Prospectus will be presented to the Health and wellbeing Board on the 18th January.

The engagement exercise will also consist of the prospectus being sent out to a range of partner organisations and stakeholders, inviting organisational and staff responses where relevant. Commissioners are particularly keen to hear from voluntary and community sector organisations about how they envisage working with, or within, the LCO. The prospectus will also be available on line, along with a video explaining Manchester’s ambition for integrated care and how it will work in practice.
