The Licensing Policy Committee discharges the duties of the Council in relation to a range of licensing and registration functions. The Committee consists of 6 members of the Council -

The Licensing Policy Committee monitors and keeps under review the Council's policy with respect to its licensing functions during the three-year period of the policy, and makes arrangements for consulting statutory consultees and other appropriate persons or bodies in relation to the Council's policy. The Committee then makes recommendations to the Council as Licensing Authority, as to any proposed revisions to its licensing policy during the period of the policy, and in relation to any new policy for the subsequent three-year period.

Copies of the agenda for each are available beforehand from the reception area at the St. Peter's Square entrance to the Town Hall Extension. Some additional public copies are available at the meeting. It is the Council's policy to consult people as fully as possible before making decisions that affect them. Members of the public do not have a right to speak at meetings but may do so if invited by the Chair. If you have a special interest in an item on the agenda and want to speak, tell the Committee Officer, who will pass on your request to the Chair. Groups of people will usually be asked to nominate a spokesperson.

The Council is concerned to ensure that its meetings are as open as possible and confidential business is kept to the strict minimum. When confidential items are involved these are considered at the end of the meeting at which point members of the public are asked to leave.
