1 Introduction

- 1.1 This report provides the committee with information in respect of work that has been undertaken by the Compliance Team during the fourth quarter of the financial year 2013/2014 covering the dates 1 January 2014 through to 31 March 2014.
- 1.2 The team's primary work is associated with taxi licensing compliance activity but also includes compliance work in respect of street trading, gambling activities, and sex establishments. Compliance work associated with premises licensed under the Licensing Act is led by Neighbourhood Delivery Teams.

2 Report

2.1 Complaints

- 2.1.1 The Licensing Team receives complaints against both Hackney Carriage and Private Hire licence holders on a regular basis. These are logged and allocated a unique reference number in chronological order.
- 2.1.2 All complaints are investigated, although the majority are dealt with on an informal basis which means that they do not result in criminal proceedings. A key factor is often the difficulty of securing the necessary evidence and/or cooperation of witnesses.
- 2.1.3 Licence holders have the opportunity to respond to any allegations made against them and all complaints are recorded against licence holders, with both the allegation and drivers response, where we are satisfied that drivers have been correctly identified.
- 2.1.4 The investigation of complaints is generally an effective compliance tool, that prevents repeat patterns of behaviour by individual drivers. However, it is also resource intensive and the number of complaints in this area received remains consistently high; The 2014 complaints database started on 1st January 2014 and any complaints received after that date were logged onto this new database. Complaints from the 2013 database continued to be worked upon during this quarter.

2.1.5 During this quarter a total number of **135** complaints were closed down as dealt with.

2.2 Prosecutions

2.2.1 A number of prosecutions were successfully concluded during this quarter and these are listed below. In addition a number of other cases are still awaiting court hearings or are under consideration in terms of legal proceedings. These will be the subject of future reports.

2.2.2 Private Hire:

- (1) Abdul QAYUM Rochdale licensed driver Mr Qayum successfully applied to the court to have the matter re-opened as he was convicted in his absence in April 2013. He elected to go to trial and the case was found to be proved. He was convicted of plying for hire and the associated no insurance offence Fined £540 and driving licence endorsed with 6 penalty points. He was ordered to pay prosecution costs of £604
- (2) Christopher SWINDELLS Rochdale Private Hire Driver Mr Swindells successfully applied to the court to have the matter reopened as he had previously been convicted in his absence. He was convicted of smoking in a prohibited place a licenced private hire vehicle- and was fined £35. He was ordered to pay prosecution costs of £170. The case arose because Mr Swindells did not pay a fixed Penalty Charge Notice issued to him by officers

- (3) Khalid MAHMOOD Oldham Private Hire driver He was convicted of plying for hire and fined £400. He was ordered to pay prosecution costs of £640
- (4) Ariko AGHO-JONES Stockport Private Hire Driver After a trial he was convicted of plying for hire and the associated no insurance offence Fined £137.50 and driving licence endorsed with 6 penalty points. He was ordered to pay prosecution costs of £674.17. Appeal against conviction and sentenced lodged with Crown Court
- (5) Mohammed FIAZ Manchester Private Hire Driver Pleaded guilty to an offence of having no vehicle insurance. He was fined £140 and his driving licence endorsed with 7 penalty points. He was ordered to pay prosecution costs of £220

2.2.3 Street Trading:

- (1) **Mbengue IBRAHIM** convicted of street trading on a prohibited street [city centre]. Fined £37 and ordered to pay prosecution costs of £170. Application for Forfeiture of seized goods used as evidence refused by the court.
- (2) Tamsin SARR convicted of street trading on a prohibited street [city centre]. The Court imposed a 12 month conditional discharge and ordered to pay prosecution costs of £300. Application for Forfeiture of seized goods used as evidence granted by the court.
- (3) Russell FLYNN convicted of street trading on a prohibited street [city centre]. The Court gave an Absolute Discharge and made no order to pay prosecution costs. Application for Forfeiture of seized goods used as evidence refused by the court.
- (4) David SCHOFIELD convicted of street trading on a prohibited street [city centre]. The Court gave an Absolute Discharge and made no order to pay prosecution costs. Application for Forfeiture of seized goods used as evidence refused by the court.
- (5) Simone STOREY convicted of street trading on a prohibited street [city centre]. Fined £35 and ordered to pay prosecution costs of £371.74. Application for Forfeiture of seized goods used as evidence granted by the court.
- (6) Su DIHONG convicted of street trading on a prohibited street [city centre]. The Court imposed a 6 month conditional discharge and ordered to pay prosecution costs of £240.98. Application for Forfeiture of seized goods used as evidence refused by the court.

2.3 Routine Hackney Carriage and Private Hire Inspections

2.3.1 Table 1 shows the number of routine day to day vehicle/driver inspections carried out at various locations across the city, including railway stations, airport, hospitals and supermarkets.

Key within the following tables:

HCV: Hackney Carriage Vehicle

PHV: Private Hire Vehicle

Sus: Suspension Notice – suspends vehicle licence until defects rectified **Ins**: Insurance Notice – requires production of insurance certificate

OVC: Operational Vehicle check - requires vehicle to be produced with

defects rectified

Other: Action not specified in other categories – e.g. smoking.

Every vehicle interaction shown in the attached tables also includes a driver check.

2.3.2 4 fixed penalty notices were served on drivers observed smoking in their vehicles which is a prohibited place for the purposes of the Health Act 2006

2.4 Operations

2.4.1 The Compliance Team participate in a number of joint agency operations targeting both the day and night time Hackney Carriage and Private Hire trades. The committee will already be aware of Operation Aviano which runs 12 times a year with dedicated GMP [Greater Manchester Police] Traffic Officers working alongside Compliance Officers. Vehicle Examiners from the

DVSA [Driver & Vehicle Standards Agency] – formerly known as VOSA (Vehicle Operator and Services Agency) also regularly attend these nighttime operations. Operation Aviano continues to be funded through the Licensing Unit budget.

2.4.2 Compliance Officers are invited to attend other formal operations that are instigated by GMP and also mutually organise other small scale *ad hoc* operations from time to time with GMP and other agencies. The majority of these operations involve the Hackney Carriage and Private Hire trades but some are organised for other work areas.

3 Other Work

- **3.1** 2 licensed sexual entertainment venues [SEV] received routine night time visits/inspections whilst they were in operation.
- 3.2 1 licensed sex shop received a routine day time visit/inspection
- 3.3 A visit to an unlicensed Sex Establishment visit took place on Thursday 13th March 2014. The unannounced visit was made to a premises located in the city centre. Officers from Compliance, Trading Standards and GMP took part. A significant number of R18 and un classified DVD's were found to be on sale and in the absence of a sex establishment licence all such articles were

seized with a view to instigating proceedings under the Video Recordings Act. Enquiries will also be made in regard to taking proceedings for the premises operating without a sex establishment licence.

- 3.4 Report compiled and presented to the Licensing and Appeals sub-committee on 31 March 2014 in respect of the renewal of a Hackney Carriage Proprietors Licence. The decision of the sub-committee was to renew licence with an additional condition relating to monthly vehicle maintenance checks.
- 3.5 Objections were lodged to three street trading applications during the 28 day consultation period and an officer attended Licensing and Appeals subcommittee hearings to assist in determining two of those applications. The decision of the sub-committee was to refuse one of the applications and to grant the other after the applicant provided further clarification to his application which satisfied the objection that had been lodged.
- 3.6 3 Senior Licensing Officer Panels were chaired by an officer from Compliance during the 4th quarter. The outcomes of these hearings are reported to the committee in a separate report.
