### 1.0 Introduction

1.1 At their meeting of 6 December 2016, the Children and Young People Scrutiny Committee considered a report on the Budget Options 2017-2020, which included options regarding school crossing patrols. Following this Members began a wider discussion on road safety around schools and decided this issue required further work and consideration. The Chair recommended that a Road Safety Around Schools Task and Finish Group be established, in consultation with the Neighbourhoods and Environment Scrutiny Committee, to undertake a detailed review of the options available to improve road safety around schools.

## 3.0 Objectives

3.1 The objectives and key lines of enquiry were agreed by both the Children and Young People Scrutiny Committee and the Neighbourhoods and Environment Scrutiny Committee at their meetings of 28 February 2017. The full terms of reference are attached at Appendix 1 to this report.

The objectives of the Task and Finish Group were:

- To review highways investment agreed by the Executive regarding schools related sites.
- To review the potential scope on investment regarding schools related sites.
- To explore ways of making schools fully aware of developments and opportunities for school crossing patrols.

- To explore ways of enhancing education and communication within schools and communities regarding road safety around schools.
- To review available technical solutions.

# 4.0 Key Lines of Enquiry

- 4.1 The key lines of enquiry identified and agreed were:
  - The Task and Finish Group will hear from a number of stakeholders and invited witnesses throughout the course of this enquiry.
  - To consider evidence of good practice and local initiatives from other UK and European cities to improve road safety around schools.
  - To consider how current and potential highways investment is used to ensure good road safety around schools.
  - To explore opportunities for education and communication within schools and communities regarding road safety around schools.
  - To consider the potential for implementing a variety of technical solutions as well as their limitations and benefits.

# 5.0 Evidence Gathering Process

# 5.1 Formal Meetings and Themes

The Task and Finish Group held six substantive meetings. The full detail of what it considered at each meeting can be found in the work programme, attached at Appendix 2.

## 5.2 Meeting 1 – 27 June 2017

This meeting provided an introduction to the subject area and provided information on what is currently being offered to schools to improve road safety. This included information on:

- The 'Road Safety Guide for Schools' that had been launched in 2014 with the aim of the document being to support and highlight what everyone could do, including the police, parents, pupils, Manchester City Council and schools to better manage the situation;
- Online resources at supporting road safety training for school pupils 'ToGo & NoGo'. (see www.togoandnogo.co.uk);
- · Bikeability Cycle Training and Bikeability Plus schemes; and
- An update on the creation of 20mph Areas.

# 5.3 Meeting 2 – 12 September 2017

This meeting enabled Members to consider the prioritising of funding for Road Safety Measures around Schools and proposals of trial schemes. Members were also provided with ward collision data that focused on child casualties around each school campus between 07.00hrs and 18.00hrs. The data showed all child related collisions for the most recent 3 year period.

Information was also provided regarding the proposed trial of temporary road closures and red routes at the four school sites identified.

# 5.4 Meeting 3 – 17 October 2017

This meeting enabled Members to consider and discuss various enforcement measures and options to improve road safety. The group were provided with information as to which responsible authority had enforcement powers to address any parking or traffic violations.

## 5.5 Meeting 4 – 22 November 2017

The group considered the enforcement report that had been adjourned from the meeting of 17 October 2017.

This meeting enabled Members to reflect and review a number of issues relating to school road safety and how the school journey could be made safer. The group heard that the Director of Education was to write to all schools to inform them of the work of the group and promote the suite of options available to address the issue of irresponsible parking around schools. Schools would then be invited to express an interest in trialling any of the physical highways options, and the decision as to which schools would be selected to pilot these would be assessed by the Executive Member for Environment in consultation with the Highways Department.

## 5.6 Meeting 5 – 20 February 2018

Following the discussions at the 22 November 17 meeting the group agreed to convene a meeting to receive an update on the responses received from schools to the letter sent by the Director of Education inviting schools to express an interest in trialling any of the physical highways options.

## 5.7 Meeting 6 – 21 March 2018

Agreement of Final Report and Recommendations.

The group considered the report that presented the findings of the investigation undertaken by the group. Members were asked to consider the content of the report and the recommendations and make any amendments.

The final report, which would contain any amendments made by the Members at this final meeting, would then be submitted to the Children and Young

People Scrutiny Committee and the Neighbourhoods and Environment Scrutiny Committee. Both committees will be asked to endorse the recommendations contained within the report.

### 6.0 Conclusions and recommendations

Following careful consideration of all of the evidence presented throughout the course of this investigation the Task and Finish Group agreed the following recommendations:

## Recommendation 1:

That the Executive Member for Environment update and refresh the school road safety guide.

## Recommendation 2:

That the Executive Member for Environment consider trial locations from the schools that had already volunteered as sites for temporary road closures and red routes outside schools.

#### Recommendation 3:

That the Executive Member for Environment adopt the agreed preferred prioritisation methodology for physical road safety measures outside schools.

#### Recommendation 4:

That the Executive Member for Environment continues to communicate with all schools' regarding the measures available to enforce parking violations and to facilitate schools own response to irresponsible driving and parking practices.
