This school was last inspected in June 2009, and the overall effectiveness of the school was awarded a “good” rating.	5

This school was last inspected in March 2007, and the overall effectiveness of the school was awarded a “good” rating.	9
The full Ofsted Reports of schools awarded with “good” and “satisfactory” ratings for the “ <b>North District</b> ”. The schools to be considered are:

<b>• St Patrick’s RC Primary School</b>	
This school was last inspected in October 2009 and the school was deemed to require special measures. The school has received monitoring inspections every school term to evaluate its progress. This is the first full inspection since the school has been taken out of special measures.	13

<b>• Ashbury Meadow Primary School</b>	
This school was last inspected in January 2009 and the overall effectiveness of the school was awarded a “satisfactory” rating.	27

<b>• Abraham Moss High School</b>	
This school was last inspected in October 2006 and the overall effectiveness of the school was awarded a “good” rating.	41
