#### **Background**

1. On 12 September 2006 members of the Standards Committee considered a report on the work being undertaken to review and develop the Council's ethical governance arrangements. It was noted that the purpose of the work was to ensure that the Council is placed in a sound position in relation to any future performance assessments.

#### **Ethical Standards, Conduct and Behaviour Across the Council**

- 2. There are a number of projects currently being undertaken in connection with the raising of the profile of ethical standards, conduct and behaviour across the Council. The existing code of conduct for members is currently being revised and a new code is due to be issued for consultation on 12 January 2007 for adoption at the Council's annual general meeting in May 2007. The changes will be communicated to members through a series of training sessions provided by the Council's Democratic Services section. There are also changes to the ethical framework set out in the Local Government and Public Involvement in Health Bill which is the subject of a separate report to the Standards Committee.
- 3. A new code of conduct for officers is expected to be issued shortly. The changes will be communicated to officers through a series of training sessions. Once the revised code has been issued a report on the changes will be brought back to the Standards Committee.
- 4. An extensive review of the governance of the Council's partnerships is also currently taking place.

#### **The Ethical Framework and Codes of Conduct**

- 5. In addition to the projects referred to above, it is proposed that the Council addresses the raising of the profile of ethical standards and codes of conduct through the activities and communication strategy listed in the appendix to this report.
- 6. Members of the Standards Committee are asked to consider and endorse the proposals set out in the appendix and provide any comments that they may have.
