## **Background**

1. The Standards Committee met on 5<sup>th</sup> August 2008 and approved the establishment of sub-committees, each chaired by a different independent member and comprising different elected members, to (a) undertake the assessment of allegations made under section 57A of the Local Government Act 2000 (b) consider any request made under section 57B of the Act for a review of any decisions to take no action in respect of the assessment of an allegation, and (c) to discharge the

function of holding hearings in connection with investigations would also be necessary.

- 2. The City Solicitor was asked to plan dates for these meetings for the remainder of the Municipal year in preference to making ad hoc arrangements as need demanded.
