#### **Background**

- Ringway Parish is the only civil parish within the City of Manchester and has its own parish council. However, for a number of years Ringway Parish Council had been moribund, with no candidates standing at the parish council elections in 2007 nor at the subsequent reruns. This, coupled with a history of previous periods of inactivity, gave rise to concerns about its future viability.
- 2. When consulted as part of the recent community governance review, the electors of Ringway expressed strong support for the retention of parish arrangements, including the parish council. Therefore, the final recommendations of the Community Governance Review, in relation to Ringway, were that parish arrangements be retained with the following provisos:
  - That the number of parish councillors be reduced from 8 to 5 (the legal minimum).
  - That the ordinary year of election for the parish council be brought forward, from 2011 (and every 4 years thereafter) to 2010 (and every 4 years thereafter).
  - That, if the parish council is not properly carrying out its statutory obligations, the continuance of parish arrangements in Ringway shall be reviewed by the City Council after two years.

These final recommendations were implemented by the Council.

- 3. Having brought forward the parish council elections, there are now 5 parish councillors in office. The parish council held its Annual Meeting on 9 June 2010.
- 4. The Committee is asked to note that Ringway Parish Council is functioning once again.

#### **Parish Involvement with the Standards Committee**

5. The Standards Committee is responsible for standards matters involving Ringway Parish Council. Similarly, Manchester City Council's Monitoring Officer is also the Monitoring Officer for Ringway Parish Council.

- 6. By law the Standards Committee must have at least two members who are parish councillors for parish councils for which the City Council is responsible (i.e. Ringway) and who are not members of the City Council. A parish member must be present when matters relating to such a parish council or its members are being considered.
- 7. The Committee may establish a sub-committee to deal with some of its functions relating to parish council matters.
- 8. The Committee is asked to note the requirements concerning the involvement of parish councillors with the Committee.

## **Nominees for the Vacant Parish Councillor Committee Posts**

- 9. Following the 2007 parish council elections, there were no parish councillors in office to take-up the parish councillor vacancies on the Committee. Following the 2010 parish council elections parish councillors are now in office and Ringway Parish Council has nominated the following to fill the two parish councillor vacancies:
  - Councillor Christopher O'Donovan
  - Councillor Peter Johnson
- 10. The nominations will go forward to the Constitutional and Nomination Committee for it to make recommendations to Full Council as to the appointments.
- 11. The Committee is asked to note the nominations made by Ringway Parish Council to fill the parish councillor vacancies on the Committee.
