### Representations received

The Trading Standards Service

The Trading Standards Service are not satisfied that, at the point of ordering/delivery/collection of alcoholic beverages, the Premises Licence Holder will be able to ensure that the operation of the Challenge 25 age verification policy will be properly communicated to customers and delivery staff (thereby ensuring that the Licensing Objective relating to the protection of children from harm is fully upheld). To satisfy The Trading Standards Services concerns in regard to this matter they are requesting that a range of

	conditions be adopted on to any subsequently granted premises licence that relate to the advertising and application of the Challenge 25 policy at point of sale/ordering and delivery.
Licensing & Out of Hours Compliance	The LOOH Compliance Team are not satisfied that the applications Operating Schedule provides sufficient assurance that the licensing Objective relating to the prevention of crime and disorder would be correctly upheld and enforced, should the application be granted in its current form. LOOH Compliance are requesting that a range of conditions be adopted on to any subsequently granted premises licence that will allay their concerns in regard to this matter and ensure full compliance in regard to the Licensing Objectives.

### **Agreements between parties**

#### **The Trading Standards Service:**

- When advertising the online delivery service, a clear statement that a strict 'Challenge 25' Policy is in operation shall be displayed on your advertisement.
- All deliveries shall be signed for by a person aged 18 or over, with reference made to the 'Challenge 25' Policy. If no signature is obtained the consignment must be returned to the point of origin.
- A photographic driving licence, passport, HM Forces card, or a form of identification bearing the 'PASS' hologram shall be requested from any person who appears to be under the age of 25 at the point of delivery. If appropriate ID is not provided then delivery shall be refused and the refusal recorded in the refusals log.
- Customers ordering alcohol for delivery shall be advised at the point of order that the 'Challenge 25' Policy shall be in force on delivery.

#### **Licensing & Out of Hours Compliance:**

- The premises shall install and maintain a digital colour CCTV system covering all public areas of the licensed premises, including all public entry and exit points. CCTV shall continually record whilst the premises are open to the public and the recording shall be kept available and unedited for a minimum of 28 days with the date and time stamping.
- A staff member who is conversant with the operation of the CCTV system shall be present on the premises at all times when they are open to the public and must be able to produce / download / burn CCTV images upon request by a police officer or an authorised officer of the licensing authority. Any footage must be in a format so it can be played back on a standard personal computer or standard DVD player. Where the recording is on a removable medium (i.e. compact disc, flash card etc.), a secure storage system to store those recording mediums shall be provided.

- All areas to which the public have legitimate access must be sufficiently illuminated for the purpose of CCTV.
