### Proposed licensable activities and opening hours to be granted

Provision of regulated entertainment indoors (recorded music indoors):  
 Mon to Sat 8am to 10pm  
 Sun 8am to 8pm

Recorded music shall be background music only.

The supply of alcohol for consumption both on and off the premises:  
 Mon to Sat 4pm to 10pm  
 Sun 4pm to 8pm

Opening hours:  
 Mon to Sat 8am to 10pm  
 Sun 8am to 8pm

Concerns regarding the lack of additional conditions offered to manage off sales and street drinking leading to public nuisance; and the need to have effective measures in place to ensure

	age restrictions are enforced, i.e. the maintenance of refusal logs.
Local Resident	Concerns regarding noise disturbance and the proposed times for alcohol including an 8am start.

### Agreements between parties

#### Licensing & Out of Hours Compliance:

- All sales of alcohol for consumption off the premises shall be in sealed containers only.
- Open containers of alcohol shall not be removed from the premises, except for consumption in any delineated external area under the control of the premises.
- Alcohol consumed outside the premises shall only be consumed by patrons seated at tables.
- Patrons permitted to temporarily leave and then re-enter the premises, e.g. to smoke, shall not be permitted to take drinks or glass containers with them.
- A log (which may be electronically recorded) shall be kept detailing all refused sales of alcohol including the date and time of the refused sale, the reason for the refusal and the name of the member of staff who refused the sale. The log shall be kept at the premises for at least six months and made available on request to GMP or an authorised officer of the licensing authority.

#### Local Resident:

Amended times agreed with the local resident have been stated in the Proposed licensable activities and opening hours to be granted section above and agreed the following condition:

- Recorded music shall be background music only.
