#### **Purpose of report**

The Constitutional and Nomination Committee is asked to make recommendations to the Council about the size and composition of the Council's committees and to appoint chairs and deputy chairs of the committees detailed in this report.

#### Recommendations

The Committee is asked to make recommendations to Council about:

- 1. The size of the Council's committees;
- 2. The appointment of members to serve on the various committees listed in the report;
- 3. The appointment of members to serve as chairs of scrutiny committees, chairs of non-executive committees, and the deputy chairs of the Planning and Highways Committee, and Licensing and Appeals Committee; and
- 4. The appointment of a member for the purpose of answering questions at Council on the work of the Standards Committee, in accordance with Article 9 of the Council Constitution.

#### 1 Introduction

- 1.1 Government regulations require the Council to appoint membership of its committees in accordance with the principles of political balance as far as reasonably practicable.
- 1.2 Due to the composition of the Council after the election (94 Labour, 1 Liberal Democrat and 1 Green Party), there is no requirement to allocate seats on the basis of political groups for each committee.
- 1.3 The Committee is asked to make recommendations to the Council about the size and the membership of committees. The Committee is asked to take into consideration, where appropriate, virus transmission safety measures arising from the COVID-19 pandemic which are likely to remain an important factor as restrictions are eased in order to work safely together.
- 1.4 The Committee is also asked to note the Terms of Reference of Scrutiny Committees (Part 3 Section E - Council's Constitution: February 2021) state a minimum of 10 members for each committee.
- 1.5 Details of the number of seats that were appointed to each committee in the previous municipal year are set out included below.
  - Art Galleries [14 Elected Members and 7 Co-opted Members]
  - Audit Committee [9 Elected Members and 2 Co-opted Members]
  - Children and Young People Scrutiny Committee [14 Elected Members and 7 Co-opted Members]
  - Communities and Equalities Scrutiny Committee [14 Elected Members]
  - Constitutional and Nomination Committee [9 Elected Members]
  - Economy Scrutiny Committee [14 Elected Members]
  - Environment and Climate Change Scrutiny Committee [14 Elected Members]
  - Health Scrutiny Committee [14 Elected Members]
  - Licensing and Appeals Committee [15 Elected Members\*] as set out in the associated Regulations]
  - Licensing Committee [15 Elected Members\*] as set out in the associated Regulations
  - Licensing Policy Committee [6 Elected Members]
  - Personnel Committee [10 Elected Members] Membership formula comprises the Leader of the Council (or a Deputy) the 6 Executive Members and the Assistant Executive Member (Finance and Human Resources)
  - Planning and Highways Committee [16 Elected Members currently, extra place added to accommodate previous opposition group. \*\*Was previously 15 members]
  - Resources and Governance Scrutiny Committee [15 Elected Members]
  - Standards Committee [6 Elected Members, 1 Parish Member, 2 Independent People]
  - Standing Executive Consultative Panel [6 Assistant Executive Members].

#### 2 Other Committees

2.1 Some of the Council's committees are subject to specific rules about membership. These details are included below. The Committee is asked to make recommendations to Council about the membership of these committees.

#### Employee Appeals Committee

- 2.2 The composition of the Committee consists of the following structure:
  - The Executive Member with a relevant portfolio (i.e. Executive Member for the service in which the employee was working or the Executive Member with a portfolio relevant to the specific subject area of the appeal) or an appropriate Assistant Executive Member; and
  - Two Elected Members drawn from the Council's Executive Members or the Assistant Executive Members, or Elected Members drawn from a prescribed 'pool' of 15 members.
- 2.3 The Constitutional and Nomination Committee is asked to confirm this composition and agree the Elected Members in the prescribed pool.

#### Health and Wellbeing Board

- 2.4 The membership of the Health and Wellbeing Board comprises of Elected Members as well as NHS and council officers. The membership was established at the meeting of Council on 27 March 2013 and subsequent amendments have been agreed through the Constitutional and Nomination Committee.
- 2.5 Following the most recent review of the governance structure of the Board, the membership of the Board is set out below. The Board has also agreed that each member should have a named substitute

- Central Primary Care Manchester Representative
- Representative of Northern Health GP Provider Organisation

#### 1. Introduction

- 1.1 The Constitutional and Nomination Committee is asked to review the appointments to joint authorities and joint committees and to make recommendations to Council about the Council's representatives for the 2021/22 Municipal Year.
- 1.2 The Council may, if it wishes, make nomination to a number of GMCA and AGMA positions (as detailed in the table appended to the report), however the final decisions on these appointments rest with the GMCA and AGMA Executive Boards at their Annual Meeting due to take place in May 2021. As such, any nominations submitted by the Council may not necessarily be appointed.
- 1.3 The report also asks the Committee to make recommendations to the joint authorities about the appointment of spokespersons to answer questions at Council meetings as outlined in Council Procedural Rule 24 (part 4, section A of the Constitution).
- 1.4 The table appended to the report details, where appropriate, the specific membership requirement of particular organisations/bodies.

#### 2. GMCA Overview and Scrutiny Committees

- 2.1 Each Overview and Scrutiny Committee will comprise 15 members.
- 2.2 Each Local Authority district is asked to make 6 nominations. 4 of these nominations should be from the ruling group and 2 from the major opposition group, except where there is a hung council or no opposition group.
- 2,3 Three of the six nominations are to be appointed as the Council's representative on one of the GMCA Overview and Scrutiny Committees.
- 2.3 The remaining 3 nominations will go into a "reserve" scrutiny pool from which a further 5 members per committee will be selected by the GMCA to ensure each committee meets its statutory and constitutional requirements regarding political balance and diversity.
- 2.4 Members of the pool who are not selected as permanent committee members, will be appointed by the GMCA as formal substitutes for all three committees. In the 2020/21 Municipal Year substitute members have regularly ensured that committees are quorate.
- 2.5 The final membership of the committees will be approved by the GMCA at its May 2021 meeting.
