Dear Alan

We note your representation in respect of this application and your assertion that the application should be refused entirely. There is surely an opportunity here for negotiation. I'd like to make the following points, which will doubtless also be apparent to the licensing sub-committee:

- Any existing problems in the area of this shop in terms of alcohol related crime, disorder and nuisance are nothing to do with this shop or my client.
- If the other outlets that are supplying alcohol and causing these issues had stricter conditions under which they operated (which could be imposed through review proceedings or by gentle persuasion and voluntary minor variations) then the problems you describe would be reduced.
- This is not a cumulative impact area; perhaps it should be, but that would need to be justified by the police and the council.
- This is a strong application, with modest hours, for a shop that satisfies a niche Eastern European clientele.
- You are correct that Elena has not been a DPS previously but she has passed the personal licence holder exam and the grant of her personal licence is imminent.

- It is her shop, she is there 7 days each week and takes her responsibilities very seriously.

If you say that there is a problem of street drinking in the area, then please give us the opportunity to offer further conditions, for example:

- There shall be no sales of alcohol earlier than ****hrs (if the problems are early in the morning)
- There shall be no sales of single cans of beer, lager or cider.
- There shall be no sales of super strength beers, ciders and lagers over 6.5% abv, except for artisan products.
- No more than **% of the retail space shall be used for the display of alcohol products.

We'd like to avoid a hearing and Elena would be happy to compromise on her application.

Let me know your thoughts please.
