| <ol style="list-style-type: none"> <li>1. Documented records of staff training completed shall be kept for each member of staff. Training shall be regularly refreshed and at no greater than 6 monthly intervals. Training records shall be made available for inspection upon request by a police officer or an authorised officer of Manchester City Council.</li> <li>2. Staff shall monitor customers smoking outside the premises on a regular basis and ensure patrons do not cause a public nuisance.</li> <li>3. All sales of alcohol for consumption off the premises shall not be removed from premises unless in sealed containers only.</li> <li>4. No bottles, glasses or similar items may be disposed of in outside receptacles between the hours of 2300 and 0700.</li> <li>5. The premises and immediate surrounding area shall always be kept clean and free from litter during the hours the premises are open to the public.</li> <li>6. The premises shall display prominent signage indicating at any point of sale that the Challenge 25 scheme is in operation</li> <li>7. Notices shall be prominently displayed at all exits requesting patrons to respect the needs of residents and leave the area quietly.</li> </ol> |
