### Proposed licensable activities and opening hours to be granted

The supply of alcohol for consumption on the premises only: Mon to Sun Noon to 10.30pm

Opening hours:

Mon to Sun Noon to 11.00pm

Representations received	
Licensing & Out of Hours Compliance	LOOH raised concerns that operating schedule of the application was inadequate and was "likely to lead to problems with noise and litter during the late hours applied for". In response to these concerns, LOOH team proposed a number of conditions, which have been agreed to by the applicant, as below.

# Agreements between parties

#### **Licensing & Out of Hours Compliance:**

1. The Designated Premises Supervisor shall ensure that a written notice of authority is kept at the premises for all staff who sell alcohol. The notice shall be made available for inspection upon request of the police or an authorised officer

of the licensing authority and all staff selling alcohol must be in possession of formal identification to verify their identity against the notice.

- 2. All staff authorised to sell alcohol shall be trained in:
  - a. Prevention of underage sales
  - b. Prevention of proxy sales
  - c. Maintenance of the refusals log
  - d. Recognising signs of drunkenness and vulnerability
  - e. How to refuse service
  - f. The conditions in force under this licence.
- 3. The premises must only operate as a restaurant:
  - a. in which customers are seated at a table which provides food in the form
    of substantial table meals that are prepared on the premises and are
    served and consumed at the table using non-disposable crockery; and
  - b. which does not provide any take-away service of food or drink for immediate consumption; and
  - c. where alcohol must not be sold, supplied, or consumed on the premises otherwise than to persons who are taking substantial table meals; and
  - d. provided always that the consumption of alcohol by such persons is ancillary to taking such meals.
- 4. Between the hours of 7.30am to 8pm no waste/glass bottles will be moved or deposited outside.
- 5. Litter will be removed from outside the premises at regular intervals and after the close of business and stored within the premises until the following day when it can be placed in premises commercial container.
- 6. Deliveries, servicing and collections, including waste collections shall not take place outside the following hours: 7.30am to 8pm, Monday to Saturday, no deliveries/waste collections on Sundays/Bank Holidays.
