I am Police Constable 17659 Isherwood of the Greater Manchester Police, Licensing Officer for the City of Manchester Division, currently based in the Licensing Team at Manchester Town Hall Extension.

Part of my remit as licensing officer is to oversee all of the licensed premises on the City of Manchester Division. The objective of the role is to promote and maintain the 4 licensing objectives at licensed premises, those being the Prevention of Crime and Disorder, Public Safety, Prevention of Public Nuisance and the Protection of Children from Harm.

#### The Queens Hotel

The premises are situated on Sedgeford Road in the Monsall area of Manchester and the premises licence was issued in 2005. The Premises Licence Holder (PLH) and Designated Premises Supervisor (DPS) is Janice Flint who was the DPS back in 2005 until 2006 and took up this position again on 8<sup>th</sup> July 2021.

#### Incident

On the evening of Wednesday 24<sup>th</sup> November 2021 GMP neighbourhood officers from Harpurhey Police station carried out a visit to licence premises at the Queens Hotel.

As the officers approached the premises a number of the patrons have made off from the location.

Officers have entered and spoken to the person in charge. On looking around the public area and on seating at the rear, officers have discovered suspected class A drugs, prepared for individual deals, which appear to have been discarded in a hurry under the seats. Nearby, a knife in a sheath was discovered under a table, again, seemingly discarded. As well as these items a single 'walkie talkie' type radio was located near to the entrance.

On further checking in and around the premises, a large amount of alcohol bottles were discovered outside of the premises, near to a storage container, and in a box, inside the gents toilets.

The person present and identifying themselves as being in charge stated to officers she was in charge of the pub on behalf of the PLH / DPS. The officers were informed that the CCTV couldn't be accessed at that time.

Officers invited her to close the pub and cease licensable activities immediately due to concerns about criminality ongoing at the premises and this request was duly complied with.

As a result of this visit the following items were seized:

16 individually wrapped packets of white power

24 individually wrapped packets of brown power

47 individually wrapped packets of white 'rock like' substance

A black handled knife in a sheath, blade approximately 8 inches long

A black ICOM walkie talkie

68 bottles of assorted spirits were recovered from waste ground outside the premises and a further 10 bottles from within the gents toilets at the premises.

#### **Interim Steps Hearing**

On Thursday 25<sup>th</sup> November 2021 I applied for a Summary Review of the Premises Licence on the grounds that the Premises were associated with Serious Crime. The certificate was signed by Superintendent Fraser.

The Interim Steps hearing took place on Friday 26<sup>th</sup> November 2021 via online facilities and GMP outlined our concerns regarding the premises and the fact that we hadn't been able to access to the CCTV to see exactly what had occurred just prior to our arrival at the premises. We asked the committee to suspend the Premises Licence pending the outcome of the full review hearing and, after deliberation; the committee took the decision to suspend the Premises Licence pending the full review hearing on Tuesday 21<sup>st</sup> December 2021.

#### **Interim Steps Appeal Hearing**

Following the decision to suspend that Premises Licence the PLH applied to appeal the interim steps stating that they had managed to extract the CCTV footage from their system and this showed that incident in a different light.

This appeal hearing took place on Tuesday 30<sup>th</sup> November and at this hearing the CCTV footage was shown to the committee and to GMP and it showed that a group of young males run into the premises and appear to throw items under the seating before trying to run out of the rear door of the premises, which was locked. It also shows one of the males carrying a box of bottles into the toilets.

The males then walk out of the premises via the door that they entered and a few seconds later GMP officers walk into the premises and they then conduct the licence check that they attended for and it is shortly after this that the items are found.

#### Conclusion

Having had chance to review this incident and, after having a discussion with my GMP colleagues, we are satisfied that the items did end up on the premises as a result of the males seeing my colleagues arrive in their liveried police vehicles and running into the premises in a bid to dispose of their drugs and other items and as a means to evade the police, by running out of the rear door.

However we do still have concerns that the person in charge was unable to operate the CCTV system when my colleagues attended and that other conditions on the Premises Licence are not worded robustly enough to ensure that the 4 licensing objectives are upheld so we would ask committee, when making their decision, to consider adding the following conditions to the Premises Licence:

CCTV cameras are located within the premises to cover all public areas including all entrances and exits. The system records clear images permitting the identification of individuals. The CCTV system is able to capture a minimum of 24 frames per second and all recorded footage must be securely retained for a minimum of 28 days.

The CCTV system shall operate at all times while the premises are open for licensable activities. All equipment must have a constant and accurate time and date generation. The CCTV system is fitted with security functions to prevent recordings being tampered with, i.e. password protected. There are members of trained staff at the premises during operating hours able to provide viewable copies on request to police or authorised local authority officers as soon as is reasonably practicable in accordance with the Data Protection Act 1998 (or any replacement legislation).

An incident log (which may be electronically recorded) shall be kept at the premises for at least six months, and made available on request to the police or an authorised officer of the licensing authority, which will record the following incidents including pertinent details of:

All alleged crimes reported to the venue or by the venue to the police

All ejections of patrons

Any complaints received

Any incidents of disorder

Seizures of drugs, offensive weapons, fraudulent ID or other items

Any refusal of the sale of alcohol

Any faults in the CCTV system, searching equipment or scanning equipment

Any visit by a responsible authority or emergency service

The times on duty, names and the licence numbers of all licensed door supervisors employed by the premises.

#### Notes for guidance:

1. A certificate of the kind mentioned in the form must accompany the application in order for it to be valid under the terms of the Licensing Act 2003. The certificate must explicitly state the senior officer's opinion that the premises in question are associated with serious crime, serious disorder or both.

Serious crime is defined by reference to section 81 of the Regulation of Investigatory Powers Act 2000. In summary, it means:

- conduct that amounts to one or more criminal offences for which a person who has attained the age of eighteen and has no previous convictions could reasonably be expected to be sentenced to imprisonment for a term of three years or more; or
- conduct that amounts to one or more criminal offences and involves the use of violence, results in substantial financial gain or is conduct by a large number of persons in pursuit of a common purpose.
