Better Care Fund Section 75 Agreement2022/23 – Executive Meeting March 2022 Better Care Fund Section 75 Agreement 2021/22 – Executive Meeting November 2021

1.0 Background

- 1.1. On 1 April 2021, new arrangements came into place between Manchester City Council (MCC) and Manchester Foundation Trust (MFT) to 'supercharge' Manchester's Local Care Organisation. This included the creation of a new Section 75 Agreement between MCC and MFT which included Adult Social Care services, following the cessation of a similar agreement between Manchester Clinical Commissioning Group (MCCG) and MCC.
- 1.2. The Council and MCCG entered into a Section 75 Better Care Fund Agreement in March 2022. The S75 Agreement sets out the terms on which the Partners have agreed to collaborate and to establish a framework, through which the Partners can secure the future position of health and social care services through Lead Commissioning Arrangements or Joint Commissioning Arrangements in relation to the BCF and IBCF. On 1 July 2022, the MCCG ceased to exist and was replaced by the GM ICB. On 1 July 2022, the S75 Agreement was transferred from MCCG to the GM ICB.
- 1.3. The report to Executive in March 2022 set out the proposal to extend the existing S75 Agreement to the 31 March 2023 with delegated authority to the Deputy Chief Executive and City Treasurer and City Solicitor, in consultation with Executive Member, to finalise any amendments that need to be made to the document which a was approved.
- 1.4. Each year the national BCF guidance is refreshed. This has not yet been released for 2023/24 and further consideration and update to local arrangements will be required in due course, with emphasis on joined up planning within the Health and Social Care System.

2.0 GM ICB / MCC Section 75 Update

- 2.1 The following material changes are required for 2022/23:
 - Revised minimum BCF contribution £18.071m. The 2021 Spending Review confirmed the NHS contribution to the BCF will rise in actual terms by 5.66% each year from 2022 to 2025. This included the minimum contributions to social care;
 - (ii) Revised iBCF allocation £31.749m an increase of 3%; and
 - (iii) Winter Discharge Fund (WDF)
 - a. the allocation to the Council of $\pounds 2.222m$
 - b. the allocation to the GM ICB of £19.558m. Of the GM ICB 2022/23 allocation, £3.982m is allocated to Manchester.
- 2.2 The following changes are required for 2023/24:
 - (i) Revised minimum BCF contribution £19.094m;
 - (ii) iBCF no change.

- (iii) Adult Discharge Fund (ADF)
 - a. the allocation to the Council of £4.451m
 - b. the allocation to the GM ICB of \pounds 17.659m. Of the GM ICB 2023/24 allocation, c \pounds 4m is expected to be allocated to Manchester.
- 2.3. The revised BCF funding contributions for 2022/23 and proposal for 2023/24 are below:

3.0 Proposed GM ICB / MCC Section 75 2022/23

- 3.1 The proposal is to extend the current S75 Agreement to the 31 March 2024.
- 3.2 There may be a requirement to update the document once the final Better Care Funding guidance is published. The Executive is asked to approve the extension to the S75 Agreement, but to also provide delegated authority to the Deputy Chief Executive and City Treasurer and City Solicitor, in consultation with Executive Member, to make any amendments to finalise the document. Any changes considered to be material would need to be presented to the Executive for approval.

4.0 Recommendations

- 4.1. The Executive is asked to:
 - (i) Approve the extension of the S75 Agreement on the Better Care Fund and the Improved Better Care Fund.
 - (ii) Provide delegated authority to the Deputy Chief Executive and City Treasurer and City Solicitor, in consultation with Executive Member, to finalise any amendments that need to be made to the document.
