Letter to the Responsible Authorities

Mini Megasave, Gorton

Dear Representor,

Thank you for timely sight of your Representation with regard to the above application. We have liaised with the applicant and have reflected on your initial observations. As a result of these we would like to provide the following information as attachments and suggest the following amended conditions as an adjunct the original application.

Firstly, we would like to like to prove our bona fides, to which we attach references from [REDACTED] to show that the applicant has a growing business and evidence of his ongoing support for Healthy Communities initiative in the form of his donations to the [REDACTED] [REDACTED] for Gorton.

Secondly, we provide a map of the locations where the other representors live. You will see that the nearest neighbours ([REDACTED]) are our near neighbours yet those who make representations against the application are not near neighbours. In further support of that proposition, at the forthcoming Hearing we will be providing the Licensing Authority with a signed petition of a further twenty plus near neighbours who (although they did not make Representations within the Consultation Period) wish to support the application and have no issue with it.

Thirdly we provide photos of the new night hatch that has been fitted to the frontage of our premises, meaning that it is perfectly possible for us to trade securely from our premises without ever opening the front door to the public.

Fourthly we have employed a new member of staff called [REDACTED] with the intention that it will be him primarily providing night cover serving in the shop. We have enclosed a copy of his wage slip to show that he is permanent and formal employment, and confirmation that he is qualified with the Security Industry Authority. Although he will not be performing a dual role of SIA supervisor whilst employed at the till, this demonstrates that he possesses the behaviours, attitudes, skills and knowledge to be able to manage the expectations of customers and refuse service where appropriate.

Fifthly, the applicant has secured the services of an SIA registered security company called [REDACTED] who will provide SIA registered supervisors should they be so required. Our contact there can be emailed at [REDACTED] should you wish to confirm their credentials.

All of the above leads us on to provide some extra reassurances to yourselves that the outcomes you fear will not in fact come to pass. These additional conditions come as a drop-down menu of possible solutions which are acceptable to us.

Additional Proposed Conditions:

1. Staff working between 23:00 and 05:00hrs at night will be qualified to Level 2 as a Door Supervisor by an SIA-approved Training Course.
And/Or
2. The premises shall operate solely via a Night Hatch between 23:00 and 05:00hrs at night.
And/Or
3. At any time that the public are physically on the premises 23:00 and 05:00hrs, an SIA-registered door supervisor employed by the Premises Licence Holder shall be on duty and present at the premises.
4. The Premises Licence Holder shall maintain a register of SIA-registered staff employed at the premises, including their full names, SIA Badge Number and hours of employment.
5. There shall be no single sales of cans of beer, lager or cider between the hours of 23:00 and 05:00hrs.
6. No beer, lager or cider exceeding 6.5%ABV shall be sold between the hours of 23:00 and 05:00hrs.
7. The premises shall be an active member of any Business Crime Initiative (e.g. Watch Scheme) approved the local Crime Safety Partnership and supported by Greater Manchester Police whilst such a scheme may be in operation for the area.

Additionally we note Dr PALMER's recent report, and therefore withdraw our request for any 24/7 home delivery facility via Online or App order platforms.

Consequently I hope that you will give the revised down application and additional proposed conditions your full consideration. If they meet your expectations, we would be delighted to hear from you. Similarly if you have any further suggested conditions that you deem appropriate to the operating schedule, we would be pleased to consider them.
