#### Good morning

I act for Euro Garages Ltd (a company now wholly owned by Asda) and am responsible for the application to which you have submitted a representation.

The purpose of this email is to advise you of changes made to the application following discussions with Trading Standards and the Licensing and Out of Hours officers.

The original application sought alcohol sales hours 24 hours a day in line with the store's opening hours. However, following discussions with the authorities the hours sought for alcohol sales have been amended to 0600 to midnight.

Furthermore, the request for late night refreshment has been limited to the provision of hot drinks only. There is a coffee machine within the premises and for hot drinks to be sold, late night refreshment is required as a licensable activity.

Finally, a robust package of operating conditions has been agreed between the my client and the responsible authorities. The effect of the reduction in alcohol sales hours and the agreed conditions is that none of the Responsible Authorities object to this application.

We understand the concerns that you have raised and wanted to be transparent with you

The only effect of the licence being granted will be to allow the premises (which operate as an Asda Express) to display and sell (between 0600 and midnight) a limited range of alcohol alongside the groceries and household goods already sold.

The grant of the application will not affect the opening hours of the premises, nor will the times of deliveries to the premises be altered.

I hope that this information allays your concerns. If it does and you wish to withdraw your representation then please contact the licensing authority (copied in).
