Conditions:

1. Preventing noise and other public nuisance

- No noise shall emanate from the premises nor vibration be transmitted through the structure of the premises that gives rise to a nuisance
- Any music at the outdoor or extension area shall not give rise to a nuisance.
- No glass to be disposed of into external receptacles between the hours of 2230 and 0730 Monday to Saturday, and between 2230 and 1000 on Sunday.

3. Door Supervisors

- Door supervision must be provided on days when the premises is used for any events promoted externally, and on days when our door staff risk assessment requires us to provide door supervision. SIA door supervisor shall be in place on Fridays and Saturdays from appropriate time deemed necessary for the security of our staff and customers. Door supervisors must be on duty from the start of the externally promoted event/staff risk assessment requirement and must remain on duty until the premises are closed and all the customers have left.
- Door supervisors shall be employed at the ratio of 2 door supervisor for every 150 customers
- Any door supervisors on duty at the premises must be supplied by an SIA – Approved Contractor Scheme company

4. No food or drink shall be consumed in the outside (uncovered) area after 01:00 and the area shall be used only for smoking at this time.

5. A metal detecting wand shall be used on all patrons who attend at the premises when it is being used for events promoted externally, and when the premises is operating as anything other than a restaurant.

NOTE:

No changes to the current regular operating hours. Seasonal extension accepted.

Not removing the condition to allow music outdoor after 23:00, remains indoor only.
