#### 1. Introduction

- 1.1 On 15/11/2018, an application for the grant of a Premises Licence under s17 of the Licensing Act 2003 was made in respect of Sicilia Pizza, 116 Mauldeth Road, Manchester, M14 6SQ in the Withington ward of Manchester. A location map of the premises is attached at **Appendix 1**.
- 1.2 A 28-day public consultation exercise was undertaken in accordance with Licensing Act 2003 regulations; requiring the application to be advertised by the displaying of a blue notice at or on the premises, a notice published in a newspaper or similar circulating in the local area, and details of the application published on the Council's website.
- 1.3 Representations may be made for or against an application during the consultation period. To be 'relevant' and, therefore, able to be taken into account in determining the application, they must be about the likely effect of the grant of the premises licence on the promotion of the licensing objectives. Where representations are made by persons who are not a responsible authority, they must not be frivolous or vexatious.
- 1.4 Relevant representations have been received in respect of this application and so it must be determined by a Licensing Hearing Panel in accordance with the Council's Constitution.

#### 2. The Application

- 2.1 A copy of the application is attached at **Appendix 2.**
- 2.2 The applicant is Mr Parvat Singh Chundawat.
- 2.3 The description of the premises by the applicant is a takeway.
- 2.4 The licensable activities applied for:

#### **Provision of late night refreshment:**

Mon to Sun: 11pm to 2am

From the start of permitted hours on New Years' Eve to the end of permitted hours on New Years' Day.

An extra hour on the day that British Summertime Commences

#### **Opening hours:**

Mon to Sun 11am to 11pm (telephone/internet orders for delivery only after 11pm)

- 2.4.1 Any further details provided relating to any of the individual licensable activities are specified on the application form at **Appendix 2**.
- 2.5 Activities unsuitable for children
- 2.5.1 The applicant has not highlighted any adult entertainment or services, activities, other entertainment or matters ancillary to the use of the premises that may give rise to concern in respect of children.

#### 2.6 Steps to promote the licensing objectives

- 2.6.1 The applicant proposes to promote the licensing objectives by taking the steps identified in the operating schedule.
- 2.6.2 These steps must be translated into conditions by the licensing authority to be included in any granted premises licence, unless the conditions are modified by the Panel following consideration of relevant representations. These conditions are set out in the Schedule of Conditions at **Appendix 4**.

#### 4. Key Policies and Considerations

#### 4.1 Legal Considerations

4.1.1 Hearings under the Licensing Act 2003 operate under the Licensing Act 2003 (Hearings) Regulations 2005.

#### 4.2 **New Information**

4.2.1 In accordance with Regulation 18 of the Licensing Act 2003 (Hearings) Regulations 2005, the authority may take into account documentary or other

information produced by a party in support of their application, representations or notice either before the hearing or, with the consent of all parties, at the hearing.

#### 4.3 **Hearsay Evidence**

4.3.1 The Panel may accept hearsay evidence and it will be a matter for the Panel to attach what weight to it that they consider appropriate. Hearsay evidence is evidence of something that a witness neither saw nor heard, but has heard or read about.

#### 4.4 The Secretary of State's Guidance to the Licensing Act 2003

- 4.4.1 The Secretary of State's Guidance to the Licensing Act 2003 is provided for all parties involved in licensing. It is a key medium for promoting best practice, ensuring consistent application of licensing powers across England and Wales and for promoting fairness, equal treatment and proportionality.
- 4.4.2 Section 4 of the 2003 Act provides that, in carrying out its functions, a licensing authority must 'have regard to' guidance issued by the Secretary of State under section 182. The Guidance is therefore binding on all licensing authorities to that extent. However, the Guidance cannot anticipate every possible scenario or set of circumstances that may arise and, as long as licensing authorities have properly understood this Guidance, they may depart from it if they have good reason to do so and can provide full reasons.
- 4.4.3 Departure from the Guidance could give rise to an appeal or judicial review, and the reasons given will then be a key consideration for the courts when considering the lawfulness and merits of any decision taken.

#### 4.5 Manchester Statement of Licensing Policy

- 4.5.1 Section 4 of the 2003 Act provides that, in carrying out its functions, a licensing authority must 'have regard to' its statement of licensing policy.
- 4.5.2 The Licensing Policy sets out the vision the licensing authority has for the regulation of licensed premises throughout Manchester and outlines the standards expected in order to ensure the promotion of the licensing objectives in the city. The Panel may depart from the policies should it consider doing so would benefit the promotion of the licensing objectives. Reasons are to be given for any such departure from the Policy.
- 4.5.3 Section 4 of the Policy (Operation of the Policy) sets out how the Licensing Policy is intended to be used in practice for licence applications and licensed premises.
- 4.5.4 Relevant to this application and the grounds of the representations made, the Panel are recommended to have regard to the following sections of the Policy:

#### Section 6: What we aim to encourage

This section identifies certain types of venues and initiatives the licensing authority aims to encourage in order to promote an inclusive evening and night-time economy not simply focused on the consumption of alcohol. We aim to encourage:

 Premises that will extend the diversity of entertainment and attract a wider range of participants

- Live music, especially original material, which will provide a range of live performances and styles of music, provided that such entertainment does not undermine the licensing objectives
- National cultural institutions, global sports events and cultural festivals
- Non-drink-led premises, including restaurants, cafes, theatres and cinemas
- Communication and integration with local residents and businesses through licensees consulting with those in the local area prior to an application
- Participation in Pubwatches, off licence forums and other crime-reduction partnerships
- Engagement with the NITENET radio scheme and DISC secure information sharing platform by city centre venues through the Cityco Manchester Business Crime Reduction Partnership
- Designing out crime in the layout of the premises

#### Section 7: Local factors

This section sets out key issues that applicants are expected to take into account relevant to the individual characteristics of the premises when preparing their operating schedule and address any local factors relevant to their premises.

Having regard to the grounds of the representations made, the Panel are recommended to have regard to the following Factors:

- Identified risk factors specific to the licensed premises
- Evidence of pre-existing problems in the area
- The proximity of the premises to local residents and other local businesses, particularly in relation to the potential for nuisance
- Ability to clean and maintain the street scene

#### Section 8: Manchester's standards to promote the licensing objectives

This section identifies the standards that the licensing authority expects of licensed premises in Manchester. It is recognised that not all standards will be appropriate to apply in every situation to every premises, and applicants are not obliged to include all standards in their operating schedule. The degree to which standards would be appropriate is expected to be proportionate to the risk posed against the promotion of the licensing objectives having regard to the individual circumstances of the premises. The standards are not exhaustive and the licensing authority will have regard to any relevant issues raised in any representation that may fall outside them.

- MS2 Effective general management of the premises
- MS10 Operate effective cleansing arrangements, including ensuring the premises and surrounding area are kept clean and free of litter, and adequate arrangements for the secure and responsible storage of refuse

#### Conclusion

- 4.6 A licensing authority must carry out its functions under this Act ("licensing functions") with a view to promoting the licensing objectives:
  - the prevention of crime and disorder
  - public safety;
  - the prevention of public nuisance; and
  - the protection of children from harm.
- 4.7 In considering the matter, the Panel should take into account any representations or objections that have been received from responsible authorities or other persons, and representations made by the applicant or premises user as the case may be. In reaching the decision, regard must also be had to relevant provisions of the national guidance and the Council's licensing policy statement.
- 4.8 Having regard to the representations, the Panel must take such of the steps set out below that it considers appropriate for the promotion of the licensing objectives:
  - a) To grant the licence subject to:
    - the conditions consistent with the operating schedule accompanying the application, which the Panel may modify to such extent as they consider appropriate, and
    - ii. any mandatory conditions that must be included in the licence:
  - b) To exclude from the scope of the licence any of the licensable activities to which the application relates;
  - c) To refuse to specify the person proposed in the application as the designated premises supervisor;
  - d) To reject the application.
- 4.9 The conditions consistent with the operating schedule may be modified to alter or omit any of them or to add any new condition, including restricting the times at which licensable activities authorised by the licence can take place.
- 4.10 All licensing determinations should be considered on the individual merits of the application.
- 4.11 The Panel's determination should be evidence-based, justified as being appropriate for the promotion of the licensing objectives and proportionate to what it is intended to achieve. Findings on any issues of fact should be on the balance of probability.
- 4.12 It is important that a licensing authority should give comprehensive reasons for its decisions in anticipation of any appeals. Failure to give adequate reasons could itself give rise to grounds for an appeal.

4.13 The Panel is asked to determine the application.


I am writing to object to application reference: 222991/JC1, Sicilia Pizza which is in Withington ward. This is on the grounds of prevention of public nuisance.

The opening hours are significantly extended compared to the other late night refreshment venues on Mauldeth Road in Ladybarn District Centre. To approve this application would increase issues around the night time economy. We have long had issues with the refuse storage at the rear of the property, plus issues relating to noise and anti-social behaviour linked to our large student population within the locality.

Furthermore, the venue already appear to be breaking the rules. On the Just Eat website, their opening hours are listed as 5pm to 4am Monday- Sunday. (<a href="https://www.just-eat.co.uk/restaurants-sicilypizza-m19">https://www.just-eat.co.uk/restaurants-sicilypizza-m19</a>). This does not give residents and elected members a good level of trust that licence terms will be stuck to. As a local resident I have personally seen the venue open and trading in the early hours of the morning.

For these reasons, I would ask that the licencing committee reject this application and encourage the applicant to significantly reduce their opening hours in any future application.

### 1. <u>Introduction</u>

- 1.1 On 19/11/2018, an application for the variation of an existing Premises Licence under s34 of the Licensing Act 2003 was made in respect of Peaky Blinders, (formerly Sakana), 23 Peter Street, Manchester, M2 5QJ in the Deansgate ward of Manchester. A location map of the premises is attached at Appendix 1.
- 1.2 A 28-day public consultation exercise was undertaken in accordance with Licensing Act 2003 regulations; requiring the application to be advertised by the displaying of a blue notice at or on the premises, a notice published in a newspaper or similar circulating in the local area, and details of the application published on the Council's website.
- 1.3 Representations may be made for or against an application during the consultation period. To be 'relevant' and, therefore, able to be taken into account in determining the application, they must be about the likely effect of the grant of the premises licence on the promotion of the licensing objectives. Where representations are made by persons who are not a responsible authority, they must not be frivolous or vexatious.
- 1.4 Relevant representations have been received in respect of this application and so it must be determined by a Licensing Hearing Panel in accordance with the Council's Constitution.

## 2. Current Licence

2.1 The premises licence holder is PB Manchester Ltd and a copy of the current licence is attached at Appendix 5.

## 3. The Application

- 3.1 A copy of the application is attached at Appendix 2.
- 3.2 The variation is to:
  - Amend the hours for licensable activities.
  - Revise the layout plans of the premises in respect of works to the ground floor; and
  - to Remove condition 6 of Annex 3, in relation to New Year's Eve "Hours for licensable activities on New Year's Eve shall be restricted to 0200".
- 3.2.1 In accordance with the Live Music Act 2012 and Deregulation Act 2015, performances of Live Music and Recorded Music between the hours of 0800 and 2300 hours have been deregulated and so should not be regarded as licensable activities for the purposes of this application.
- 3.2.2 Any further details provided relating to any of the individual licensable activities are specified on the application form at Appendix 2.

#### 3.3 Activities unsuitable for children

3.3.1 The applicant has not highlighted any adult entertainment or services, activities, other entertainment or matters ancillary to the use of the premises that may give rise to concern in respect of children.

## 3.4 Steps to promote the licensing objectives

- 3.4.1 The applicant proposes to promote the licensing objectives by taking the steps identified in the operating schedule.
- 3.4.2 These steps must be translated into conditions by the licensing authority to be included in any granted premises licence, unless the conditions are modified by the Panel following consideration of relevant representations. These conditions are set out in the Schedule of Conditions at Appendix 3.

## 3.5 Further documentation accompanying the application

- 3.5.1 The applicant has submitted the following documents in support of their application, which are included at Appendix 6:
  - New plan of the premises

### 5. <u>Key Policies and Considerations</u>

#### 5.1 **Legal Considerations**

5.1.1 Hearings under the Licensing Act 2003 operate under the Licensing Act 2003 (Hearings) Regulations 2005.

#### 5.2 **New Information**

5.2.1 In accordance with Regulation 18 of the Licensing Act 2003 (Hearings)
Regulations 2005, the authority may take into account documentary or other
information produced by a party in support of their application, representations
or notice either before the hearing or, with the consent of all parties, at the
hearing.

## 5.3 **Hearsay Evidence**

5.3.1 The Panel may accept hearsay evidence and it will be a matter for the Panel to attach what weight to it that they consider appropriate. Hearsay evidence is evidence of something that a witness neither saw nor heard, but has heard or read about.

### 5.4 The Secretary of State's Guidance to the Licensing Act 2003

- 5.4.1 The Secretary of State's Guidance to the Licensing Act 2003 is provided to licensing authorities in relation to the carrying out of their functions under the 2003 Act. It also provides information to magistrates' courts hearing appeals against licensing decisions and has been made widely available for the benefit of those who run licensed premises, their legal advisers and the general public. It is a key medium for promoting best practice, ensuring consistent application of licensing powers across England and Wales and for promoting fairness, equal treatment and proportionality.
- 5.4.2 Section 4 of the 2003 Act provides that, in carrying out its functions, a licensing authority must 'have regard to' guidance issued by the Secretary of State under section 182. The Guidance is therefore binding on all licensing authorities to that extent. However, the Guidance cannot anticipate every possible scenario or set of circumstances that may arise and, as long as licensing authorities have properly understood this Guidance, they may depart from it if they have good reason to do so and can provide full reasons.

5.4.3 Departure from the Guidance could give rise to an appeal or judicial review, and the reasons given will then be a key consideration for the courts when considering the lawfulness and merits of any decision taken.

#### 5.5 Manchester Statement of Licensing Policy

- 5.5.1 Section 4 of the 2003 Act provides that, in carrying out its functions, a licensing authority must 'have regard to' its statement of licensing policy.
- 5.5.2 The Licensing Policy sets out the vision the licensing authority has for the regulation of licensed premises throughout Manchester and outlines the standards expected in order to ensure the promotion of the licensing objectives in the city The Panel may depart from the policies should it consider doing so would benefit the promotion of the licensing objectives Reasons are to be given for any such departure from the Policy.
- 5.5.3 Section 4 of the Policy (Operation of the Policy) sets out that an opposed application that complies with the Policy will not necessarily be granted, nor will an opposed application that does not comply with it necessarily be refused.
- 5.5.4 Where there is objection to an operating schedule that departs from the Policy, the Panel hearing an opposed application will normally expect to be given a good reason for the departure if it is to be asked to make an exception to the Policy.
- 5.5.5 The licensing authority will not interfere with an operating schedule that does not comply with the Policy where the steps proposed are sufficient to meet the licensing objectives in the individual circumstances of the case.
- 5.5.6 There are a number of references in the Policy to the licensing authority's expectations of applicants. The licensing authority will not apply the Policy rigidly, but will always have regard to the merits of the case with a view to promoting the licensing objectives.
- 5.5.7 Relevant to this application and the grounds of the representations made, the Panel are recommended to have regard to the following sections of the Policy:

#### Section 6: What we aim to encourage

This section identifies certain types of venues and initiatives the licensing authority aims to encourage in order to promote an inclusive evening and night-time economy not simply focused on the consumption of alcohol. We aim to encourage:

- Premises that will extend the diversity of entertainment and attract a wider range of participants
- Live music, especially original material, which will provide a range of live performances and styles of music, provided that such entertainment does not undermine the licensing objectives
- National cultural institutions, global sports events and cultural festivals

- Non-drink-led premises, including restaurants, cafes, theatres and cinemas
- Communication and integration with local residents and businesses through licensees consulting with those in the local area prior to an application
- Participation in Pubwatches, off licence forums and other crime-reduction partnerships
- Engagement with the NITENET radio scheme and DISC secure information sharing platform by city centre venues through the Cityco Manchester Business Crime Reduction Partnership
- Designing out crime in the layout of the premises

#### Section 7: Local factors

This section sets out key issues that applicants are expected to take into account relevant to the individual characteristics of the premises when preparing their operating schedule and address any local factors relevant to their premises.

Having regard to the grounds of the representations made, the Panel are recommended to have regard to the following Factors:

- Identified risk factors specific to the licensed premises.
- Evidence of pre-existing problems in the area.
- The proximity of the premises to local residents and other local businesses, particularly in relation to the potential for nuisance.
- Ability to clean and maintain the street scene.

#### Section 8: Manchester's standards to promote the licensing objectives

This section identifies the standards that the licensing authority expects of licensed premises in Manchester. It is recognised that not all standards will be appropriate to apply in every situation to every premises, and applicants are not obliged to include all standards in their operating schedule. The degree to which standards would be appropriate is expected to be proportionate to the risk posed against the promotion of the licensing objectives having regard to the individual circumstances of the premises. The standards are not exhaustive and the licensing authority will have regard to any relevant issues raised in any representation that may fall outside them.MS1 Implement effective security measures at the premises.

- MS2 Effective general management of the premises.
- MS3 Responsible promotion and sale of alcohol.

- MS8 Prevent noise nuisance from the premises.
- MS9 Effectively manage exterior spaces (e.g. beer gardens, smoking areas, and table and chair areas on the highway).

#### 6. Conclusion

- 6.1 A licensing authority must carry out its functions under this Act ("licensing functions") with a view to promoting the licensing objectives:
  - the prevention of crime and disorder;
  - public safety;
  - · the prevention of public nuisance; and
  - the protection of children from harm.
- 6.2 In considering the matter, the Committee should take into account any representations or objections that have been received from responsible authorities or other persons, and representations made by the applicant or premises user as the case may be. In reaching the decision, regard must also be had to relevant provisions of the national guidance and the Council's licensing policy statement.
- The Panel must take such of the steps set out below that it considers appropriate for the promotion of the licensing objectives:
  - To grant the licence subject to the conditions consistent with the operating schedule accompanying the application, which the Panel may modify to such extent as they consider appropriate;
  - b) To reject the whole or part of the application
- 6.4 The conditions consistent with the operating schedule may be modified to alter or omit any of them or to add any new condition, including restricting the times at which licensable activities authorised by the licence can take place.
- 6.5 However, conditions should not be imposed on a licence which are unrelated to the variation sought.
- 6.6 All licensing determinations should be considered on the individual merits of the application.
- 6.7 The authority's determination should be evidence-based, justified as being appropriate for the promotion of the licensing objectives and proportionate to what it is intended to achieve. Findings on any issues of fact should be on the balance of probability.
- 6.8 It is important that a licensing authority should give comprehensive reasons for its decisions in anticipation of any appeals. Failure to give adequate reasons could itself give rise to grounds for an appeal.

6.9 The Panel is asked to determine the application.

Appropriate signage representative of the above shall be placed in conspicuous positions
- 5. Customers shall be actively encouraged to leave the premises quietly.
- 6. Children accompanied by an adult, shall be allowed on the premises until 19.30 after which time no children shall be allowed on the premises.
- 7. All windows and doors will remain closed from 21:00 onwards to abate noise pollution.
- 8. The outside drinking area will not be used after 23:00
- 9. All health and safety/fire safety etc requirements will be complied with
- 10. (1) The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

Please accept this as formal notification of the Greater Manchester Police objection to the premises licence in relation to the above premises on the grounds of Prevention of Crime and Disorder and the Prevention of Public Nuisance, Public Safety and the Protection of Children from Harm.

The application seeks to extend the licensable hours to remove a condition from the operating schedule and to alter the layout of the premises and the last date for representations was Monday 17<sup>th</sup> December 2018.

Licensing officers from GMP visited the premises on the early morning of Sunday 16<sup>th</sup> December and found that the premises were open and carrying our licensable activities with the new layout already in place. The entire premises was set out as a bar and there were no persons dining or any sign of a designated dining area.

This is despite condition 17 in Annex 2 of the Premises Licence which states that "No Less than 2/3 of the Trading Area shall be set out for Dining" and condition 3 in Annex 3 states that "The first floor of the Premises (Ocean Treasure) shall operate as a restaurant with ancillary bar. On the first floor, alcohol shall be sold either to persons dining at the premises, or pre and post meal drinks for those diners "

There was no evidence anywhere within the premises of any dining taking place and the premises was operating solely as a bar, with large numbers of vertical drinkers.

The layout changes have not been granted yet so the premises were operating in breach of the 2 conditions highlighted and in breach of their plans.

The operator of the premises was spoken to on the night and it was clear that he was unaware of these conditions so GMP would need to have another more formal meeting with the applicant to discuss the way the premises are to be operated and this needs to take place before we would be in agreement to what is being proposed within this variation.

We therefore ask that this variation is refused.

The Licensing and Out of Hours Team have assessed the likely impact of the late night premise at Ground and First Floor, 23 Peter Street taking into account a number of factors and the licensing objectives.

The premises is located on Peter Street in the City Centre. Peter Street is a busy area with a mixture of late night drinking establishments and clubs in the immediate vicinity with residential properties nearby which have historically been a source of noise complaints relating to noise outbreak from the many licensed premises on Peter Street. There are regular issues along Peter Street with queuing for entry to the licensed premises, customers wishing to smoke outside the premises and later with dispersal as customers leave the licenced premises and leave the area

Manchester City Council Statement of Licensing Policy 2016–2021 states

7.12 Where its discretion is engaged, the authority will give particular consideration to the general character of the surrounding area, including crime and antisocial behaviour (ASB) levels, litter problems, issues regarding underage or proxy sales, and noise complaints. Where there are demonstrable problems linked to the operation of licensed premises in the area and the evidence demonstrates problems with licensed premises in the area, the licensing authority will, in exercising its discretion, take this into consideration when deciding what (if any) steps are appropriate and proportionate in the individual case.

7.13 The authority is mindful of problems that can arise around the clustering of licensed premises, where a number of premises closing simultaneously can lead to large numbers of people leaving at the same time, thereby increasing the risk of disorder and disturbance, as well as creating spikes in demand for taxis and other sources of transport or at takeaways.

  - (b) Outbreaks of disorder, or
  - (c) Damage,

unless otherwise entitled by virtue of section 4 of the Private Security Industry Act 2001 to carry out such activities.

#### Supply of alcohol

- 2. No supply of alcohol may be made under this premises licence:
  - (a) At a time when there is no designated premises supervisor in respect of the premises licence or,
  - (b) At a time when the designated premises supervisor does not hold a personal licence or his

personal licence is suspended.

- 3. Every retail sale or supply of alcohol made under this licence must be made or authorised by a person who holds a personal licence.
- 4. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
  - (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
  - (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either
    - (a) a holographic mark, or
    - (b) an ultraviolet feature.
- 5. (1) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price, which is less than the permitted price.
  - (2) For the purposes of the condition set out in (1) above—
    - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979
    - (b) "permitted price" is the price found by applying the formula-

$$P = D + (D \times V)$$

where -

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence
  - (i) the holder of the premises licence,
  - (ii) the designated premises supervisor (if any) in respect of such a licence, or
  - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "valued added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- (3) Where the permitted price given by paragraph (2)(b) would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- (4) Sub-paragraph (4)(b) applies where the permitted price given by paragraph (2)(b) on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
  - (b) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.
- 6. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

- (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises
  - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to
    - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
    - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
  - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective:
  - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
  - (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
  - (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
- 7. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 8. The responsible person must ensure that
  - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures
    - (i) beer or cider: ½ pint;
    - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
    - (iii) still wine in a glass: 125 ml;
  - (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
  - (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold the customer is made aware that these measures are available.

For the purposes of conditions 6, 7 and 8 above, a responsible person in relation to a licensed premises means the holder of the premise licence in respect of the premises, the designated premises supervisor (if any) or any individual aged 18 or over who is authorised by either the licence holder or designated premises supervisor. For premises with a club premises certificate, any member or officer of the club present on the premises in a capacity that which enables him to prevent the supply of alcohol.

#### **Exhibition of films**

- 9. The admission of children under the age of 18 to film exhibitions permitted under the terms of this certificate shall be restricted in accordance with any recommendations made:
  - (a) by the British Board of Film Classification (BBFC) where the film has been classified by that Board, or
  - (b) by the Licensing Authority where no classification certificate has been granted by the BBFC, or where the licensing authority has notified the club which holds the certificate that section 20 (3) (b) (74 (3)(b) for clubs) of the Licensing Act 2003 applies to the film.

#### Annex 2 – Conditions consistent with the operating schedule

- Any area where customers have legitimate access shall be sufficiently illuminated for the purposes of CCTV.
- 2. CCTV shall be in operation at all times the premises is open to trade.
- 3. All CCTV recorded images shall have sufficient clarity / quality / definition to enable facial recognition.
- 4. CCTV shall be kept in an unedited format for a minimum period of 28 days.
- 5. CCTV shall be maintained on a regular basis and kept in good working order at all times.
- 6. CCTV maintenance records shall be kept with details of contractor used and work carried out shall be recorded.
- 7. Where CCTV is recorded on to a hard drive system any DVDs subsequently produced shall be in a format so it can be played back on a standard personal computer or standard DVD player.
- 8. Where CCTV is recorded on to a hard drive system, the hard drive system shall have a minimum of 28-day roll over recording period.
- 9. Any person left in charge of the premises shall be trained in the use of any such CCTV equipment and able to produce / download / burn CCTV images upon request by a person from a responsible authority.
- 10. Plans indicating the position of CCTV cameras shall be submitted to the responsible bodies within one week of the granting of a licence requiring CCTV.
- 11. Where the recording is on a removable medium (ie compact disc, flash card etc), a secure storage system to store those recording mediums shall be provided.
- 12. Whenever licensable activities continue after midnight a minimum of two SIA registered door staff shall be on duty no later than 2200. A further door supervisor shall be employed based on capacity at a ratio of 1:100 customers (e.g. 290 customers = 3 x SIA).
- 13. They shall remain on duty until the premises are closed and shall clearly display their SIA badges on their person at all times when on duty.
- 14. Door staff shall sign on and off duty in a book kept for that purpose and all entries shall be checked and signed by the DPS or their nominated deputy.
- 15. An additional book shall be kept at the premises which shall contain the full names, current addresses, dates of birth, badge number and up to date photograph of all door staff who work at the premises.
- 16. No 'stand-alone' dance events shall take place at the premises.
- 17. No less than 2/3rds of the trading area shall be set out for dining.
- 18. Signs requesting that customers leave the premises quietly having respect for nearby residents shall be displayed at the exit.
- 19. No glassware shall be collected from the premises or be disposed of into outside waste receptacles between 2200 and 0800.
- 20. A Taxi ringback scheme shall be operated.
- 21. A challenge 25 policy shall be in force at all times, requiring production of valid photographic ID.
- 22. A refusals book containing records of instances/persons who have been refused the supply of alcohol on the basis of their perceived age shall be completed and maintained.
- 23. Staff shall be trained (and undergo regular refresher training) in respect of the sale of all age-restricted goods (including awareness/prevention of proxy sales) such training sessions shall be documented and records made available to authorised persons from Responsible Authorities.

#### Annex 3 - Conditions attached after hearing by the licensing authority

1. Noise from patrons of the premises or from regulated entertainment at the premises shall not cause a

- noise nuisance at the nearest sensitive receptor.
- 2. Written policies with regards to smoking, queuing and dispersal shall be approved with Environmental Health and Greater Manchester Police these policies shall not be modified otherwise than in consultation with and with the agreement of Environmental Health and Greater Manchester Police.
- 3. The first floor of the premises (Ocean Treasure) shall operate as a restaurant with ancillary bar. On the first floor, alcohol shall be sold either to persons dining at the premises, or for pre and post meal drinks for those diners.
- 4. No dancing shall be permitted on the first floor of the premises (subject to the condition below).
- 5. On giving no less than 7 days' notice to GMP of a private, pre-arranged function which is due to take place on the first floor, this area may be used for dancing subject to a GMP veto. Such notice shall be given to GMP by email and shall include the nature of the event, organisers name and telephone number. If GMP objects to the event in writing (by email) within 48 hours, no dancing shall be permitted during the function.
- 6. Hours for licensable activities on New Year's Eve shall be restricted to 0200.
- 7. On Thursdays, Fridays and Saturdays, a minimum of 2 SIA door supervisors shall be employed from 2200. Further door supervisors shall be employed based on capacity at a ratio of 1:100 customers (e.g. 290 customers = 3 x SIA).
- 8. On notification to the DPS by GMP or Cityco of the name and photograph of any "undesirable" the DPS shall use his/her best endeavours to ensure that such person is not admitted to the premises.
- 9. The premises shall operate a music policy, dress code policy, glass policy and emergency response plan, which shall be agreed with GMP and lodged with the licensing authority.
