Ofsted inspections in Manchester Sept 2018 to Dec 12th 2018

There have been 11 inspections during this period. This is a decrease on the number of schools inspected in autumn term 2017.

Of these 9 took place in primary schools and 2 in High schools.

An HMI visit of a school currently judged to be RI also took place and found that the school was making appropriate progress towards becoming good.

One primary moved from RI to good, one moved from good to RI and 7 primary schools remain good, Of these one will be re-visited within the next 12-24 months to see if it is outstanding. Out of 9 primary schools inspections 89% were judged to be good or better during this time.

There have been 2 secondary school inspections. 1 secondary school moved from RI to outstanding, the final report for another is still to be published.

The current inspection process (where schools have no serious triggers for inspection) is a Section 8 inspection which typically lasts for 1 day. Where this confirms the school is good this is where the inspection ends. However if the school is potentially outstanding or the evidence base points to the school being less than good a section 5 inspection will be recommended within 12 to 24 months.

% of pupils attending a good or better school

83.5% of pupils in Manchester attend a primary or secondary school that is judged to be good or better by OfSTED. (Nationally this is 86.5%, and in the NW 84.1%)

90.1% of pupils in Manchester attend a primary school that is judged to be good or better by OfSTED. (Nationally this is 88.9%, and in the NW 90.3%)

70.9% of pupils in Manchester attend a secondary school that is judged to be good or better by OfSTED. (Nationally this is 82.9%, and in the NW 73.9%)

%of schools that are good or better

86.7% of schools in Manchester are judged to be good or better. (Nationally 87.9% NW 87.9%)

90.9% of primary schools in Manchester are judged to be good or better. (Nationally 89.3% NW 90.8%)

65.4% of schools in Manchester are judged to be good or better. (Nationally 80.3% NW 71%)
