- 21 schools were inspected between March and July 2019.
- One school remained as requires improvement however improvements were evident:
  - Leaders, governors and trustees are on a transformational journey to improve the school.
  - The proportion of pupils, including disadvantaged pupils, who achieve a standard or strong pass in English and mathematics is good and improving.
  - Most middle leaders have a strong focus on improving teaching and learning. They receive effective ongoing training from senior leaders.
  - There is a strong culture of safeguarding in the school, coupled with effective pastoral support.
- 5 schools improved from requires improvement to good.

- 11 schools remained good.
- Two schools improved from good to outstanding.
- One school moved from outstanding to good however the following points were noted:
  - The headteacher and the governing body have successfully addressed previous leadership issues that contributed to a decline in standards. They have ensured that the school now provides a good quality of education.
  - Leaders have taken effective action to ensure that the quality of teaching, learning and assessment has improved and is now good.
  - Leaders provide an interesting and broad curriculum that contributes effectively to pupils' development.
  - Governors have an accurate view of standards in the school. They challenge leaders strongly and are ambitious for further improvement.
  - There is a strong culture of safeguarding in the school. Pupils feel safe and know how to stay safe.
- One school was judged outstanding at their first inspection.

### Summary of Ofsted outcomes in Manchester 2018-2019

- 47 schools were inspected: 5 judged outstanding, 32 good, 6 requires improvement and 1 inadequate. 3 schools were taking effective action towards being removed from special measures.
- 89.4% overall schools good or better
- 87% pupils attend a good or better school (5th highest in the North West)
- 92.5% Primary schools good or better
- 74.1% Secondary schools good or better; a 26% improvement from June 2018 and 2nd highest in Greater Manchester
