1. <u>Introduction</u>

- 1.1 On 05 January 2021, an application for the variation of an existing Premises Licence under s34 of the Licensing Act 2003 was made in respect of West Village, 220 Burton Road, Manchester, M20 2LW in the Didsbury West ward of Manchester. A location map of the premises is attached at **Appendix 1**.
- 1.2 A 28-day public consultation exercise was undertaken in accordance with Licensing Act 2003 regulations; requiring the application to be advertised by the displaying of a blue notice at or on the premises, a notice published in a newspaper or similar circulating in the local area, and details of the application published on the Council's website.
- 1.3 Representations may be made for or against an application during the consultation period. To be 'relevant' and, therefore, able to be taken into account in determining the application, they must be about the likely effect of the grant of the premises licence on the promotion of the licensing objectives. Where representations are made by persons who are not a responsible authority, they must not be frivolous or vexatious.
- 1.4 Relevant representations have been received in respect of this application and so it must be determined by a Licensing Hearing Panel in accordance with the Council's Constitution.

2. Current Licence

2.1 The premises licence holder is Urban Village Bars (Didsbury) Limited and a copy of the current licence is attached at **Appendix 2.**

3. The Application

- 3.1 A copy of the application is attached at **Appendix 3.**
- 3.2 The variation is to extend the hours for sale of alcohol from:
 - 11.00 23.00 Monday to Sunday, to:
 - 11.00 00.00 Sunday to Thursday & 11.00 01.00 Friday to Saturday

Supply of alcohol for consumption both on and off the premises:

Current hours: Mon to Sun 11am to 11pm, Seasonal Variations: None Proposed hours: Sun to Thurs 11am to midnight, Fri to Sat 11am to 1am Seasonal Variations: An extension of one hour from midnight to 1am on bank holidays

Opening hours:

Current hours: Mon to Sun 11am to 11.30pm, Seasonal Variations: None Proposed hours: Sun to Thurs 11am to 12.30am, Fri to Sat 11am to 1.30am Seasonal Variations: An extension of one hour from 12.30am to 1.30am on bank holidays

- 3.2.1 In accordance with the Live Music Act 2012 and Deregulation Act 2015, performances of Live Music and Recorded Music between the hours of 0800 and 2300 hours have been deregulated and so should not be regarded as licensable activities for the purposes of this application.
- 3.2.2 Any further details provided relating to any of the individual licensable activities are specified on the application form at **Appendix 3**.
- 3.3 Activities unsuitable for children
- 3.3.1 The applicant has not highlighted any adult entertainment or services, activities, other entertainment or matters ancillary to the use of the premises that may give rise to concern in respect of children.
- 3.4 Steps to promote the licensing objectives
- 3.4.1 The applicant has not proposed any additional steps to promote the licensing objectives.

4. Relevant Representations

4.1 A total of five relevant representations were received in respect of the application (**Appendix 4**). The personal details of all members of the public have been redacted. Original copies of these representation will be available to the Committee at the hearing.

- 4.2 Summary of the representations:

4.3 No conditions have been proposed by the objectors.

5. **Key Policies and Considerations**

5.1 **Legal Considerations**

5.1.1 Hearings under the Licensing Act 2003 operate under the Licensing Act 2003 (Hearings) Regulations 2005.

5.2 **New Information**

5.2.1 In accordance with Regulation 18 of the Licensing Act 2003 (Hearings)
Regulations 2005, the authority may take into account documentary or other
information produced by a party in support of their application, representations
or notice either before the hearing or, with the consent of all parties, at the
hearing.

5.3 **Hearsay Evidence**

5.3.1 The Panel may accept hearsay evidence and it will be a matter for the Panel to attach what weight to it that they consider appropriate. Hearsay evidence is evidence of something that a witness neither saw nor heard, but has heard or read about.

5.4 The Secretary of State's Guidance to the Licensing Act 2003

5.4.1 The Secretary of State's Guidance to the Licensing Act 2003 is provided for all parties involved in licensing. It is a key medium for promoting best practice, ensuring consistent application of licensing powers across England and Wales and for promoting fairness, equal treatment and proportionality.

- 5.4.2 Section 4 of the 2003 Act provides that, in carrying out its functions, a licensing authority must 'have regard to' guidance issued by the Secretary of State under section 182. The Guidance is therefore binding on all licensing authorities to that extent. However, the Guidance cannot anticipate every possible scenario or set of circumstances that may arise and, as long as licensing authorities have properly understood this Guidance, they may depart from it if they have good reason to do so and can provide full reasons.
- 5.4.3 Departure from the Guidance could give rise to an appeal or judicial review, and the reasons given will then be a key consideration for the courts when considering the lawfulness and merits of any decision taken.

5.5 Manchester Statement of Licensing Policy

- 5.5.1 Section 4 of the 2003 Act provides that, in carrying out its functions, a licensing authority must 'have regard to' its statement of licensing policy.
- 5.5.2 The Licensing Policy sets out the vision the licensing authority has for the regulation of licensed premises throughout Manchester and outlines the standards expected in order to ensure the promotion of the licensing objectives in the city. The Panel may depart from the policies should it consider doing so would benefit the promotion of the licensing objectives. Reasons are to be given for any such departure from the Policy.
- 5.5.3 Section 4 of the Policy (Operation of the Policy) sets out how the Licensing Policy is intended to be used in practice for licence applications and licensed premises.
- 5.5.4 Relevant to this application and the grounds of the representations made, the Panel are recommended to have regard to the following sections of the Policy:

Section 6: What we aim to encourage

This section identifies certain types of venues and initiatives the licensing authority aims to encourage in order to promote an inclusive evening and night-time economy not simply focused on the consumption of alcohol. We aim to encourage:

- Premises that will extend the diversity of entertainment and attract a wider range of participants
- Live music, especially original material, which will provide a range of live performances and styles of music, provided that such entertainment does not undermine the licensing objectives
- National cultural institutions, global sports events and cultural festivals
- Non-drink-led premises, including restaurants, cafes, theatres and cinemas
- Communication and integration with local residents and businesses through licensees consulting with those in the local area prior to an application
- Participation in Pubwatches, off licence forums and other crime-reduction partnerships

- Engagement with the NITENET radio scheme and DISC secure information sharing platform by city centre venues through the Cityco Manchester Business Crime Reduction Partnership
- Designing out crime in the layout of the premises

Section 7: Local factors

This section sets out key issues that applicants are expected to take into account relevant to the individual characteristics of the premises when preparing their operating schedule and address any local factors relevant to their premises.

Having regard to the grounds of the representations made, the Panel are recommended to have regard to the following Factors:

- Identified risk factors specific to the licensed premises
- Evidence of pre-existing problems in the area
- Consistency with relevant Council strategies
- The proximity of the premises to local residents and other local businesses, particularly in relation to the potential for nuisance
- Ability to clean and maintain the street scene

Section 8: Manchester's standards to promote the licensing objectives

This section identifies the standards that the licensing authority expects of licensed premises in Manchester. It is recognised that not all standards will be appropriate to apply in every situation to every premises, and applicants are not obliged to include all standards in their operating schedule. The degree to which standards would be appropriate is expected to be proportionate to the risk posed against the promotion of the licensing objectives having regard to the individual circumstances of the premises. The standards are not exhaustive and the licensing authority will have regard to any relevant issues raised in any representation that may fall outside them.

MS5	Prevent on-street consumption of alcohol
MS8	Prevent noise nuisance from the premises
MS9	Effectively manage exterior spaces (e.g. beer gardens, smoking

Section 9: Alcohol delivery services

This section sets out specific provisions for alcohol delivery services to be considered in conjunction with relevant standards from Section 8 of the Policy

Section 10: Adult entertainment (including striptease, nudity and other entertainment of a sexual nature)

This section sets out specific considerations in respect of applications to provide adult entertainment, including entertainment of a sexual nature e.g. nudity, striptease and lap dancing.

Section 11: The use of tables and chairs on the public highway

This section provides that the operation of any areas on the public highway licensed for tables and chairs should be considered with regard to all relevant Standards set out in Section 8 of the Policy.

Section 12: Premises Licences for large-scale public events


This section sets out particular expectations regarding large scale public events, given the specific associated risks.

6. **Conclusion**

- A licensing authority must carry out its functions under this Act ("licensing functions") with a view to promoting the licensing objectives:
 - the prevention of crime and disorder
 - public safety;
 - the prevention of public nuisance; and
 - the protection of children from harm.
- 6.2 In considering the matter, the Panel should take into account any representations or objections that have been received from responsible authorities or other persons, and representations made by the applicant or premises user as the case may be. In reaching the decision, regard must also be had to relevant provisions of the national guidance and the Council's licensing policy statement.
- The Panel must take such of the steps set out below that it considers appropriate for the promotion of the licensing objectives:
 - To grant the licence subject to the conditions consistent with the operating schedule accompanying the application, which the Panel may modify to such extent as they consider appropriate;
 - b) To reject the whole or part of the application
- 6.4 The conditions consistent with the operating schedule may be modified to alter or omit any of them or to add any new condition, including restricting the times at which licensable activities authorised by the licence can take place.
- 6.5 However, conditions should not be imposed on a licence which are unrelated to the variation sought.
- 6.6 All licensing determinations should be considered on the individual merits of the application.
- 6.7 The Panel's determination should be evidence-based, justified as being appropriate for the promotion of the licensing objectives and proportionate to what it is intended to achieve. Findings on any issues of fact should be on the balance of probability.
- 6.8 It is important that a licensing authority should give comprehensive reasons for its decisions in anticipation of any appeals. Failure to give adequate reasons could itself give rise to grounds for an appeal.

6.9 The Panel is asked to determine the application.

Annex 1 – Mandatory conditions

Door Supervisors

- Only individuals licensed by the Security Industry Authority shall be used at the premises to undertake 1. security activities, which include guarding against: -
 - Unauthorised access or occupation (e.g. through door supervision),
 - (b) Outbreaks of disorder, or
 - (c) Damage,

unless otherwise entitled by virtue of section 4 of the Private Security Industry Act 2001 to carry out such activities.

Supply of alcohol

- No supply of alcohol may be made under this premises licence: 2.
 - At a time when there is no designated premises supervisor in respect of the premises licence or, (a)
 - At a time when the designated premises supervisor does not hold a personal licence or his (b) personal licence is suspended.
- Every retail sale or supply of alcohol made under this licence must be made or authorised by a person 3. who holds a personal licence.
- The premises licence holder or club premises certificate holder must ensure that an age 4. (1) verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
 - The designated premises supervisor in relation to the premises licence must ensure that the (2)supply of alcohol at the premises is carried on in accordance with the age verification policy.
 - The policy must require individuals who appear to the responsible person to be under 18 years of (3) age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either
 - a holographic mark, or (a)
 - (b) an ultraviolet feature.
- A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the 5. (1) premises for a price, which is less than the permitted price.
 - For the purposes of the condition set out in (1) above-(2)
 - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979
 - "permitted price" is the price found by applying the formula-(b)

$$P = D + (D \times V)$$

where -

- P is the permitted price, (i)
- D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;

- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence
 - (i) the holder of the premises licence,
 - (ii) the designated premises supervisor (if any) in respect of such a licence, or
 - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence:
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "valued added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- (3) Where the permitted price given by paragraph (2)(b) would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- (4) (a) Sub-paragraph (4)(b) applies where the permitted price given by paragraph (2)(b) on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
 - (b) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.
- 6. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
 - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises
 - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to
 - drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
 - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
 - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
 - (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
 - (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
- 7. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 8. The responsible person must ensure that
 - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures –

- (i) beer or cider: ½ pint;
- (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
- (iii) still wine in a glass: 125 ml;
- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold the customer is made aware that these measures are available.

For the purposes of conditions 6, 7 and 8 above, a responsible person in relation to a licensed premises means the holder of the premise licence in respect of the premises, the designated premises supervisor (if any) or any individual aged 18 or over who is authorised by either the licence holder or designated premises supervisor. For premises with a club premises certificate, any member or officer of the club present on the premises in a capacity that which enables him to prevent the supply of alcohol.

Annex 2 – Conditions consistent with the operating schedule

- 1. CCTV shall be installed at the premises
- 2. Alcohol shall not be taken off the premises save for sealed containers.
- 3. The manager /Designated Premises Supervisor shall request that customers leave the premises quietly at the end of the evening.
- 4. A notice requesting customers leave quietly will be displayed at the exit of the premise.
- 5. The manager/ Designated Premises Supervisor shall assist in the calling of taxis for customers when requested.
- 6. All members of staff shall be trained in the law relating to the sale of alcohol to those underage.

Annex 3 – Conditions attached after hearing by the licensing authority

- 1. Members of staff shall take reasonable steps to prevent customers congregating outside the premises and to encourage dispersal at the end of the evening.
- 2. Members of staff shall request that any customers smoking outside the premises do so quietly, out of consideration to neighbours.
- 3. Suitable receptacles for the disposal of cigarette litter shall be provided for customers.
- 4. At the end of each evening, members of staff shall ensure that any litter is cleared from the front of the premises.
- 5. A 'Challenge 21' policy shall be implemented in full at the premises. Appropriate identification must be sought from any person who appears to be under the age of 21. The only acceptable forms of identification will be a passport, photographic driving licence and those bearing the PASS logo. Staff training to include the Challenge 21 policy.
- 6. The bi-fold doors at the front of the premises shall be closed and shall remain closed at all times after 2230 daily.
- 7. The rear yard and access alleyway shall not be used at any time for customer smoking.
- 8. Staff shall be permitted to smoke in the rear yard (but not the shared access alleyway) but no more than 3 persons shall be permitted to do so at any one time.
- 9. Staff using the rear yard to smoke shall be advised of the need to keep noise to a minimum so as not to disturb nearby residents.
- 10. Staff using the rear yard shall not be permitted to speak on their mobile phones whilst in the yard.
- 11. Staff shall not be permitted to use the rear yard to smoke after midnight.



WDRA wish to make a representation as follows:

The variation seeks extension of permitted times for alcohol supply:

by one hour until 00:00 midnight Sunday until Thursday,

by two hours until 01:00 Friday and Saturday

with changed customer opening hours Current hours: Mon to Sun 11am to 11.30pm

Proposed hours: Sun to Thurs 11am to 12.30am, Fri to Sat 11am to 1.30am

These premises have a past record of trading outside the limits permitted by the premises licence, causing great disturbance to neighbours and footpath users and including late night disturbance to neighbouring residents. Permitting this variation would almost certainly encourage further public nuisance.

We are aware that under the present covid lock down any variation is, for the present, academic as no alcohol may be supplied for consumption on or off the premises. However the covid lock down is we hope a situation that will end some time. The application seeks variation to a consent for supply of alcohol for consumption **both on and off the premises**.

The premises have past history of causing public nuisance associated with inconsiderate use of pavement, noise from outside drinkers. Extension of opening hours has the potential to produce additional later evening disturbance and would also encourage similar applications from neighbouring establishments.

WDRA wish to object to these proposed variations which would extend into the late evening the potential for public nuisance from both on sales and off sales customers.

In the spirit of compromise can we propose supply of alcohol on Friday and Saturday evenings be permitted until 00:00 midnight, with Friday and Saturday hours of opening permitted until 00:30.

Hello there

I understand that West Village has applied to extend its opening hours until midnight on weekdays and 1 am on Friday and Saturday.

I very much appreciate that independent businesses in the hospitality industry have been severely impacted by the ongoing covid 19 crisis and that they will seek to mitigate the impact once they are able to open again. It seems reasonable that while social distancing measures remain in force, business will have to adapt to ensure that their loss of footfall and income is minimised, and that this could be achieved in part by limiting customer numbers while extending opening hours.

Burton Road and the surrounding streets are, however, heavily residential and home to many families with small children. A large number of residents are also working from home where possible in line with local and national guidance. This means our homes are also our workplaces. Sadly, I have witnessed antisocial behaviour outside the shack, the unit which is now Mary and Archie's. I've seen customers spilling out into the road causing disruption to other pedestrians and traffic, and urinating on the pavement, in one instance against a private residential property on Orchard Street. No door staff were visible in either case.

With this context in mind I have a few questions about the application and the conditions on which the late license may be granted. I feel these are critical to understanding the potential impact of the application, should it be successful.

- 1. Are there specific guidelines or guidance currently in place for either decision makers in the licensing department, or applicants, that take account of the impact of social distancing measures, and both the primary and secondary legislation currently in force as regards coronavirus? - 2. Have the applicants made clear and thorough reference to the measures they will employ to ensure compliance with any required social distancing measures, including but not limited to caps on the numbers of persons allowed in the venue at any one time, and sufficient PPE and hygiene measures to protect staff and customers?

For reference, We currently struggle with the
noise during an average week but as the hours are curtailed to 11pm, we currently cope and acknowledge the bar has to operate. However, to increase the operating hours to 12 and 1am
respectively is completely unreasonable for many reasons. Before I outline my major concerns, I'd
like to provide an overview of the Didsbury Bar scene currently.

Burton Rd currently has a chilled bar scene where the majority use as a pit stop before heading into the city centre where operational hours are later. This means that at 11pm people tend to move on, albeit fairly slowly. If this extension was granted, Didsbury would be seen as a whole night destination which would mean more would visit Burton Rd to stay for the entire night. As we see in

city centre locations, this ends with increased public disorder due to bar goers having more drinking time, and increased levels of potential for criminal activity. There's also the increased traffic at late hours with taxis etc taking those hanging around - home. I'd like to believe those who are deciding on this application, will look at the situation as a whole.

Above being said, my concerns are as follows:

Firstly, I've attached ar image for reference My concern is that this pathway, which is where the bins are stored, is not lit at all and already provides a safe haven for criminal activity. I'm deeply concerned that any increase to operating hours will only increase the chances of criminal activity down this ally way. Having being burgled at our previous address in Didsbury, this affects us deeply. I'd like to state, the answer to this in not installing lights,
Secondly, noise disruption is a major concern. Currently, the rear door to the bar,
is constantly thrown open by the staff members to put out all the trash during the night. This means bottles are thrown into large bins between 9pm and 11pm (can be seen in image - blue lids) currently or various different occasions throughout the night. It causes an absolute racket and inevitably wakes us up.
Equally, when the bars close, all those who spill out onto the road tend to hand around until 11.30 /12 causing further noise beyond operational hours. If this were to be extended to 1am on Friday, we would not get to sleep until 1.30 /2am without fail. This is entirely unfair, especially as my partner, works weekends.
Thirdly, I'm also concerned this would set a precedent for other bars to seek an extension to operating hours on Burton Rd which will cause noise pollution far beyond what would be deemed fair and reasonable. Other bars on that street staff smoke in the outside space and cause additional noise. West Village aren't the worst offenders with this but it does happen. So not only are bottles thrown out during current operational hours, staff use this space to smoke. This inevitably happens after the bar has closed when the staff take a moment before going home.
This application can't be seen as $12/1$ am closing, as the noise and potential for criminality goes far beyond this time frame.
Lastly, I'm sure our neighbours at will raise this, but incase they did not receive the note in time, they also have a very young child who would struggle to sleep and therefore concentrate at school during her most formative years. Truly unacceptable in my view.

Anyway, I'm not one to usually complain about planning applications. However, on this occasion I genuinely believe it is wholly unreasonable for the reasons laid out above, and would inadvertently

set a tone for others to follow which would affect local residents deeply.

Please see our comments in relation to the above application, below.

It is with dismay that we understand that West Village is applying for an extension to their current opening hours and their license to sell alcohol.

We have attached a summary of the current opportunities for the public to acquire alcohol via pubs, restaurants and retail shops on a section of Burton Road which we measured as only 313 metres between Nell Lane and Cavendish Road. As you will see in the pdf attachment, this short area has currently 29 establishments which sell alcohol. Three of whom we understand have a late license already. I think you will agree that this densely populated residential area does not need an increase in alcohol licensing of any description for any establishment and the public is adequately served regarding their current ability to obtain alcohol.

As residents of this area of West Didsbury we are already living with unacceptable noise, litter and drug/alcohol taking in the streets and alleyways on Thursday, Friday, Saturday and Sunday nights in particular plus problems with parking. It is also difficult in (normal times) to push a pram or get a wheelchair down this part of Burton Road as bars and restaurants have got seating on the pavement in front of their premises. This has an affect on public safety.

We believe there are few benefits for those of us who live here; it is a residential area, and to approve further extensions to opening hours and alcohol sales would continue to erode this neighbourhood further and increase public nuisance and disorder.
