1. Introduction

- On 02/05/2023, an application for the variation of an existing Premises Licence under s34 of the Licensing Act 2003 was made in respect of Fallowfield Convenience Store, 240-242 Wilmslow Road, Manchester, M14 6LD in the Fallowfield ward of Manchester. A location map of the premises is attached at **Appendix 1**.
- 1.2 A 28-day public consultation exercise was undertaken in accordance with Licensing Act 2003 regulations; requiring the application to be advertised by the displaying of a blue notice at or on the premises, a notice published in a newspaper or similar circulating in the local area, and details of the application published on the Council's website.
- 1.3 Representations may be made for or against an application during the consultation period. To be 'relevant' and, therefore, able to be taken into account in determining the application, they must be about the likely effect of the grant of the premises licence on the promotion of the licensing objectives. Where representations are made by persons who are not a responsible authority, they must not be frivolous or vexatious.
- 1.4 Relevant representations have been received in respect of this application and so it must be determined by a Licensing Hearing Panel in accordance with the Council's Constitution.

2. Current Licence

2.1 The premises licence holder is Mr Ehsan Ali and a copy of the current licence is attached at **Appendix 2**.

3. The Application

- 3.1 A copy of the application is attached at **Appendix 3.**
- 3.2 The variation is to:

Vary the hours for the sale of alcohol and opening hours and the addition of late night refreshment.

The premises is an existing convenience store that has been operated by the applicant without problems or complaints.

All types of convenience products are sold including fresh & frozen food, toiletries, household, newspapers etc. Other services are also offered to customers such as the ability to pay bills & collect/send packages.

In terms of addressing the licensing objectives, the existing licence has several robust conditions and those have been supplemented by additional measures volunteered within this application to ensure the continuing support of the licensing objectives.

Proposed hours and licensable activities:

Provision of late night refreshment (indoors):

Current hours: Not currently permitted Proposed hours: Mon to Sun 11pm to 2am

Supply of alcohol for consumption off the premises only:

Current hours: Mon to Sun 8am to 12 midnight Proposed hours: Mon to Sun 8am to 2am

Opening hours:

Current hours: Mon to Sun 8am to 12 midnight Proposed hours: Mon to Sun 8am to 2am

Steps to promote licensing objectives as given by the applicant

Removal of condition 7 (Annex 2)

Removal of condition 12 (Annex 2) – replaced by improved version.

Removal of condition 1 (Annex 3)

Removal of condition 2 (Annex 3) – replaced by improved version.

On first appointment, all staff employed at the premises shall receive training on the Licensing Act 2003 including input on preventing underage sales, preventing sales of alcohol to people who are drunk and any other relevant matters. Training shall be regularly refreshed at no less than annual intervals. The training must be recorded and be accessible on the premises and made available for inspection upon request of a Police Officer or an authorised officer of the licensing authority or (in the case of online training) within 48 hours.

All crimes to be reported to police.

The premises licence holder shall ensure that a risk assessment is completed to determine if door supervisors are required to cover busier periods of the week.

There shall be no sales of beer, lager or cider with an alcohol content above 6.5% ABV in metal or plastic containers. This restriction shall not apply in respect of specialist branded premium priced products, for example craft ales, local or micro-brewery specialist products, boxed gifts or national celebratory/commemorative beer, lager or cider. Staff shall reinforce that alcohol should not be consumed in the street at point of sale, where appropriate.

Notices shall be displayed at the entrance/exit to the premises asking customers to leave the store quietly and respect local residents.

The premises shall adopt a 'Challenge 25' policy. This means that if a customer purchasing alcohol appears to be under the age of 25, they will be asked for proof of their age, to prove that they are 18 years or older.

The only forms of identification that will be accepted will bear their photograph, date of birth and a holographic mark and/or ultraviolet feature. Examples of appropriate identification include a passport, photocard driving licence, military ID, and Home Office approved proof of age ID card bearing the PASS hologram.

- 3.2.1 In accordance with the Live Music Act 2012 and Deregulation Act 2015, performances of Live Music and Recorded Music between the hours of 0800 and 2300 hours have been deregulated and so should not be regarded as licensable activities for the purposes of this application.
- 3.2.2 Any further details provided relating to any of the individual licensable activities are specified on the application form at **Appendix 3**.
- 3.3 Activities unsuitable for children
- 3.3.1 The applicant has not highlighted any adult entertainment or services, activities, other entertainment or matters ancillary to the use of the premises that may give rise to concern in respect of children.
- 3.4 Steps to promote the licensing objectives
- 3.4.1 The applicant proposes to promote the licensing objectives by taking the steps identified in the operating schedule.
- 3.4.2 These steps must be translated into conditions by the licensing authority to be included in any granted premises licence, unless the conditions are modified by the Panel following consideration of relevant representations. These conditions are set out in the Schedule of Conditions at **Appendix 4**.

4. Relevant Representations

4.1 A total of 12 relevant representations were received in respect of the application (**Appendix 5**). The personal details of all members of the public have been redacted. Original copies of these representation will be available to the Committee at the hearing.

- 4.2 Summary of the representations: AMEND AS NECESSARY

- 4.4 No agreements on conditions have been reached with persons making representations.
- 5. **Key Policies and Considerations**
- 5.1 Legal Considerations
- 5.1.1 Hearings under the Licensing Act 2003 operate under the Licensing Act 2003 (Hearings) Regulations 2005.
- 5.2 **New Information**
- 5.2.1 In accordance with Regulation 18 of the Licensing Act 2003 (Hearings)
 Regulations 2005, the authority may take into account documentary or other
 information produced by a party in support of their application, representations
 or notice either before the hearing or, with the consent of all parties, at the
 hearing.
- 5.3 **Hearsay Evidence**
- 5.3.1 The Panel may accept hearsay evidence and it will be a matter for the Panel to attach what weight to it that they consider appropriate. Hearsay evidence is evidence of something that a witness neither saw nor heard, but has heard or read about.
- 5.4 The Secretary of State's Guidance to the Licensing Act 2003

- 5.4.1 The Secretary of State's Guidance to the Licensing Act 2003 is provided for all parties involved in licensing. It is a key medium for promoting best practice, ensuring consistent application of licensing powers across England and Wales and for promoting fairness, equal treatment and proportionality.
- 5.4.2 Section 4 of the 2003 Act provides that, in carrying out its functions, a licensing authority must 'have regard to' guidance issued by the Secretary of State under section 182. The Guidance is therefore binding on all licensing authorities to that extent. However, the Guidance cannot anticipate every possible scenario or set of circumstances that may arise and, as long as licensing authorities have properly understood this Guidance, they may depart from it if they have good reason to do so and can provide full reasons.
- 5.4.3 Departure from the Guidance could give rise to an appeal or judicial review, and the reasons given will then be a key consideration for the courts when considering the lawfulness and merits of any decision taken.

5.5 Manchester Statement of Licensing Policy

- 5.5.1 Section 4 of the 2003 Act provides that, in carrying out its functions, a licensing authority must 'have regard to' its statement of licensing policy.
- 5.5.2 The Licensing Policy sets out the vision the licensing authority has for the regulation of licensed premises throughout Manchester and outlines the standards expected in order to ensure the promotion of the licensing objectives in the city. The Panel may depart from the policies should it consider doing so would benefit the promotion of the licensing objectives. Reasons are to be given for any such departure from the Policy.
- 5.5.3 Section 4 of the Policy (Operation of the Policy) sets out how the Licensing Policy is intended to be used in practice for licence applications and licensed premises.
- 5.5.4 Relevant to this application and the grounds of the representations made, the Panel are recommended to have regard to the following sections of the Policy:

Section 5: Special Policy Area

The premises is located within the following special policy area:

Fallowfield and Wilmslow Road

The effect of the Special Policy is that the Council will refuse applications for a new Premises Licence or Club Premises Certificate, or variation of an existing licence or certificate, whenever it receives relevant representation, unless an applicant can demonstrate why the operation of the premises involved will not add to the cumulative impact already being experienced. In relation to variations, this includes any variation that seeks to add a licensable activity, increase the capacity/size of a licensed premises, or extend the hours for licensable activities, but will usually exclude minor variations.

Section 6: What we aim to encourage

This section identifies certain types of venues and initiatives the licensing authority aims to encourage in order to promote an inclusive evening and night-time economy not simply focused on the consumption of alcohol. We aim to encourage:

- Premises that will extend the diversity of entertainment and attract a wider range of participants
- Live music, especially original material, which will provide a range of live performances and styles of music, provided that such entertainment does not undermine the licensing objectives
- National cultural institutions, global sports events and cultural festivals
- Non-drink-led premises, including restaurants, cafes, theatres and cinemas
- Communication and integration with local residents and businesses through licensees consulting with those in the local area prior to an application
- Participation in Pubwatches, off licence forums and other crime-reduction partnerships
- Engagement with the NITENET radio scheme and DISC secure information sharing platform by city centre venues through the Cityco Manchester Business Crime Reduction Partnership
- Designing out crime in the layout of the premises

Section 7: Local factors

This section sets out key issues that applicants are expected to take into account relevant to the individual characteristics of the premises when preparing their operating schedule and address any local factors relevant to their premises.

Having regard to the grounds of the representations made, the Panel are recommended to have regard to the following Factors:

- Identified risk factors specific to the licensed premises
- Evidence of pre-existing problems in the area
- Proximity of takeaways and off-licences to nightlife entertainment areas
- Consistency with relevant Council strategies
- The proximity of the premises to local residents and other local businesses, particularly in relation to the potential for nuisance
- Ability to clean and maintain the street scene

Section 8: Manchester's standards to promote the licensing objectives

This section identifies the standards that the licensing authority expects of licensed premises in Manchester. It is recognised that not all standards will be appropriate to apply in every situation to every premises, and applicants are not obliged to include all standards in their operating schedule. The degree to which standards would be appropriate is expected to be proportionate to the risk posed against the promotion of the licensing objectives having regard to the individual circumstances of the premises. The standards are not exhaustive and the licensing authority will have regard to any relevant issues raised in any representation that may fall outside them.

MS1 Implement effective security measures at the premises

MS2 Effective general management of the premises
 MS5 Prevent on-street consumption of alcohol
 MS8 Prevent noise nuisance from the premises
 MS10 Operate effective cleansing arrangements, including ensuring the premises and surrounding area are kept clean and free of litter, and adequate arrangements for the secure and responsible storage of refuse

6. **Conclusion**

- 6.1 A licensing authority must carry out its functions under this Act ("licensing functions") with a view to promoting the licensing objectives:
 - the prevention of crime and disorder
 - public safety;
 - the prevention of public nuisance; and
 - the protection of children from harm.
- 6.2 In considering the matter, the Panel should take into account any representations or objections that have been received from responsible authorities or other persons, and representations made by the applicant or premises user as the case may be. In reaching the decision, regard must also be had to relevant provisions of the national guidance and the Council's licensing policy statement.
- The Panel must take such of the steps set out below that it considers appropriate for the promotion of the licensing objectives:
 - To grant the licence subject to the conditions consistent with the operating schedule accompanying the application, which the Panel may modify to such extent as they consider appropriate;
 - b) To reject the whole or part of the application
- 6.4 The conditions consistent with the operating schedule may be modified to alter or omit any of them or to add any new condition, including restricting the times at which licensable activities authorised by the licence can take place.
- 6.5 However, conditions should not be imposed on a licence which are unrelated to the variation sought.
- 6.6 All licensing determinations should be considered on the individual merits of the application.
- 6.7 The Panel's determination should be evidence-based, justified as being appropriate for the promotion of the licensing objectives and proportionate to what it is intended to achieve. Findings on any issues of fact should be on the balance of probability.
- 6.8 It is important that a licensing authority should give comprehensive reasons for its decisions in anticipation of any appeals. Failure to give adequate reasons could itself give rise to grounds for an appeal.
- 6.9 The Panel is asked to determine the application.

Annex 1 – Mandatory conditions

Door Supervisors

- 1. Only individuals licensed by the Security Industry Authority shall be used at the premises to undertake security activities, which include guarding against: -
 - (a) Unauthorised access or occupation (e.g. through door supervision),
 - (b) Outbreaks of disorder, or
 - (c) Damage,

unless otherwise entitled by virtue of section 4 of the Private Security Industry Act 2001 to carry out such activities.

Supply of alcohol

- 2. No supply of alcohol may be made under this premises licence:
 - (a) At a time when there is no designated premises supervisor in respect of the premises licence or,
 - (b) At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- 3. Every retail sale or supply of alcohol made under this licence must be made or authorised by a person who holds a personal licence
- 4. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
 - (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
 - (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either —

- (a) a holographic mark, or
- (b) an ultraviolet feature.
- 5. (1) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price, which is less than the permitted price.
 - (2) For the purposes of the condition set out in (1) above—
 - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979
 - (b) "permitted price" is the price found by applying the formula-

$$P = D + (D \times V)$$

where -

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol:
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence
 - (i) the holder of the premises licence,
 - (ii) the designated premises supervisor (if any) in respect of such a licence, or
 - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence:
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- (3) Where the permitted price given by paragraph (2)(b) would (apart from this paragraph) not be a whole number of pennies, the price given by that subparagraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- (4) (a) Sub-paragraph (4)(b) applies where the permitted price given by paragraph (2)(b) on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
 - (b) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Annex 2 – Conditions consistent with the operating schedule

- 13. Notices shall be displayed in prominent positions indicating that the Challenge 25 Policy is in force.
- 14. Notices advising what forms of identification are acceptable shall be clearly displayed.
- 15. Notices explaining the law in relation to purchasing alcohol on behalf of persons under 18 shall be displayed.
- 16. The premises shall operate a refusals book; such book shall be shown to an officer of a responsible authority upon request.

The grounds for the objection are the Prevention of Crime and Disorder and the Prevention of Public Nuisance.

The premises are situated on Wilmslow Road, Fallowfield which is one of the main arterial routes into and out of Manchester City centre.

It is in close proximity to residential properties and is also in an area where there are a large number of bars, public houses, off licenses, late night refreshment outlets and one of the largest student populations in Europe.

Specifically, the application is seeking to allow the provision of alcohol until 0200 hours 7 days a week

The Wilmslow Road corridor suffers from littering, noise disturbance and other anti-social behaviour and to allow a longer window of availability of alcohol in this area is likely to exacerbate these problems and undermine the hard work of the local Neighbourhood Policing Team.

The area where the premises are situated was, until recently, subject to a Cumulative Impact Policy due to the problems in the area, many of which are noise, littering and anti-social behaviour related.

This policy recently lapsed and, whilst it cannot be used as a reason in itself to refuse an application in this area, it shows that there are issues within the area which resulted in the policy being introduced back in 2013.

The latest consultation for the reintroduction of the Special Policy has recently been circulated so this shows that the same kind of issues still exist today.

Fallowfield suffers from issues with late night, noisy, alcohol fuelled house parties, which cause a high level of disturbance to local residents.

GMP are concerned that by allowing this premises to be able to sell alcohol for 2 hours extra each night will mean that there is yet another readily available source of alcohol at a time when these parties are often in full swing.

Greater Manchester Police would therefore ask that the application be refused.

Licensing and out of hours team have assessed the likely impact of the granting of this variation taking into account a number of factors, including the nature of the area in which the premises is located, the hours applied for and any potential risk that the granting of this licence could lead to issues of public nuisance.

The premises is situated on the Fallowfield Brow section of Wilmslow Road an area almost exclusively made up of licensed premises with 2 other off licenses, numerous late-night refreshment take aways and 3 public houses. Directly to the rear of the premises is Fallowfield Brow, a large residential area densely populated with students.

Granting this variation is likely to contribute further to the considerable preexisting public nuisance issues in this area. Complaints of antisocial behaviour from local residents repeatedly cite problems with noise and litter (see images below). The addition of another store selling alcohol ,making it more readily available and easing access, to alcohol until 2am, is likely to draw more people to the area adding to the nuisance local residents experience and undermine the licensing objectives.

The granting of the variation would be inconsistent with the Council's policy. The statement of licensing policy states in section

Section 7.31 states Later hours will generally be more appropriate within the city centre than other areas due to the developed infrastructure in respect of managing a later night-time economy, such as the comprehensive integrated CCTV network, increased access to public transport, cleansing services, and a more visible enforcement presence.


7.25 The potential impact on any local residents will be an important matter for consideration.

7.29 The authority considers that later hours will typically be more sensitive and higher risk in causing problems.

Whilst the premises existing licence conditions go some way to address these issues the application appears to diminish their effectiveness with the removal of key safeguards ensuring that all staff are personal licence holders.

Furthermore, the increased sensitivity and high risk of problems associated with later hours are not fully addressed. There is no detail on how the premises will effectively risk assess the need for door staff and the condition offered is hazy. The issue of litter in the surrounding area are not sufficiently dealt with, nor can they be by way of licence conditions as they exist outside the immediate vicinity of the premise.

Therefore, we recommend this application is refused.

I would like to raise concerns as Neighbourhood Manager with this application to sell alcohol from midnight to 2am This particular part of Fallowfield has a high number of students and we often have complaints of ASB, litter and transient noise.

There are community tensions in and around this area with noise and litter and more recently there was a serious incident on Wilmslow Rd. We also get complaints of begging or aggressive begging in Withington and Fallowfield which again impacts on local residents or students.

With Withington and Fallowfield having a large student population, we want to reduce as many issues as possible in the local community and noise, transient noise, litter, drugs and ASB are all such common factors that local residents often suffer from with students travelling in and around Wilmslow Rd.

I feel selling alcohol until early hours will increase issues and complaints and I do not support it.

On behalf of the licensing authority as a responsible authority, I am objecting to the grant of this proposed variation.

The locality has recently seen an increase in the number of off licence premises with 2 new licences granted. Both applications considered it appropriate to mitigate the impact of off sales of alcohol by limiting the terminal hour - notably, the neighbouring Go Local application reduced its hours from 4am to midnight following the receipt of relevant representations. Concerningly, this application takes a contrary approach, whilst seeking to dilute the regulatory restrictions currently in place on the licence.

The premises is situated in a parade of various commercial uses opposite the Owens Park and Oak House campuses. The area is also home to a high density of HMOs populated by students and temporary homeless accommodation. The locality experiences significant challenges, particularly in respect of noise and antisocial behaviour, such as from house parties and litter including from local takeaways and street drinking. I have concerns that the grant of this application would contribute to these issues and undo the significant local work undertaken by the council, University and police to tackle them.

In summary, my concerns are the grant of the application is likely to undermine the promotion of the licensing objection as it:

- Proposes to weaken the existing controls in place for staff training whilst increasing the level of risk of alcohol-related issues
- Increases the sale of alcohol at a period that customers are increasingly likely to be intoxicated and potentially vulnerable.
- Increases the availability of alcohol and will exacerbate existing issues with anti-social behaviour in the locality.
- Provides no detail around the proposed variation, such as what late night refreshment will be provided and how this will be served.
- Fails to address relevant risks associated with the proposed variation, such as litter and the risk
 of increased conflict
- Fails to address relevant standards as set out in Section 8 of the Council's policy
- Increases the risk and likelihood of cheaper alcohol consumed in unsupervised environments

Further,

- The premises have previously been evidenced as selling higher strength alcohol products including those associated with problematic
- The grant of the variation would be inconsistent with the Council's policy
- The proposed step in relation to the provision of a risk assessment provides no assurance that appropriate door supervision would be provided.
- The proposed steps offer little tangible protections to promote the licensing objectives

I would draw the committee's attention to the following sections of the Council's licensing policy, although references are not limited to just these sections:

Evidence of pre-existing problems in the area

7.12 Where its discretion is engaged, the authority will give particular consideration to the general character of the surrounding area, including crime and antisocial behaviour (ASB) levels, litter problems, issues regarding underage or proxy sales, and noise complaints. Where there are demonstrable problems linked to the operation of licensed premises in the area and the evidence demonstrates problems with licensed premises in the area, the licensing authority will, in exercising its discretion, take this into consideration when deciding what (if any) steps are appropriate and proportionate in the individual case

Proximity of takeaways and off-licences to nightlife entertainment areas

7.17 Such premises typically lack the type of design and management provisions necessary to process the custom of a large intoxicated late-night customer base, and may act as flashpoints for alcohol-related crime and disorder. Additionally, there is a risk of staff being subjected to threatening behaviour, physical violence, and property damage. Operators are encouraged to consider conflict management training and/or employment of door supervisors, where appropriate. However, where the authority's discretion is engaged, consideration may be given to restricting hours of operation to avoid the risk of such premises acting as flashpoints for crime and disorder.

Consistency with relevant Council strategies

- 7.18 The Council recognises that a vibrant evening economy is important, both to the wellbeing of its residents and as a source of economic activity. Accessible district centres and local centres are important in creating a sense of place and focus and, therefore, central to creating neighbourhoods of choice.
- 7.19 Manchester City Centre and its district centres are places to shop, work, eat, drink, enjoy leisure activities, access services and, increasingly, to live.
- 7.20 Centres, in particular the city centre and district centres, have an important role as the focus for the city's evening economy. They are a hub for activity and thrive when they attract visitors from the surrounding neighbourhoods.
- 7.21 An aim for the city is to achieve a better balance of evening and night-time activities and a better distribution throughout the city. In some areas, concentrations of uses associated with the evening economy have led to problems with antisocial behaviour, while other parts of the city suffer from lack of activity during the evening. It is important that the uses within centres are carefully balanced so that evening and night-time uses are complementary to neighbouring uses.

The proximity of the premises to local residents and other local businesses, particularly in relation to the potential for nuisance

- 7.25 Where its discretion is engaged, the licensing authority will ensure that due consideration is given to the proximity of licensed premises not only to local residents and businesses, but also in relation to other licensed premises, to ensure they are located in a position that does not adversely affect their ability to ensure the promotion of the licensing objectives. The potential impact on any local residents will be an important matter for consideration.
- 7.26 Where premises are in the direct vicinity of local residential properties, and where its discretion is engaged, the authority will give particular consideration to measures proposed in the application in relation to prevent nuisance, such as:
- Prevention of noise or vibration escaping from the premises due to volume of music or plant and machinery noise
- Prevention of noise disturbance from people entering and leaving the premises (eg. queue management, dispersal policy)
- Prevention of disturbance by people outside the premises (eg. smoking areas)
- Litter from the premises (This issue is considered particularly relevant in respect of late-night takeaways and smoking-related litter outside licensed premises)
- Disturbance caused by deliveries associated with licensable activities, including waste collection.

7.27 The leisure and night-time economy can be an important contributor to an area's appeal to work, live or visit there. However, each of our neighbourhoods is different to each other and services need to be flexible to meet these different needs. For example, while doorstep access to a thriving late-night-time economy appeals to many living and working in the city centre, it will not be acceptable to those in other areas of the city.

7.28 Where its discretion is engaged, the licensing authority will give consideration to the appropriateness of hours applied for, having regard to the location of premises and their likely effect on the promotion of the four licensing objectives. While it is recognised that in some circumstances flexible licensing hours for the sale of alcohol can help to ensure that concentrations of customers leaving premises simultaneously are avoided, the licensing authority will consider restricting hours to ensure the promotion of the licensing objectives, subject to relevant representations being made in relation to the hours applied for, should the licensing authority deem this appropriate and proportionate following a hearing.

7.29 The authority considers that later hours will typically be more sensitive and higher risk in causing problems.

7.30 Applicants are strongly encouraged only to apply for hours that they realistically intend to operate, as later hours are typically more likely to attract objections.

7.31 It is recognised that in spite of the quality of the operation of the business, where patrons are out of the control of the licensee, the lateness of the terminal hour for the premises will often be a contributory factor in the potential for disturbance.

7.32 Therefore, where its discretion is engaged, the authority will be mindful of the density of residential use in proximity to the premises and the level of risk of nuisance arising. The authority expects that terminal hours will normally be earlier to promote the licensing objectives for licensed premises located in areas with a higher density of residential property

- - -

7.35 Where its discretion is engaged, the licensing authority will not consider the fact that other premises in the vicinity already have similar hours as a justification for granting similar or extended hours, and each application will be considered on its individual merits.

MS1 Implement effective security measures at the premises

Effective monitoring of the premises (both interior and exterior) including the use of CCTV:

• Consideration should be given to the location of alcoholic products in off-licence premises, particularly in relation to the ability of staff to effectively monitor the area in order to guard against the risks of shoplifting and to deter attempts by underage persons to purchase.

Off-licence premises should give particular consideration to alcohol promotions at the premises, including the location within store of any promotional activity.

MS5 Prevent on-street consumption of alcohol

Manchester City Council has previously implemented Designated Public Place Orders (DPPOs) in areas throughout Manchester in order to help address and prevent numerous problems caused by public consumption of alcohol. With effect from 20 October 2014, any new or renewal of such orders are known as Public Space Protection Orders (PSPOs). Street drinking can be a major cause of antisocial behaviour, often involving underage persons, which gives rise to disorder, concerns over public safety and harm to children. Additionally, it is widely reported that consumption of alcohol by persons on the way to on-licensed premises gives rise to problems of drunken and disorderly behaviour. Licensees should ensure all staff are aware of the DPPO/PSPO when situated within the designated area and reinforce the No Street Drinking warning at point of sale. Other conditions may be imposed directed at avoiding problematic street drinking in the vicinity of the premises. Another particular concern will be irresponsible drink promotions that would appeal to underage drinkers or street drinkers, or that

encourage excessive consumption and do not follow best practice, such as the Portman Group Code of Practice on the Naming, Packaging and Promotion of Alcoholic Drinks, that would appeal to underage drinkers or street drinkers, or that encourage excessive consumption.

Condition 7: All alcoholic products shall be labelled with the name of the shop.

Examples of appropriate identification include a passport, photocard driving licence, military ID, and Home Office approved proof of age ID card bearing the PASS hologram.

Annex 3, Condition 2: All staff selling alcohol shall undertake extra training on the following areas;

- a) The law concerning the sale of alcohol.
- b) The four licensing objectives.
- c) Conflict Management.

with:

 On first appointment, all staff employed at the premises will receive training on the Licensing Act 2003 including input on preventing underage sales, preventing sales of alcohol to people who are drunk and any other relevant matters. Training shall be regularly refreshed at no less than annual intervals. The training must be recorded and be accessible on the premises and made available for inspection upon request of a Police Officer or an authorised officer of the licensing authority or (in the case of online training) within 48 hours.

Add:

- Notices will be displayed at the entrance/exit to the premises asking customers to leave the store quietly and respect local residents.
- There will be no sales of beer, lager or cider with an alcohol content above 6.5% ABV in metal or plastic containers. This restriction shall not apply in respect of specialist branded premium priced

Response on behalf of Withington Civic Society Planning Group

Withington Civic Society Planning Group opposes the application.

We believe, according to research previously carried out by Manchester City Council, that Fallowfield already suffers from the greatest levels of crime (both general and alcohol-related) compared to surrounding areas,. The degree of antisocial behaviour recorded in the area is also significantly disproportionate. Antisocial behaviour levels peak during the late night/early morning, and correlate with the closing times of alcohol-led licensed premises.

Complaints about antisocial behaviour from local residents repeatedly cite problems of noise, vandalism and antisocial behaviour from persons going out to and returning from licensed premises, including complaints of preloading and drunkenness. Additionally, there was evidence of litter caused as a result, including discarded alcohol containers and takeaway wrappers in the street. Extra street cleaning services are required in the local area as a result of the disproportionate levels of litter, particularly caused by the high number of late-night takeaways in

Fallowfield. Problems of preloading en route to licensed premises persist despite the existence of a Designated Public Place Order for Fallowfield.

We would note in particular that:

- The incidence of anti social behaviour in the immediate area causes significant loss
 of amenity to families and residents, with much on street drinking and late night /all
 night parties by young people living in HMOs. Such a late night store with an alcohol
 licence will lead to the congregation of large numbers of drinkers with all the
 attendant noise and littering.
- These issues would be exacerbated by off sales of alcohol
- Litter in the area of the relevant premises is already a problem. Later opening hours will exacerbate this.
- The problems of Fallowfield are working their way into Withington, and we in Withington are very anxious that the situation in Fallowfield should not get any worse.

Whatever steps the applicant may take, the overwhelming probability is that the granting of such a licence as requested by the applicant will only exacerbate the problems associated with such premises which already cause substantial loss of amenity to families and permanent residents as identified above.

Therefore the application should be refused.

I am a long-term resident of and I am objecting to the request for an off license, proposal for extended opening hours to sell alcohol until 2am, 7 x days a week at the Fallowfield Convenience Store, 240-242 Wilmslow Road, Manchester, M14 6LD, (Fallowfield ward)

These premises (Fallowfield Convenience Store, 240-242 Wilmslow Road, Manchester, M14 6LD, that is) are situated on Wilmslow Road, which is one of the main arterial routes into and out of Manchester City centre.

It is in close proximity to myself on Landcross Road and local residential properties and is also in an area where there are a plethora of bars, public houses & off licenses and one of the largest student populations in Europe.

This application for alcohol sales Mon to Sun until 2am are quite frankly outrageous. Current hours until midnight 7 x days per week as they stand are ridiculous.

This is just another one of the tsunami of licence applications that the area has had recently (particularly in light of the demise of the Cumulative Impact Policy) and all of which have been granted; The Shell petrol Station (Premises Licence variation 285721/CT4), Kwik e Mart (Now "Go-local" - 280605/HH1)

The area is awash with off licences, maxed out with them in fact: the above two (Shell Petrol Station & Go-Local) and fronting Wilmslow Road – Go-Local, New Zealand Wines off licence (which already has an unbelievable small hour 2am licence; granted before the Cumulative Impact Policy was established) & this place – Fallowfield Convenience Store, until 12am. For goodness sake, we do not need yet another off licence with an extended opening hours window.

I returned to my lovely home on least second late last night (after attending a jazz concert in town) Coming across Wilmslow Road from the bus stop and just into at 11:45pm, I'm greeted by the deafening alcohol fuelled babbling cacophony of the herds of inebriated patrons that are crammed into the outside seating area of the "Studio Bar", resting on the corner of Landcross Road, which at that time (11:45pm) is at fever pitch. And what happens when it closes? They all go quietly back to bed and have some tea and toast? Of course they don't. This drunken zombified mass will be tottering around the "Fallowfield Brow area" (an area encompassing a canopy of 7 x streets. 5 x streets moving South to North & 2 x streets East to West, of which the Fallowfield Convenience Store resting at 240-242 Wilmslow Road, is in the centre) to feast on junk food and utilise one of these off licences (Go-Local, New Zealand Wines, & this one - Fallowfield Convenience Store) with a view to purchasing more alcohol, and, highly likely that the area outside the premises will become yet another zone where noisy, inebriated humans (and I use that term loosely) gather to collect further alcohol supplies, with people spilling out onto the busy thoroughfare of Wilmslow Road, putting themselves and others at risk and from the opportunists (drug dealers looking for another sale, thieves and Of course, robbers for an easy mark) Also, as the area is subject to a Designated Public Place Order it is likely that this order will be breached far more regularly, creating more work for the local police officers.

As I've stated before in many objections; This "Fallowfield Brow" area, is now nothing more than a party/club fested, drunken drugged up conurbation, that's really fit for no human life or existence, becoming one giant noise fest; people to and fro, taxis to and fro, shouting, screeching, hollering, yelling, "music" pumping out ad finitum, from early evening until 6am in the morning.

This will create added noise disturbance which will obviously be extended beyond what is already being suffered by the local residents.

The Wilmslow Road corridor already suffers from begging, street drinking and other alcohol related anti-social behaviour and to allow yet another premises a license to sell alcohol, will undoubtedly exacerbate these problems.

The request for extended license liquor sales by Fallowfield Convenience Store, particularly in view of the fact that the premises has had an alcohol licence revoked due to all sorts of illegal activity and breaches, with the current licence eventually being granted with a strict midnight closing, and in the light of what's been happening in the near vicinity in Fallowfield (a murder, serious assaults etc), quite frankly, beggars' belief.

A cynical application proposal from a rogue outfit then, and on the back of the demise of the Cumulative Impact policy, out to exploit the get down 24/7 party/club zombie liquor saturated wallets and purses that totter around the M14 streets; and makes the "Steps to promote licence Objectives" with its "Notices shall be displayed at the entrance/exit to the premises asking customers to leave the store quietly and respect local residents" in the proposal, if it wasn't so serious, laughable. A transient (of which 90% of the Brow residents are) fuelled with 6 x pints of strong lager and a plethora of B52's quite frankly isn't capable of reading anything and understanding it, let alone abiding by it.

In addition, In the four years that I've purchased my car, and parked up outside my house, it has been "hit/vandalised" 8 x times. Here's one incident and most pertinent to this application; a cctv still of a pair of



drunken students smashing into the nearside door, causing two huge dents in it 19 @ 05:39am)

With all the garbage that pervades the area, we have a rat infestation (in all the years that I've lived here, we've never had that before) I've already spent £42 for a 5-x visit Pest Control event, which was back in October 2022 and now? .. absolutely no surprise at all .. they're back (see picture below from Boxing Day in my back yard – 26-12-22) and I'm now booking yet another £42 visit from Pest Control. Empty cans/empty bottled garbage from Mr "Fallowfield Convenience Store" will only add to the overload.



Personally? I am at the very end of my tether in this Fallowfield Brow area; suffering from extreme sleep deprivation, being awoken in the small hours from the transient noise (much of it, created by patrons of drinking emporiums and off licences that provide the liquor of which "Fallowfield Convenience Store's" extended hours, would be yet another addition to the problems in the area) pervading the streets here and wading through the mountains of garbage, filth, graffiti, herds of drug dealers and rats.

We are writing on behalf of Fallowfield & Withington Community Guardians and SE Fallowfied Residents Group We wish to strongly object to the variation of licence and later opening hours at 240-242 Wilmslow Road, M14 6XQ.

The main reason for our objection is that the current number of licensed premises in Fallowfield District Centre (54 licensed premises) already cause residents many problems; in particular in terms of noise, nuisance, littering, criminal damage and anti social behaviour. These alcohol related antisocial problems have been going on for years and are so pronounced that a cumulative impact policy zone has been assigned to Fallowfield District Centre to try and prevent further problems. Whilst this CIP is currently lapsed and a new policy is out for consultation, these problems are real, harmful and continuing. Adding later hours for the sale of alcohol will undoubtedly add to the existing problems.

This premises falls within the M14 6 subpostcode which has a massive student population unlike most other suburbs of Manchester. In 2018/19 there were 11,195 students and this is likely to be higher now due to the expansion of Owen's Park by more than 1000 bedspaces and the intensification of HMOs due to permitted development. The proximity of these premises to so many young people make off licences a real 'go to place' for last minute purchases of alcohol for pre drinks social parties, drinking at bus stops as money saving ways of getting in a few drinks before paying bar prices and of course the infamous Fallowfield house parties which cause much distress to many residents.

We consider that later availability of alcohol will definitely add to the existing problems. Other nearby off licences have caused problems over many years, including New Zealand Wines (granted a 2am licence before the Cumulative Impact Policy), Gaffs (licence revoked). Fallowfield Convenience Store had their licence revoked and the recently named premises (Midway Wines) was granted a licence to midnight before CIP and an application to extend hours was refused in 2019. Even though the CIP is under review, we would request that you use the same strict conditions to protect residents on the interim. MCC Statement of Licensing Policy 2021-2026 recommends refusal "The effect of the Special Policy is that the Council will refuse applications for a new Premises Licence or Club Premises Certificate, or variation of an existing licence or certificate, whenever it receives relevant representation, unless an applicant can demonstrate why the operation of the premises involved will not add to the cumulative impact already being experienced"

We believe that the licensing objectives will be undermined if extended hours are added to the existing licensed premises. Considerable problems exist for residents and relate to public nuisance, crime and disorder and public safety. Everyday occurrences include broken glass on surrounding pavements, vomit, litter and noise from patrons drinking in outside areas. Noise of patrons going to and from premises also creates a lot of sleep disturbance for residents.

Fallowfield has also recently been in the national news following the murder of a student in the early hours of the morning at the end of October 2022. In our experience of living in this area, we know that the consumption of alcohol and drugs exacerbates the problems which create so much anti social behaviour.

Our group have been meeting monthly since 2006 and at all of our meetings residents recount incidents of noise and anti social behaviour which often relates to the consumption of alcohol in bars and clubs as well as on-street drinking and house partying. This has a terrible effect of many of us and affects our sleep, health and well being. Alcohol is a root cause of many of these problems. World Heath Orgaisation research highlights that: "Restriction of availability has been assessed as a highly cost-effective best-buy intervention... Countries are recommended to regulate... to reduce the hours of sale (a highly cost-effective measure) and density of outlets." https://www.who.int/initiatives/SAFER/alcohol-availability

Residents in our group are suffering immense stress and strain from living close to Fallowfield District Centre.

We completely oppose the request for additional hours for the sale of alcohol at Fallowfield Convenience Store and feel that it will undermine the licensing objectives and cause further harm to this fragile neighbourhood. Please reject this application for the wellbeing of residents.

1. **Introduction**

- 1.1 On 03/05/2023, an application for the grant of a Premises Licence under s17 of the Licensing Act 2003 was made in respect of Sam Off Licence, 20a Swan Street, Manchester, M4 5JW in the Piccadilly ward of Manchester. A location map and photograph of the premises is attached at **Appendix 1**.
- 1.2 This application follows a previous review of the licence on 12 April 2023. A copy of the decision from the previous hearing is attached at **Appendix 5.**
- 1.3 A 28-day public consultation exercise was undertaken in accordance with Licensing Act 2003 regulations; requiring the application to be advertised by the displaying of a blue notice at or on the premises, a notice published in a newspaper or similar circulating in the local area, and details of the application published on the Council's website.
- 1.4 Representations may be made for or against an application during the consultation period. To be 'relevant' and, therefore, able to be taken into account in determining the application, they must be about the likely effect of the grant of the premises licence on the promotion of the licensing objectives. Where representations are made by persons who are not a responsible authority, they must not be frivolous or vexatious.
- 1.5 Relevant representations have been received in respect of this application and so it must be determined by a Licensing Hearing Panel in accordance with the Council's Constitution.

2. The Application

- 2.1 A copy of the application is attached at **Appendix 2.**
- 2.2 The applicant is Bereket Amanuel.
- 2.3 The description of the premises given by the applicant is Off Licence
- 2.4 The proposed designated premises supervisor is Bereket Amanuel
- 2.5 The licensable activities applied for:

The supply of alcohol for consumption off the premises only: Monday to Sunday 9am to 1am

Opening hours: Monday to Sunday 9am to 1am

- 2.5.1 In accordance with the Live Music Act 2012 and Deregulation Act 2015, performances of Live Music and Recorded Music between the hours of 0800 and 2300 hours have been deregulated and so should not be regarded as licensable activities for the purposes of this application.
- 2.5.2 Any further details provided relating to any of the individual licensable activities are specified on the application form at **Appendix 2**.

2.6 Activities unsuitable for children

2.6.1 The applicant has not highlighted any adult entertainment or services, activities, other entertainment or matters ancillary to the use of the premises that may give rise to concern in respect of children.

2.7 Steps to promote the licensing objectives

- 2.7.1 The applicant proposes to promote the licensing objectives by taking the steps identified in the operating schedule.
- 2.7.2 These steps must be translated into conditions by the licensing authority to be included in any granted premises licence, unless the conditions are modified by the Panel following consideration of relevant representations. These conditions are set out in the Schedule of Conditions at **Appendix 4**.

3. Relevant Representations

3.1 A total of 2 relevant representations were received in respect of the application (**Appendix 3**). The personal details of all members of the public have been redacted. Original copies of these representations will be available to the Panel at the hearing.

- 3.3 Any conditions proposed by objectors are set out in the Schedule of Conditions at **Appendix 4**.
- 3.4 No agreements on conditions have been reached with the Responsible Authorities who have made representations.

4. Key Policies and Considerations

4.1 Legal Considerations

4.1.1 Hearings under the Licensing Act 2003 operate under the Licensing Act 2003 (Hearings) Regulations 2005.

4.2 **New Information**

4.2.1 In accordance with Regulation 18 of the Licensing Act 2003 (Hearings)
Regulations 2005, the authority may take into account documentary or other information produced by a party in support of their application, representations or notice either before the hearing or, with the consent of all parties, at the hearing.

4.3 **Hearsay Evidence**

4.3.1 The Panel may accept hearsay evidence and it will be a matter for the Panel to attach what weight to it that they consider appropriate. Hearsay evidence is evidence of something that a witness neither saw nor heard, but has heard or read about.

4.4 The Secretary of State's Guidance to the Licensing Act 2003

- 4.4.1 The Secretary of State's Guidance to the Licensing Act 2003 is provided for all parties involved in licensing. It is a key medium for promoting best practice, ensuring consistent application of licensing powers across England and Wales and for promoting fairness, equal treatment and proportionality.
- 4.4.2 Section 4 of the 2003 Act provides that, in carrying out its functions, a licensing authority must 'have regard to' guidance issued by the Secretary of State under section 182. The Guidance is therefore binding on all licensing authorities to that extent. However, the Guidance cannot anticipate every possible scenario or set of circumstances that may arise and, as long as licensing authorities have properly understood this Guidance, they may depart from it if they have good reason to do so and can provide full reasons.
- 4.4.3 Departure from the Guidance could give rise to an appeal or judicial review, and the reasons given will then be a key consideration for the courts when considering the lawfulness and merits of any decision taken.

4.5 Manchester Statement of Licensing Policy

- 4.5.1 Section 4 of the 2003 Act provides that, in carrying out its functions, a licensing authority must 'have regard to' its statement of licensing policy.
- 4.5.2 The Licensing Policy sets out the vision the licensing authority has for the regulation of licensed premises throughout Manchester and outlines the standards expected in order to ensure the promotion of the licensing objectives in the city. The Panel may depart from the policies should it consider doing so would benefit the promotion of the licensing objectives. Reasons are to be given for any such departure from the Policy.
- 4.5.3 Section 4 of the Policy (Operation of the Policy) sets out how the Licensing Policy is intended to be used in practice for licence applications and licensed premises.
- 4.5.4 Relevant to this application and the grounds of the representations made, the Panel are recommended to have regard to the following sections of the Policy:

Section 6: What we aim to encourage

This section identifies certain types of venues and initiatives the licensing authority aims to encourage in order to promote an inclusive evening and night-time economy not simply focused on the consumption of alcohol. We aim to encourage:

- Premises that will extend the diversity of entertainment and attract a wider range of participants
- Live music, especially original material, which will provide a range of live performances and styles of music, provided that such entertainment does not undermine the licensing objectives
- National cultural institutions, global sports events and cultural festivals
- Non-drink-led premises, including restaurants, cafes, theatres and cinemas
- Communication and integration with local residents and businesses through licensees consulting with those in the local area prior to an application
- Participation in Pubwatches, off licence forums and other crimereduction partnerships
- Engagement with the NITENET radio scheme and DISC secure information sharing platform by city centre venues through the Cityco Manchester Business Crime Reduction Partnership
- Designing out crime in the layout of the premises

Section 7: Local factors

This section sets out key issues that applicants are expected to take into account relevant to the individual characteristics of the premises when preparing their operating schedule and address any local factors relevant to their premises.

Having regard to the grounds of the representations made, the Panel are recommended to have regard to the following Factors:

- Identified risk factors specific to the licensed premises
- Evidence of pre-existing problems in the area
- Proximity of takeaways and off-licences to nightlife entertainment areas
- Consistency with relevant Council strategies
- The proximity of the premises to local residents and other local businesses, particularly in relation to the potential for nuisance
- Ability to clean and maintain the street scene

Section 8: Manchester's standards to promote the licensing objectives

This section identifies the standards that the licensing authority expects of licensed premises in Manchester. It is recognised that not all standards will be appropriate to apply in every situation to every premises, and applicants are not obliged to include all standards in their operating schedule. The degree to which standards would be appropriate is expected to be proportionate to the risk posed against the promotion of the licensing objectives having regard to the individual circumstances of the premises. The standards are not exhaustive and the licensing authority will have regard to any relevant issues raised in any representation that may fall outside them.

- MS1 Implement effective security measures at the premises
- MS2 Effective general management of the premises
- MS5 Prevent on-street consumption of alcohol
- MS8 Prevent noise nuisance from the premises
- MS12 Prevent underage sales of alcohol, including proxy sales

Conclusion

- 4.6 A licensing authority must carry out its functions under this Act ("licensing functions") with a view to promoting the licensing objectives:
 - the prevention of crime and disorder
 - public safety;
 - the prevention of public nuisance; and
 - the protection of children from harm.
- 4.7 In considering the matter, the Panel should take into account any representations or objections that have been received from responsible authorities or other persons, and representations made by the applicant or premises user as the case may be. In reaching the decision, regard must also be had to relevant provisions of the national guidance and the Council's licensing policy statement.
- 4.8 Having regard to the representations, the Panel must take such of the steps set out below that it considers appropriate for the promotion of the licensing objectives:
 - a) To grant the licence subject to:
 - i. the conditions consistent with the operating schedule accompanying the application, which the Panel may modify to such extent as they consider appropriate, and
 - ii. any mandatory conditions that must be included in the licence;

- b) To exclude from the scope of the licence any of the licensable activities to which the application relates;
- c) To refuse to specify the person proposed in the application as the designated premises supervisor;
- d) To reject the application.
- 4.9 The conditions consistent with the operating schedule may be modified to alter or omit any of them or to add any new condition, including restricting the times at which licensable activities authorised by the licence can take place.
- 4.10 All licensing determinations should be considered on the individual merits of the application.
- 4.11 The Panel's determination should be evidence-based, justified as being appropriate for the promotion of the licensing objectives and proportionate to what it is intended to achieve. Findings on any issues of fact should be on the balance of probability.
- 4.12 It is important that a licensing authority should give comprehensive reasons for its decisions in anticipation of any appeals. Failure to give adequate reasons could itself give rise to grounds for an appeal.
- 4.13 The Panel is asked to determine the application.

Licensing and out of hours (LOH) have assessed the likely impact of the grant of this application taking into account a number of factors, including, the nature of the area in which the premises is located, the hours applied for and any potential risk that the granting of this application could have, taking into account the licensing objectives Prevention of Crime and Disorder, Public Safety, Prevention of Public Nuisance and Protection of Children From Harm.

The premises at 20a Swan street is currently a small barber shop trading as HQ Barbers, whose current trading hours are 0900 Hrs until 2000 Hrs Monday to Friday and 1000Hrs to 1700 Hrs on Sundays. The area around the premises is a variety of commercial and residential uses which are located in the Northern Quarter of the City Centre. including licensed premises the majority of which have terminal hours of 0100 Hrs. The area also has a number of short term lets which have proven problematic leading to complaints relating to noise and Antisocial Behaviour (ASB). The immediate vicinity of the premises also forms part of the city centre Public Space Protection Order (PSPO).

The premises has been subject to a premises licence application by the same applicant that was refused at a hearing on 12th April 2023.

LOH have concerns relating to the applicant who is also proposed to be the DPS of the premises specifically their knowledge of the licensing act 2003. At a meeting with the applicant on the 13th March 2023 the applicant displayed poor knowledge of the 4 licensing objectives and was unable to explain what was meant by 'proxy sales', the applicant was also unable to explain how he would prevent drunk persons from entering the premises. It is of particular concern to LOH that the operating schedule contains the following 'All staff other than personal licence holders must receive training regarding the four licensing principles contained in the Licensing Act 2003, Responsible retailing of alcohol, and the law, the conditions attached to the premises licence.

In this current application the applicant has offered many conditions that are vague and

effectively water down the importance of licence conditions. For example: 'Staff are trained as appropriate in respect of relevant licensing law' - this is ambiguous in nature and not clear, precise, or enforceable, as per S1.16 of the S182 guidance.

LOH have further concerns that there is no consideration or understanding of the area the premises will be trading in. There is no mention in the operating schedule of training in relation to conflict management which its proximity to other licensed premises, hours of operation, the area the premises is located in and alcohol sales post 2200Hrs LOH feel would be proportionate. It is also a concern to LOH that there is no SIA security provision in the operating schedule which primarily relates to the upholding the licensing objective 'prevention and detection of crime and disorder' also aids in the upholding of the licensing objective 'prevention of public nuisance' especially given the proximity of the premises to the City Centre PSPO

S7.17 of Manchester City Council's Statement of Licensing Policy states Proximity of takeaways and off-licences to nightlife entertainment areas Such premises typically lack the type of design and management provisions necessary to process the custom of a large intoxicated late-night customer base, and may act as flashpoints for alcohol-related crime and disorder. Additionally, there is a risk of staff being subjected to threatening behaviour, physical violence, and property damage. Operators are encouraged to consider conflict management training and/or employment of door supervisors, where appropriate. However, where the authority's discretion is engaged, consideration may be given to restricting hours of operation.

- S7.2 of Manchester City Council's Statement of Licensing Policy states 'In accordance with the section 182 Guidance, when setting out the steps they propose to take to promote the licensing objectives, applicants are expected to obtain sufficient information to enable them to demonstrate that they understand:
- The layout of the local area and physical environment, including crime and disorder hotspots, proximity to residential premises, and proximity to areas where children may congregate
- Any risk posed to the local area by the applicant's proposed licensable activities.

MS5 of the statement of licensing policy states: Manchester City Council has previously implemented Designated Public Place Orders(DPPOs) in areas throughout Manchester in order to help address and prevent numerous problems caused by public consumption of alcohol. With effect from 20 October 2014, any new or renewal of such orders are known as Public Space Protection Orders (PSPOs). Street drinking can be a major cause of antisocial behaviour, often involving underage persons, which gives rise to disorder, concerns over public safety and harm to children. Additionally, it is widely reported that consumption of alcohol by persons on the way to on-licensed premises gives rise to problems of drunken and disorderly behaviour. Licensees should ensure all staff are aware of the DPPO/PSPO when situated within the designated area and reinforce the No Street Drinking warning at point of sale. Other conditions may be imposed directed at avoiding problematic street drinking in the vicinity of the premises. Another particular concern will be irresponsible drink promotions that would appeal to underage drinkers or street drinkers, or that encourage excessive consumption and do not follow best practice, such as the Portman Group Code of Practice on the Naming, Packaging and Promotion of Alcoholic Drinks, that would appeal to underage drinkers or street drinkers, or that encourage excessive consumption.

Notice of decision: Premises Licence (new)

Following the Licensing Sub-committee hearing on 12/04/2023, I write to formally advise you of the sub-committee's decision regarding:

Sam Off Licence 20a Swan Street Manchester M4 5JW

Decision: To refuse the application .

Reasons: The Committee considered carefully the content of the Report and the supplementary agenda as well as the oral representations of GMP. The Applicant did not attend the hearing and therefore made no oral representations to the Committee the Committee did however consider the content of the email sent by the applicants representative on his behalf. The Committee heard from GMP that on a visit on 13 March 2023 the Applicant was unaware of his responsibilities as an operator to prevent crime and disorder, the planned layout for the premises had not taken into account the prevention of crime and disorder licensing objective , no consideration had been given to use of Security staff during the later hours , he could not answer when asked how he would prevent drunk persons from entering the premises and he did not understand the concept of proxy sales. This gave GMP no confidence that the Applicant was able to operate the premises in a manner which would not undermine the licensing objectives. The Committee was very concerned that an Applicant was unaware of his basic responsibilities and did not understand the concept of proxy sales which all operators should be familiar with.

The Committee also noted that the content of the application did not take into account the nature of these premises. For example the Committee questioned the relevance of the condition keeping doors and windows closed . The Committee therefore considered it likely that the conditions have simply been copied from other licences without any real consideration and thought given to their implementation at the premises.

Therefore, in all the circumstances the Committee considered it appropriate to refuse the licence.

The holder of the premises licence may appeal any decision to:

- Refuse the application
- Impose conditions on the licence
- Exclude a licensable activity
- Refuse to nominate someone as a Designated Premises Supervisor
- Modify conditions attached to a licence (where the application is a variation)

Any person having made relevant representation against the application may appeal the decision if they believe that:

- The licence should not have been granted
- · A licensable activity should have been excluded
- Different or additional conditions should have been attached by the Licensing Authority
- A Designated Premises Supervisor should not have been nominated
- The conditions attached to the licence should not have been modified or should have been modified in a different way (where the application is a variation)

Any appeal must be made to Manchester City Magistrates' Court, Crown Square, Manchester, M60 1PR (tel 0161 830 4200) and must be commenced within the period of 21 days beginning with the day on which you were notified by the licensing authority of the decision, as provided for in Section 181 of the Licensing Act 2003.

Please note, the licensing decision is separate from any planning decision; *the licensing decision does not confer planning consent*. Please ensure you have the proper planning consent before commencing trading.

1. <u>Introduction</u>

- 1.1 On 2 May 2023, a temporary event notice (TEN) was given under s100A of the Licensing Act 2003 in respect of Empire House Manchester, 2 Empire Street, Manchester, M3 1JA in the Cheetham ward of Manchester. A location map of the premises is attached at **Appendix 1**.
- 1.2 In accordance with Licensing Act 2003 regulations, Greater Manchester Police (GMP) and Licensing Out of Hours Compliance (LOOH) were notified of the TEN.
- 1.3 Where either GMP or LOOH is satisfied that allowing the premises to be used in accordance with the TEN would undermine a licensing objective, they must give an objection notice to the relevant licensing authority, the premises user, and to every other relevant person.
- 1.4 The objection notice must be given no later than three working days after the day on which the objector is given the TEN.
- 1.5 An objection notice has been received in respect of this TEN and so it must be determined by a Licensing Hearing Panel in accordance with the Council's Constitution.

2. The Notice

- 2.1 A copy of the TEN is attached at **Appendix 2.**
- 2.2 The premises user is Adijatu Tejan-kadri.
- 2.3 The description of the event is Sierra Leonean music Jamboree.
- 2.3.1 In accordance with the Live Music Act 2012 and Deregulation Act 2015, performances of Live Music and Recorded Music between the hours of 0800 and 2300 hours have been deregulated and so should not be regarded as licensable activities for the purposes of this TEN.
- 2.3.2 Any further details provided relating to any of the individual licensable activities are specified on the TEN at **Appendix 2**.

2.4 Activities unsuitable for children

2.4.1 The premises user has not highlighted any adult entertainment or services, activities, other entertainment or matters ancillary to the use of the premises that may give rise to concern in respect of children.

3. Objection Notice(s)

Objection notices were received from GMP and from LOOH in respect of the TEN (**Appendix 3**). The personal details of all members of the public have been redacted. Original copies of these objections will be available to the Panel at the hearing.

3.2 Summary of the objections:

4. Key Policies and Considerations

4.1 Legal Considerations

4.1.1 Hearings under the Licensing Act 2003 operate under the Licensing Act 2003 (Hearings) Regulations 2005.

4.2 **New Information**

4.2.1 In accordance with Regulation 18 of the Licensing Act 2003 (Hearings)
Regulations 2005, the authority may take into account documentary or other information produced by a party in support of their application, representations or notice either before the hearing or, with the consent of all parties, at the hearing.

4.3 **Hearsay Evidence**

4.3.1 The Panel may accept hearsay evidence and it will be a matter for the Panel to attach what weight to it that they consider appropriate. Hearsay evidence is

evidence of something that a witness neither saw nor heard, but has heard or read about.

4.4 The Secretary of State's Guidance to the Licensing Act 2003

- 4.4.1 The Secretary of State's Guidance to the Licensing Act 2003 is provided for all parties involved in licensing. It is a key medium for promoting best practice, ensuring consistent application of licensing powers across England and Wales and for promoting fairness, equal treatment and proportionality.
- 4.4.2 Section 4 of the 2003 Act provides that, in carrying out its functions, a licensing authority must 'have regard to' guidance issued by the Secretary of State under section 182. The Guidance is therefore binding on all licensing authorities to that extent. However, the Guidance cannot anticipate every possible scenario or set of circumstances that may arise and, as long as licensing authorities have properly understood this Guidance, they may depart from it if they have good reason to do so and can provide full reasons.
- 4.4.3 Departure from the Guidance could give rise to an appeal or judicial review, and the reasons given will then be a key consideration for the courts when considering the lawfulness and merits of any decision taken.

4.5 Manchester Statement of Licensing Policy

- 4.5.1 Section 4 of the 2003 Act provides that, in carrying out its functions, a licensing authority must 'have regard to' its statement of licensing policy.
- 4.5.2 The Licensing Policy sets out the vision the licensing authority has for the regulation of licensed premises throughout Manchester and outlines the standards expected in order to ensure the promotion of the licensing objectives in the city. The Panel may depart from the policies should it consider doing so would benefit the promotion of the licensing objectives. Reasons are to be given for any such departure from the Policy.
- 4.5.3 Section 4 of the Policy (Operation of the Policy) sets out how the Licensing Policy is intended to be used in practice for licence applications and licensed premises.
- 4.5.4 Where the authority considers that to impose on the TEN one or more of the conditions from a premises licence or club premises certificate in force at the premises (insofar as such conditions are not inconsistent with the event) is appropriate for the promotion of the licencing objectives, the policy is to give notice to the premises user that includes a statement of the conditions imposed. Copies of this notice will be provided for GMP and LOOH.
- 4.5.5 Where, following any representations at the hearing, the licensing authority is not satisfied the event will ensure the promotion of the licensing objectives, the policy is to issue a counter-notice against the Temporary Event Notice.

5. <u>Conclusion</u>

- 5.1 A licensing authority must carry out its functions under this Act ("licensing functions") with a view to promoting the licensing objectives:
 - the prevention of crime and disorder
 - public safety;
 - the prevention of public nuisance; and
 - the protection of children from harm.
- In considering the matter, the Panel should take into account any objections that have been received from GMP or LOOH, and representations made by the applicant or premises user as the case may be. In reaching the decision, regard must also be had to relevant provisions of the national guidance and the Council's licensing policy statement.
- 5.3 Having regard to the objection notice(s), the panel must give the premises user a counter notice if it considers it appropriate for the promotion of a licensing objective to do so.
- 5.4 If the panel decides not to give a counter notice the panel may impose one or more conditions on the TEN if
 - the authority considers it appropriate for the promotion of the licensing objectives to do so,
 - the conditions are also imposed on a premises licence or club premises certificate that has effect in respect of the same premises, or any part of the same premises, as the temporary event notice, and
 - the conditions would not be inconsistent with the carrying out of the licensable activities under the temporary event notice.
- 5.5 All licensing determinations should be considered on the individual merits of the notification.
- The Panel's determination should be evidence-based, justified as being appropriate for the promotion of the licensing objectives and proportionate to what it is intended to achieve. Findings on any issues of fact should be on the balance of probability.
- 5.7 It is important that a licensing authority should give comprehensive reasons for its decisions in anticipation of any appeals. Failure to give adequate reasons could itself give rise to grounds for an appeal.
- 6. The Panel is asked to determine the temporary event notice.
