CN/19/11 Terms of Office of the Independent Members of the Standards Committee and the Independent Persons

The Council has a Standards Committee the role of which includes promoting and maintaining high standards of conduct by Councillors, Co-opted Members and church and parent governor representatives. In 2015 the Council appointed 2 Independent Members to its Standards Committee and 2 'Independent Persons' each for 4 year terms. A report by the City Solicitor invited the Committee to consider the extension of the terms of office of the Council's Independent Members of the Standards Committee and the Independent Persons for a further two years, all of whom would otherwise leave office in November 2019. The extension to the terms of office was supported by the Standards Committee.

The Committee considered the report of the City Solicitor setting out proposed changes to the Council's Constitution.

To note in relation to Part 3 that responsibility for the discharge of executive functions and the delegation of such responsibility rests with the Leader of the Council and that the recommended delegations of executive functions as set out in the attached Part 3, Section F (Scheme of Delegation to Officers) are for the information of the Council only;
- 4. To note that the Leader has approved the delegations of executive functions contained in Part 3, Section F and has agreed that the City Solicitor may make

- any consequential amendments to Part 3, Section A (Local Choice Functions) of the Constitution, insofar as they relate to executive functions; and
- 5. To note that this report represents an interim review of the Constitution and a report on a full review will be brought to the Council's October meeting.

CN/19/13 Greater Manchester Transport Committee - Roles and Responsibilities

This report outlined the current GM transport governance arrangements. In the context of the Devolution Agreement and specifically the GMCA Transport Order 3, it also presented some broad revised terms of reference for a reconstituted GM Transport Committee, options for its structure, responsibilities and examples of how it might work in practice.

There has been significant change to GM governance since 2011, when the existing Transport for Greater Manchester Committee was established. In that time period, the mayoral combined authority has been established, major reforms of scrutiny arrangements and the former waste, fire and police authorities undertaken, and more recently the confirmation of GM Order 3 (which was agreed by all of the Districts) has specific implications for transport governance.

The proposed Terms of Reference for the Committee were included in the Operating Agreement (Schedule 1). They set out the key areas of work for the Committee and the delegations from the Mayor, GMCA and the districts. The Terms of Reference more accurately reflect the proposed role of the Committee and do not make any changes to the delegations from the Districts.

The first Operating Agreement was entered into between GMCA and the districts in 2011. It set out how the Committee would be appointed to, the Terms of Reference of the Committee, and other provisions relating to Transport Protocols, funding and scrutiny arrangement.

The proposed amendments update the membership and appointment process; include the Mayor as a signatory as he now has specific transport powers; deletes the references to a joint scrutiny committee as the CA now has Scrutiny functions; retains the same funding provisions and the Rules of Procedure.

- 1. Approve the establishment of the new GM Transport Committee as a joint committee of the 10 districts, GMCA and Mayor.
- 2. Approve the Terms of Reference and Operating Agreement for the Committee as set out in Schedule 1 of the report.
- 3. Delegate the functions as set out in the Terms of Reference to the Transport Committee.

- 4. As set out above in minute CN/19/08 appoint two members to the Transport Committee for 2019 2020, one being the Executive Member for Environment, Planning & Transport, and one other Councillor.
- 5. As set out above in minute CN/19/08 appoint as a substitute for the Executive Member the Assistant Executive Member for Environment, Planning & Transport, and to appoint another Councillor as the second substitute.

CN/19/14 Redesignation of polling places for the European Parliamentary Elections on 23 May 2019.

Not all of the locations used as polling places in the Local Election on 2 May are also available at short-notice for use for the European Parliamentary Elections on 23 May. Where a polling place was not available to Chief Executive used delegated powers to re-designate an alternative.

Ward / District - Cheetham, Deansgate 1CTB/1DGA

As a result of the short notice given for the European Parliamentary Elections the Electoral Services Unit was unable to secure a booking for the polling station currently designated for the 1CTB / 1DGA polling district located at The Park Inn, Cheetham Hill Road. It has not been possible to secure a polling place within either of the polling districts. However, an alternative polling place for the EPE only has been identified at Manchester Cathedral Visitors Centre. Although it is located in the adjoining polling district 2DGC, it is in a well-known location and is accessible to all electors. Having consulted the relevant Councillors, the Chief Executive made the decision to re-designate on a temporary basis this polling place for the EPE only.

Ward / District - Chorlton Park - 4CPA

As a result of the short notice given for the European Parliamentary Elections the Electoral Services Unit was unable to secure a booking for the polling place currently designated for the 4CPA polling district which is at Loreto High School. Exams are taking place in the school at this time. Unfortunately, the Maris Centre on the same site is also not available for use. An alternative location, for the EPE only, has been identified as the Function Room located within Sai Spice Indian Restaurant on Mauldeth Road West. This is on the ground floor, is accessible to electors and has some parking available outside. Having consulted the relevant Councillors, the Chief Executive made the decision to re-designate on a temporary basis this polling place for the EPE only.

Ward / District - Didsbury West - 4DWE

As a result of the short notice given for the European Parliamentary Elections the Electoral Services Unit was unable to secure a booking for the polling place currently designated for the 4DWD polling district located at St James and Emmanuel Church Parish Centre. An alternative location, for the EPE only, has been identified as Ivy Church Manchester, which is also the polling place for 4DWE. The building is well known to local residents and has enough space to accommodate both stations.

Having consulted the relevant Councillors, the Chief Executive made the decision to re-designate on a temporary basis this polling place for the EPE only.

Ward / District - Fallowfield - 3FAD

As a result of short notice given for the European Parliamentary Elections the Electoral Services Unit was unable to secure a booking for the polling place currently designated for the 3FAD polling district located at the Armitage Centre. An alternative location, for the EPE only, was identified at Owens Park. This polling place is already used by electors in polling district 3FAE. There is enough room for all electors from both polling districts to use this polling place and the building is well known to all electors in the area. Having consulted the relevant Councillors, the Chief Executive made the decision to re-designate on a temporary basis this polling place for the EPE only.

To note and endorse the urgent decisions made by the Chief Executive to change the scheme of polling places to be in use for the European Parliamentary Elections later this month.

The costs of conducting the Review will be in the region of £5,000 to include the cost of publishing statutory notices, polling place visits and consultation activity. This will be funded from within the existing Electoral Services budget.

1. Background and context

- 1.1 As required by the Electoral Administration and Registration Act 2013, compulsory reviews of parliamentary polling districts and polling places must take place every 5 years, reflecting the Fixed Term Parliament Act 2011.
- 1.2 The Council undertook its last compulsory review, which was combined with a review of local election arrangements, in the autumn of 2013 coming into effect in February 2014. The Council is therefore required to undertake the next compulsory review within the 16 month period beginning on 1 October 2018 and concluding by 31 January 2020.
- 1.3 In the autumn of 2017, an interim of review of the city's parliamentary polling districts and polling places took place, which was conducted simultaneously with a review of the equivalent local government polling arrangements. This review was necessary in order to take into account the city's 32 new ward boundaries, following the conclusion of the Local Government Boundary Commission for England's (LGBCE) Electoral Review of Manchester. This new scheme came into effect when the register was re-published on 1 February 2018, ahead May's elections.
- 1.4 Given the comprehensive nature of the interim review undertaken in 2017/8, it was agreed at the Constitutional and Nomination Committee's meeting of 28 November 2018, that the optimum time to conduct the compulsory review was the summer/autumn of 2019. This was to enable learning from the both the local elections in 2018 and 2019 to be taken into account. In practice, learning from the European Parliamentary Election held in May 2019 can also now be considered.

2. Responsibilities and the scope of the review

- 2.1 In order to deliver elections, wards are sub divided into the polling districts and suitable polling places identified within them, in which electors can cast their vote. The designation of the city's polling districts and places is the responsibility of the Council and the relevant functions are delegated to the Constitutional and Nomination Committee under the Council's Constitution. This includes the Council's duties under the Representation of the People Act 1983 to divide constituencies into polling districts and the power to divide wards into polling districts at local elections. The Electoral Commission advises that polling districts for UK parliamentary and local government elections should always be the same. It therefore follows that any review of parliamentary polling arrangements should be conducted simultaneously with one of local government arrangements, and with those for any other type of election for which provision is made for the designation of polling districts and polling places, for example, the Combined Authority Mayoral election.
- 2.2 On occasion, it may be necessary to change the designation of a polling place outside the statutory review process or meeting of the Constitutional and Nomination Committee. This usually occurs as a result of premises being closed or unexpectedly becoming unavailable, often at short notice, or if an

unscheduled poll takes place. Authority is delegated to the Chief Executive to make, where necessary, alterations to the designation of any polling place in such circumstances, in consultation with group leaders, ward Councillors and the Chair of Constitutional and Nomination Committee, as agreed by Council at its 24 January 2018 meeting.

- 2.3 The allocation of polling stations within polling places is not a Council function and is the responsibility of the Returning Officer.
- 2.4 The review can only consider the internal boundaries of polling districts within wards. Parliamentary constituency boundaries are the responsibility of the Boundary Commission for England (BCE) and are subject to a completely separate review process. Ward boundaries are the responsibility of the LGBCE as already referred to under point 1.3 above. See point 4.3 for further details of considerations relevant to this review.

3. Aim of the proposed Review

- 3.1 In designating polling places, the Council has an obligation that it will:
 - (a) seek to ensure that all the electors in the constituency have such reasonable facilities for voting as are practicable in the circumstances;
 - (b) seek to ensure that so far as is reasonable and practicable, the polling places it is responsible for are accessible to all electors who are disabled;
 - (c) have regard to the accessibility of disabled persons to potential polling stations in the polling place;
 - (d) other than in special circumstances, locate the polling place in the polling district it serves; and
 - (e) ensure the polling place is small enough to indicate to electors in different parts of the polling district how they will be able to reach the polling station.
- 3.2 The focus of the Review will be to identify wherever possible polling places which meet criteria, relating to:
 - Location
 - Facilities
 - Accessibility to/and within the polling place/station
 - Heath and safety, and
 - Space
- 3.3 Although the legislation would seem to suggest the adoption of a top down approach to the review, with polling districts being determined before polling places, in practice a bottom up approach is usually adopted. The reality is that, where good quality polling station sites are identified, it is sensible to build polling places and districts around them and this approach is recognised by the Electoral Commission.

3.4 At the same time, whilst ideally the Council would have the choice of a range of fully accessible buildings, conveniently located for the electors in the area, this is not always the case and there may be little choice available. Ensuring the continuing accessibility of buildings and the location of polling places will be a key factor in developing the final proposals. Where it is not possible to identify polling places which meet the specification exactly, particularly around accessibility, every reasonable adjustment will be undertaken to provide access for all electors. Further details regarding the terminology used in this report can be found in Appendix 1. Draft specifications for polling places/stations can be found in Appendix 2.

4. Preparations for the review

- 4.1 Following the implementation of the current scheme, officers in the Electoral Services Unit have been actively monitoring the effectiveness of the current arrangements, taking into account the number of electors and turnout at different polls, with the best interests of the elector in mind. In addition, a record has been kept of any comments received from stakeholders, including previous representations made by elected representatives, officers and premises, for consideration once the review is formally underway.
- 4.2 Officers are also collating information from a variety of sources using the Council's wider knowledge and intelligence in relation to demographics, residential planning and development to understand the future volume and distribution of electors. This is particularly relevant to wards in the city centre and its fringes where the greatest levels of new residential development is taking place. This work is also taking into account the suitability, availability and accessibility of polling places, including the identification of new premises.
- 4.3 It should be noted that parliamentary constituency boundaries are based on groupings of the wards in place prior to Manchester's Electoral Review. The city's new ward boundaries which came into effect in May 2018, therefore no longer exactly correlate with the parliamentary constituency boundaries. In order to ensure that both parliamentary and local elections (standalone or combined) can be delivered using the same scheme, there are a small number of polling districts (with accompanying polling places) where the boundaries cannot be changed.

5. The proposed review process and timetable

5.1 It is proposed that the compulsory review takes place between 15 July 2019 and 27 November 2019. The timetable set out in Appendix 3 takes account of the three distinct stages, further details of which are outlined overleaf.

5.2 Stage 1: Formal notification of the Review

5.2.1 Formal notification of the review process is when the Council publishes a notice of the Review, which will be displayed in each parliamentary constituency and be published on the Council's website. Subject to the

Committee's approval, this notice would be published on 11 July 2019 and will set out:

- that the Council is conducting a review of polling districts and polling places
- that the (Acting) Returning Officer will make comment on proposed polling stations, and an indication of when and where the (Acting) Returning Officer's representations will be made available
- that electors within the authority or within a UK parliamentary constituency which has any part in the authority may make a representation
- that the Council would welcome the views of all residents, particularly disabled residents, on the authority's proposals, the (Acting) Returning Officer's representations or any other matters
- that the authority would welcome any person or body with expertise in access for persons with any type of disability to comment on the authority's proposals, the (Acting) Returning Officer's representations or any other matters
- that persons or bodies making representations should, if possible, give alternative places that may be used as polling places
- the postal address, e-mail address and website address at which documents can be inspected and representations made
- the timetable of the review and a deadline for representations

5.3 Stage 2: Consultation

- 5.3.1 The consultation period will run from 15 July 2019 until 4 October 2019.
- 5.3.2 This stage is for representations and comments to be made on the existing arrangements for polling districts and polling places. There are two aspects to this stage:
 - A submission from the (Acting) Returning Officer of the UK parliamentary constituency or constituencies, which must then be published by the Council and must include information regarding the location of polling stations within polling places (current or proposed). The Council will publish the (Acting) Returning Officer's representations during the week commencing 29 July 2019. Any persons involved in the consultation have the right to comment on the (Acting) Returning Officer's submission.
 - Submissions from electors and other interested persons and bodies, including elected representatives and those with expertise in relation to access to premises or facilities for disabled people.
- 5.3.3 Any elector for a UK parliamentary constituency either wholly within or partly within the Manchester City Council area may comment on any of the recommendations within the whole local authority area.

- 5.3.4 By law representations must be sought from such persons as the Council considers as having particular expertise in relation to access to premises or facilities for persons who have different forms of disability. Such persons must also have an opportunity to make representations and comment on the (Acting) Returning Officer's representations.
- 5.3.5 It is important that any person or body that makes a comment has the opportunity to suggest alternative polling districts/polling places and where possible to give a reason for the alternative proposal so that it may be given appropriate consideration.
- 5.3.6 A short consultation questionnaire is being developed to enable consultees to provide comment on the current polling arrangements, including suggesting alternatives, either using a hard copy or via the Council's website.
- 5.3.7 A communications strategy has been developed for the review to ensure that stakeholders are aware that it is taking place and have the opportunity to respond to the consultation. This will include:
 - a dedicated page on the Council's Consultation section of the website including a questionnaire for completion (linked to from the Elections webpages) to encourage electors to participate
 - raising awareness of the consultation via social media and the e-bulletin press releases
 - direct contact with Councillors, MPs and other elected representatives, political parties and those with expertise relating to access for disabled people to request their input into the review
 - consultation sessions for Councillors, MPs and other elected representatives.
- 5.3.8 Hard copies of questionnaires, ward maps and key documentation will be available for inspection in each of the five parliamentary constituencies (at a number of public libraries) for which Manchester's (Acting) Returning Officer is responsible.
- 5.3.9 As part of the review the existing Elections and Registration Member Working Group (membership of Councillor Nigel Murphy, Councillor Sue Murphy and Councillor Leech) will work with officers from the Electoral Services Unit to review current polling district and polling place arrangements, taking into account the existing comments and those consultation responses received, in order to inform the development of proposals. Subject to the consideration of submissions received during the consultation process, it is envisaged that where existing arrangements do continue to work effectively, these will be retained for the benefit of electors.
- 5.4 Stage 3: Concluding the Review
- 5.4.1 Final draft proposals for polling districts and polling places will be prepared by officers for submission to a special meeting of the Committee in October 2019,

- to enable them to make recommendations to Council at their meeting taking place on 27 November 2019.
- 5.4.2 Any changes to the scheme agreed by Council will be reflected in the Electoral Register published by the Electoral Registration Officer on 1 December 2019 and will be in place for the next scheduled elections the local elections and the Combined Authority Mayoral Election taking place on 7 May 2020.
- 5.4.3 Once the final proposals are approved by the Constitutional and Nomination Committee and a decision made by the Council, the reasons for the decision must be published, along with the following documentation:
 - (a) all correspondence sent to an (Acting) Returning Officer in connection with the review;
 - all correspondence sent to any person whom the authority thinks has particular expertise in relation to access to premises or facilities for persons who have different forms of disability;
 - (c) all representations made by any person in connection with the review;
 - (d) the minutes of any meeting held by the authority to consider any revision to the designation of polling districts or polling places within its area as a result of the review;
 - details of the designation of polling districts or polling places within its areas of as a result of the review; and
 - (f) details of the places where the results of the review have been published.

6. Recommendations

6.1 Recommendations to the Committee appear at the front of this report.

Appendix 1

Terminology used in the Report

Ward: the 32 wards into which the Manchester City Council area is sub divided.

Polling district: the area created by the division of a constituency or ward into smaller parts, within which a polling place can be determined, which is convenient to electors. In Manchester, each ward is divided into a number of polling districts. Each polling district starts with a number (denoting the parliamentary constituency) followed by a three letter code (the first two letters of which indicate the ward in which the polling district is located). It should be noted that Ringway Parish must have its own polling district currently 5WPF.

Polling place: is the building or area in which the polling station(s) will be sited by the Returning Officer.

Polling station: the room where the poll takes place (e.g. community room), which must be located within the polling place. The polling station is chosen by the Returning Officer.

Where possible, every polling district should have its own dedicated polling place and all electors in that polling district are assigned to vote at the polling station located in that place. However, it is possible to have a polling place based in an adjacent polling district where circumstances determine this is the best option.

It should be noted that the terms 'polling place' and 'polling station' are often used interchangeably and most people consider the polling place (such as a community centre) to be the polling station. However, it is possible to have a double polling station in a polling place (e.g. two sets of staff, two ballot boxes, and two electors' registers). Double stations exist where electors may be coming from two different polling districts/wards, in polling districts where there are a large number of electors in person or where there is high turnout expected.

Appendix 2

Specification for polling places/stations

A polling place is the geographical area within which polling stations are sited. It is normally a building or group of buildings or in the case of a temporary polling station the area of land on which the temporary station would be sited. The polling station is the actual area where the poll takes place and it must be within the polling place. In order to establish the suitability of a polling place/polling station consideration should be given to the following:

1. Location of the building

Is it located close to where most of the electors in the polling district live?
Is it located at the top/bottom of a steep hill?
Does it have suitable access from a road?
If there is a pavement does it have a dropped kerb close by?
Are there convenient public transport links?
Is it safe and well lit?
Are there facilities such as toilets and a kitchen area for polling station staff to use?

2. Parking facilities/pathways

Are there adequate parking facilities close to the to the entrance of the building Are there designated disabled parking spaces? Is there a dropped kerb from the parking area to the polling station? Is the approach from the road/car parking suitable e.g.

- are there steps?
- is the surface suitable particularly for wheelchair users?
- is it well lit?
- are there any severe gradients?

3. Main Entrance to the building

Does the building have a level entrance?
Are there steps to the entrance of the building?
Is there a hand rail by the steps?
Is a permanent ramp provided?
If not could a temporary ramp with a suitable gradient be provided safely, or is there another entrance that disabled people or other electors could use?
Is the door wide enough for a wheelchair user to gain access?
How heavy are the doors to open?

4. Inside the building

Are there any internal steps or barriers for electors to negotiate?
Are there any trip hazards e.g. uneven door mats?
Are the floor coverings suitable e.g. would they become slippery when wet?
Are there any corridors which may be difficult to negotiate for any electors using wheel chairs or those who find walking difficult?

Are there any security issues inside the building? Is the route from the entrance to the polling station room straightforward?

5. Polling station room

Is there enough space in the polling station room for staff, polling equipment and a number of electors, including wheelchair users?

Is there enough space in the room to have two polling stations (a double station) if necessary?

Is the lighting in the polling station room adequate?

Is the heating in the polling station room adequate?
