What is the decision?	<p>To approve the annual care contracts uplift for 2020/21, effective 1<sup>st</sup> April 2020. The cost impact is £5.667m and has been provided for within the 2020/21 ASC cash limit budget, specifically funding set aside for the National Living Wage increase and price inflation.</p> <p>The approved increases are follows:</p> <ol style="list-style-type: none"><li>1) Residential and Nursing Older People 4% or £19.50 per placement per week</li><li>2) Learning Disability and Mental Health Services 4.62% capped at a max £132 per package per week covering:-<ul style="list-style-type: none"><li>• Residential and Nursing</li><li>• Homecare</li><li>• Daycare</li><li>• Supported Living</li><li>• Direct Payments</li></ul></li><li>3) Direct Payments (PA's) 4.72%</li><li>4) Other Services 4.5% covering:-<ul style="list-style-type: none"><li>• Supported Living</li><li>• Supporting People</li><li>• ILF</li><li>• Other Day Care</li></ul></li><li>5) Extracare 3.3% which forms part of the new framework contracts for Homecare</li></ol>
Reasons for the decision (but excluding any exempt or confidential information)	<p>The increase will help to secure adequate care provision is maintained within the market to meet statutory responsibilities and to provide care and support for Manchester people.</p> <p>Following consultation and feedback from providers, the uplift ensure providers are able to meet the requirements of the national living wage and provides for inflationary pressures on other costs.</p>
