The licensing and out of hours team have assessed the application taking into account a numbers of factors, including the hours applied for and any potential risk that the granting of this application could lead to undermining the prevention of public nuisance as a licensing objective under the Licensing Act 2003.

The premise is on a busy main road, a road which is predominantly made up of licensed premises already with other late night refreshment establishments

This application is requesting operating hours of Sunday – Wednesday 2300-0200 Thursday – Saturday 2300-0400

To further ensure that public nuisance is diminished where practicable, the Licensing and Out Of Hours Team request the following additional conditions

- Documented records of training completed shall be kept for each member of staff. Training shall be regularly refreshed at no greater than 12 monthly intervals.
- Training records shall be made available for inspection upon request by a police officer or an authorised officer of Manchester City Council
- The premises shall install and maintain a comprehensive digital colour CCTV system. All public areas of the licensed premises, including all public entry and exit points and the street environment will be covered, enabling facial

identification of every person entering in any light condition. The CCTV cameras shall continually record whilst the premises are open to the public and recording shall be kept available and unedited for a minimum of 28 days with the date and time stamping. A staff member who is conversant with the operation of the CCTV system shall be present on the premises at all times when they are open to the public and must be able to produce / download / burn CCTV images upon request by a police officer or an authorised officer of the licensing authority. Any footage must be in a format so it can be played back on a standard personal computer or standard DVD player. Where the recording is on a removable medium (i.e. compact disc, flash card etc.), a secure storage system to store those recording mediums shall be provided.

- Prominent, clear and legible notices shall be displayed at the exits requesting customers to leave the premises and area quietly and respect the needs of local residents
- Delivery of goods necessary to the operation of the business shall be carried
 out at such a time and manner as to prevent nuisance and disturbance to
 nearby residents.

Whilst it's acknowledged that planning legislation runs separately to the licensing regime, we would like the premises to consider bringing the premises licence opening hours to run in conjunction with the operating hours within the current planning permission granted on the premises as advised below.

The current planning operating hours are;

Sunday to Thursday, until 2330 Friday – Saturday until 0000
