Open containers of alcohol shall not be removed from the premises save for consumption in this area. Customers leaving the premises to smoke will be required to leave their drinks inside, unless they are going into the delineated external area at the premises.'</li> <li>Remove condition 4 of annex 3.</li> <li>Add the following condition: 'There shall be no external drinking or dining after 10pm daily.'</li> </ol> The premises intends to bring into use a courtyard at the rear of the premises which forms part
of their demise. This area is to be serviced by off sales only, and will not form part of the licensed area, so no amendments to the plan is required.
