Annex 1 – Mandatory conditions
<b>Door Supervisors</b>  1. Only individuals licensed by the Security Industry Authority shall be used at the premises to undertake security activities, which include guarding against: - (a) Unauthorised access or occupation (e.g. through door supervision), (b) Outbreaks of disorder, or (c) Damage, unless otherwise entitled by virtue of section 4 of the Private Security Industry Act 2001 to carry out such activities.

Annex 2 – Conditions consistent with the operating schedule
1. An effective and adequate CCTV system shall be installed, maintained and operated at the premises. 2. Notices shall be displayed to inform customers that any anti-social behaviour will be reported to the police. 3. Management shall work with the officers from the Council to set the limit of the sound played from the jukebox, which will play background music only. 4. Any complaints will be dealt with promptly. 5. Delivery drivers shall be instructed not to use “high beam” lights. 6. The loading of orders into delivery vehicles shall take place as quickly as possible.

Annex 3 – Conditions attached after hearing by the licensing authority
1. No takeaways to be purchased from the shop after 2300. The restaurant shall operate a dine-in and delivery service only from this time. 2. Noise or vibration shall not emanate from the premises so as to give rise to a nuisance to other premises. 3. Delivery drivers shall be instructed to enter and leave their vehicles quietly and considerately, not to leave engines running, to park considerately, and at all times to have in mind the neighbours and in particular residential occupiers. 4. Delivery drivers shall not sound their vehicle horns whilst outside the delivery address. 5. A written record of all staff training shall be held at the premises. 6. An adequate number of litter bins shall be provided for waste packaging and food. 7. Notices shall be displayed in the premises instructing customers to leave the premises in a quiet, orderly manner and to give consideration to nearby residents. 8. Staff shall take all reasonable steps to ensure that customers do not congregate outside the premises. 9. Refuse shall not be emptied into bins between the hours of 2000 and 0800.

10. Waste collections shall not take place between 2000 and 0800.
11. The area outside the premises shall be kept clean and tidy. Staff shall be required to remove all litter associated with the premises on a regular basis throughout the licensed hours and in particular shall clear any litter when the premises closes.
12. Regulated entertainment shall cease at 2300.
