<p>A) The Prevention of Crime and Disorder</p> <ol style="list-style-type: none"> 1. A CCTV system shall be maintained and operated at the premises with cameras positioned both internally and externally. 2. Recorded CCTV images will be maintained and stored for a period of twenty-eight days and shall be produced to the Police or Licensing Authority upon request. 3. CCTV will be in operation at any time a person is in the premises. Where CCTV is recorded onto a hard drive system, any DVDs subsequently produced will be in a format so it can be played back on a standard PC or DVD player. 4. Any person left in charge of the premises must be trained in the use of any such CCTV equipment, and be able to produce CCTV images to an officer from a responsible authority upon request. 5. SIA registered door staff shall be employed at the premises, in accordance with a risk assessment, to be carried out by the DPS. When employed, door staff will wear high visibility armbands. 6. When employed, a register of those door staff employed shall be maintained at the premises and shall include: <ol style="list-style-type: none"> (i) the number of door staff on duty; (ii) the identity of each member of door staff; 7. Staff will be trained in the requirements of the Licensing Act 2003 with regard to the Licensing Objectives, and the laws relating to under age sales and the sale of alcohol to intoxicated persons, and that training shall be documented and repeated at 6 monthly intervals. 8. A refusals book will be maintained at the premises, and made available to an officer of a responsible authority upon request. <p><u>B) Public Safety</u></p> <ol style="list-style-type: none"> 1. Management shall liaise with the Fire Authority as necessary to ensure compliance with all necessary fire regulations. <p><u>C) The Prevention of Public Nuisance</u></p> <ol style="list-style-type: none"> 1. <ol style="list-style-type: none"> 2. No noise shall emanate from the premises nor vibration be transmitted through the structure of the premises which gives rise to a nuisance. 3. The exterior of the building shall be cleared of litter at regular intervals. 4. Notices will be positioned at the exits to the building requesting customers to leave in a quiet manner. 5. Doors and windows at the premises are to remain closed after 11pm, save for access and egress. 6. A Dispersal and Smoking Policy will be implemented and adhered to. <p><u>D) The Protection of Children From Harm</u></p> <ol style="list-style-type: none"> 1. A "Challenge 25" Policy shall be implemented in full and appropriate identification sought from any person who appears to be under the age of 25. The only acceptable forms of ID are photographic driving licences, passports, HM forces warrant cards, EU/EEA national ID card or similar document or a form of identification with the "PASS" hologram. 2. Staff training will include the Challenge 25 Policy and its operation. In particular, staff shall be trained to take such action as is necessary to prevent the sale of alcohol to persons over the age of 18 where those customers are engaged in the distribution of alcohol to persons under the age of 18. The training must be given to a new member of staff before they commence employment and all staff must receive refresher training every 6 months. 3. Notices advising what forms of ID are acceptable must be displayed. 4. Notices must be displayed in prominent positions indicating that the Challenge 25 policy is in force.

These checklists shall be recorded and kept for a minimum of six months and made available to an authorised officer 4. The premises shall maintain an Incident Log that records all important and relevant incidents that occur at the premises and public liability insurance. 5. The outside seating area will be fully cleared of all plates, glass, food utensils etc by 23.00hrs and all customers shall have vacated this area by 23.00hrs except for customers smoking. 6. There shall be no external speakers in the outside area 7. No odour shall emanate from the premises that give rise to a nuisance

A noise limiter must be fitted to the musical amplification system set at a level determined by and to the satisfaction of an authorised officer of the Environmental Health Service, so as to ensure that no noise nuisance is caused to local residents or businesses. The operational panel of the noise limiter shall then be secured by key or password to the satisfaction of officers from the Environmental Health Service and access shall only be by persons authorised by the Premises Licence holder. The limiter shall not be altered without prior agreement with the Environmental Health Service. A direct telephone number for the manager of the premises shall be publicly available at all times the premises is open. This telephone number is to be made available to residents in the vicinity 4. No speakers shall be located in external areas (<i>duplicate of condition agreed with LOOH and Resident 1</i>) 5. Alcohol sold for consumption off the premises shall be limited to consumption in the external area at the premises only. 6. Any incidents of crime and disorder will be dealt with by staff and/or door staff who shall be appropriately trained in this regard. 7. A noise limiter must be fitted to the musical amplification system set at a level determined by and to the satisfaction of an authorised officer of the Environmental Health Service, so as to ensure that no noise nuisance is caused to local residents or businesses. The operational panel of the noise limiter shall then be secured by key or password to the satisfaction of officers from the Environmental Health Service and access shall only be by persons authorised by the Premises Licence holder.
