Annex 1 – Mandatory conditions**Door Supervisors**

1. Only individuals licensed by the Security Industry Authority shall be used at the premises to undertake security activities, which include guarding against: -
 - (a) Unauthorised access or occupation (e.g. through door supervision),
 - (b) Outbreaks of disorder, or
 - (c) Damage,
 unless otherwise entitled by virtue of section 4 of the Private Security Industry Act 2001 to carry out such activities.

Supply of alcohol

2. No supply of alcohol may be made under this premises licence:
 - (a) At a time when there is no designated premises supervisor in respect of the premises licence or,
 - (b) At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
3. Every retail sale or supply of alcohol made under this licence must be made or authorised by a person who holds a personal licence.
4. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

- (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either –
 - (a) a holographic mark, or
 - (b) an ultraviolet feature.

- 5. (1) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price, which is less than the permitted price.
- (2) For the purposes of the condition set out in (1) above–
 - (a) “duty” is to be construed in accordance with the Alcoholic Liquor Duties Act 1979
 - (b) “permitted price” is the price found by applying the formula–

$$P = D + (D \times V)$$

where –

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) “relevant person” means, in relation to premises in respect of which there is in force a premises licence –
 - (i) the holder of the premises licence,
 - (ii) the designated premises supervisor (if any) in respect of such a licence, or
 - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) “relevant person” means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) “valued added tax” means value added tax charged in accordance with the Value Added Tax Act 1994.
- (3) Where the permitted price given by paragraph (2)(b) would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- (4) (a) Sub-paragraph (4)(b) applies where the permitted price given by paragraph (2)(b) on a day (“the first day”) would be different from the permitted price on the next day (“the second day”) as a result of a change to the rate of duty or value added tax.
- (b) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

- 6. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises –
 - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to –

- (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
- (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

7. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

8. The responsible person must ensure that –

- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures –
 - (i) beer or cider: ½ pint;
 - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - (iii) still wine in a glass: 125 ml;
- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold the customer is made aware that these measures are available.

For the purposes of conditions 6, 7 and 8 above, a responsible person in relation to a licensed premises means the holder of the premise licence in respect of the premises, the designated premises supervisor (if any) or any individual aged 18 or over who is authorised by either the licence holder or designated premises supervisor. For premises with a club premises certificate, any member or officer of the club present on the premises in a capacity that which enables him to prevent the supply of alcohol.

Annex 3 – Conditions attached after a hearing by the licensing authority

1. Any areas where customers have legitimate access shall be sufficiently illuminated for the purposes of CCTV. CCTV shall be in operation at all times the premises is open to trade. All CCTV recorded images shall have sufficient clarity/quality/definition to enable facial recognition. CCTV shall be kept in an unedited format for minimum period of 28 days. CCTV shall be maintained on a regular basis and kept in good working order at all times. Where CCTV is recorded on to a hard drive system any DVDs subsequently produced shall be in a format so it can be played back on a standard personal computer or a standard DVD player. Where CCTV is recorded on to a hard drive system, the hard drive system shall have a minimum of 28 day roll over recording period. Any person left in charge of the premises shall be trained in the use of any such CCTV equipment and able to produce/download/burn CCTV images upon request by a person from a responsible authority. Where the recording is on a removable medium (i.e. compact disc, flash card etc.) a secure storage system to store those recording mediums shall be provided.
2. Hand-held metal detectors shall be operated by door supervisors monitoring the front entrance at all times and used on all patrons; door supervisors at the rear exit shall also operate hand-held metal detectors when customers are being re-admitted to the premises from the smoking area.
3. A fully functioning knife arch shall be installed within the front entrance door frame of the premises. The knife arch shall be operational during the hours of licensable activities. All persons entering the premises shall pass through the knife arch.
4. All door staff shall be employed through an SIA registered company.
5. During the hours of licensable activities at least one member of door staff shall be female.
6. An ID Clubscan or equivalent (to the same standard) shall be operated at the premises. All customer identification documents shall be checked via the system before being allowed access to the premises. Any person refusing to comply shall be refused access to the premises.
7. Regular toilet checks shall be made to ensure the area is not being used for criminal activities.
8. On Sunday to Thursday SIA door staff shall be employed at the premises at a ratio of 1:100 from 2200 hours until 30 minutes after closing with a minimum of 2 door staff on duty from 2200 hours. The requirement for extra door staff on these days will be risk assessed by the DPS / Manager.

On Fridays SIA door staff shall be employed at the premises at a ratio of 1:100, with a minimum of 2 door staff on duty from 2200 hours and a minimum of 4 door staff on duty from 2400 hours until 30 minutes after closing. The requirement for extra door staff on these days will be risk assessed by the DPS/Manager.

On Saturdays SIA door staff shall be employed at a ratio of 1:100 with a minimum of 3 door staff on duty from 2200 hours and a minimum of 6 door staff on duty from 2400 hours until 30 minutes after closing. The requirement for extra door staff on these days will be risk assessed by the DPS/Manager.
9. When the designated VIP area is in use there shall be a minimum of 1 SIA registered supervisor allocated to the area. They shall remain on duty until the premises are closed and shall clearly display their SIA badges on their person and wear hi-visibility vests at all times when on duty.
10. Door staff shall sign on sign on and off duty in a book kept for that purpose and all entries shall be checked and signed by the DPS or their nominated deputy.
11. An additional book shall be kept at the premises which shall contain the full names, current addresses, dates of birth, badge number and up to date photograph of all door staff who work at the premises.
12. An internal pager system shall be used within the premises.
13. Only polycarbonate drinking vessels shall be used within the premises.
14. Persons shall not be permitted to enter or leave the premises if in possession of any form of open bottle or glassware.
15. The premises shall provide all drinks in polycarbonate drinking vessels other than in the VIP area.
16. Bottles of wine, spirits and champagne shall be available for purchase and consumption in the VIP area.
17. Bottles shall not be taken out of the VIP area into other areas of the club.
18. Bottles shall be removed from the VIP area as soon as all drink has been decanted from them.

19. There shall be a minimum of 2 glass collectors employed at the premises to ensure that glasses are collected regularly and removed from the licensed area.
20. The reception area staff shall monitor CCTV in the VIP room and advise staff if a glass collection is required.
21. Amplified music played at the premises shall not be audible at the nearest residential dwelling.
22. A 30-minute wind down period towards the end of licensable activities, playing less intense music shall be implemented.
23. Local taxi numbers shall be displayed near the exit of the premises.
24. No refuse shall be disposed of outside the premises between the hours of 23:00 and 08:00.
25. No doors or windows shall be opened after 23:00 whilst licensable activities are taking place except for access and egress.
26. Prominent, clear and legible notices shall be displayed at all exits requesting the customers to respect the needs of local residents and leave the premises and area quietly.
27. At the close of premises a minimum of 2 door staff shall remain outside the premises for at least 30 minutes to actively manage the quiet, orderly dispersal of all customers.
28. Persons under the age of 18 years shall not be permitted to enter the premises.
29. A Challenge 25 scheme shall be operated at the premises - the only form of valid identification being passport, photo driving licence, PASS hologram id card or Her Majesty's Forces Warrant Card - failure to provide such ID shall result in no sale of alcohol to that person;
