<ol style="list-style-type: none"> 1. The licence holder will ensure that the premises benefit from a CCTV system that operates at all times when licensable activities are taking place. 2. The system will incorporate a camera covering each of the entrance doors and the main alcohol display area and will be capable of providing an image which is regarded as identification standard. The precise positions of the cameras may be agreed, subject to compliance with Data Protection legislation, with the police from time to time. 3. The system will incorporate a recording facility and any recording will be retained and stored in a suitable and secure manner for a minimum of 30 days and will be made available, subject to compliance with Data Protection legislation, to the police for inspection on request. 4. The system must be able to export recorded images to a removable means e.g. CD/DVD and have its own software enabled to allow playback/review. 5. A member of staff trained in the use of the CCTV system must be available at the premises at all times that the premises are open to the public. 6. The system will display, on any recording, the correct time and date of the recording. 7. An incidents register shall be maintained at the premises recording: <ol style="list-style-type: none"> a) all incidents of crime and disorder occurring at the premises; b) details of occasions when the police are called to the premises. <p>This register will be available for inspection by a police officer on request.</p> 8. The applicant will at all times maintain adequate levels of staff and security. Such staff and security levels will be disclosed, on request, to the licensing authority and police. 9. Signage will be displayed at the exit of the premises requesting customers leaving the premises late at night to do so quietly and with consideration so as not to disturb nearby residents. 10. The premises licence holder will ensure that an age verification policy will apply to the premises whereby all cashiers will be trained to ask any customer attempting to purchase alcohol, who appears to be under the age of 25 years (or older if the licence holder so elects) to produce, before being sold alcohol, identification being a passport or photocard driving licence bearing a holographic mark or other form or method of identification that complies with any mandatory condition that may apply to this licence. <p>11. All staff engaged or to be engaged in the sale of alcohol on the premises shall receive training in age restricted sales. Induction training must be completed and documented prior to the sale of alcohol by the staff member. Refresher/reinforcement training must be completed and documented at intervals of no more than 6 months. Training records will be kept at the premises available for inspection by a police officer on request.</p> <p>12. All cashiers shall be trained to record refusals of sales of alcohol in a refusals register. The register will contain:</p> <ul style="list-style-type: none"> a) details of the time and date the refusal was made; b) the identity of the staff member refusing the sale; c) details of the alcohol the person attempted to purchase. <p>This register will be available for inspection by a police officer on request.</p>

<p>1. The premises licence holder shall ensure that the provision of door supervisors at the premises is appropriate to ensure the safe control of the premises, and shall review this on a regular basis and upon request from GMP.</p> <p>Condition b)7 to be replaced with:</p> <p>2. An incident log (which may be electronically recorded) shall be kept at the premises for at least six months, and made available on request to GMP or an authorised officer of the licensing authority, which will record the following incidents including pertinent details:</p> <ul style="list-style-type: none"> (a) all crimes reported to the venue, or by the venue to the police (b) any incidents of disorder (c) any faults in the CCTV system (d) any refusal of the sale of alcohol (e) any visit by a relevant authority or emergency service <p>3. All staff shall be trained in recognising signs of drunkenness. Documented records of training completed shall be kept for each member of staff. Training shall be regularly refreshed and at no greater than 6 monthly intervals. Training records shall be made available for inspection upon request by a police officer or an authorised officer of Manchester City Council.</p> <p>4. No noise shall emanate from the premises nor vibration be transmitted through the structure of the premises that gives rise to a nuisance.</p>	No (all)	Licensing and Out of Hours

<p>5. The premises and immediate surrounding area shall be kept clean and free from litter at all times the premises are open to the public.</p> <p>6. Litter bins shall be provided at the premises in sufficient capacity to ensure that customers can adequately dispose of any litter.</p> <p>7. No bottles, glasses or similar items may be disposed of in outside receptacles between 22:00 and 07:30 hours.</p> <p>8. Delivery drivers shall conduct the delivery in a manner that will not cause a noise disturbance to the occupiers of any residential properties surrounding the delivery address. This includes the avoidance of slamming doors, playing loud music, shouting, overrevving engines and sounding horns to signal their arrival. The driver shall turn the engine off immediately upon arrival at the delivery address and will park considerately without causing any obstruction to the highway.</p> <p>9. All sales of alcohol for consumption off the premises shall be in sealed containers only and shall not be consumed on the premises.</p> <p>10. Prior to any designated special event by Greater Manchester Police and 'designated sporting event' (as defined in the Sporting Events Control of Alcohol Act 1985) the premises licence holder shall ensure that:</p> <ul style="list-style-type: none">(i) Alcohol sales in respect of cans of beer or cider are limited to no more than four cans per person for a minimum of four hours before the commencement of the relevant designated special and sporting event.(ii) On any day where there is a relevant designated special and sporting event taking place, the premises will not externally advertise as a result of a local store promotion the availability of beer or cider in such a way as to be likely to be the sole inducement to attract persons to the premises who are either attending the designated special and sporting event or in the vicinity of the premises as a result of the designated special and sporting event.(iii) All members of staff working at the premises are informed of this condition prior to taking up employment.(iv) On the day of the relevant designated special and sporting event, upon the direction of a police officer, using the grounds of the prevention of crime and disorder or public safety, the premises will immediately cease to sell alcohol until further directed.
