1. Management and staff shall contact Greater Manchester Police to report any incidents of crime and disorder which occur at the premises.
2. The management and staff shall ensure that the premises and the area immediately surrounding the exterior of the premises are cleaned on a regular basis and remain free from debris and litter.
3. All electrical equipment and systems at the premises shall be maintained and serviced according to the manufacturers instructions.

Annex 3 – Conditions attached after a hearing by the licensing authority

1. To ensure noise levels are kept to a minimum.
2. To ensure all working equipment including extraction and ventilation systems are well maintained to ensure noise levels are kept to a minimum.
3. The outside and inside of the premises to be kept clean and safe for the public. Litter to be removed from outside the premises at regular intervals and after the close of business.
4. The collection or disposal of waste in external containers, including glass bottles, not to be permitted at noise sensitive times, that is between 22.00 hours and 08.00 hours.
5. Deliveries of stock to the premises only to be carried out between 07.00 hours and 22.00 hours, apart from newspaper deliveries.
6. To ensure litterbins are emptied on a regular basis and more often at peak business times.
7. To ensure all commercial refuse is removed regularly.
8. A sign to be fixed prominently near the exit, requesting customers do not congregate outside the premises.
