#### **Door Supervisors**

- 1. Only individuals licensed by the Security Industry Authority shall be used at the premises to undertake security activities, which include guarding against: -

  - (b) Outbreaks of disorder, or
  - (c) Damage,

unless otherwise entitled by virtue of section 4 of the Private Security Industry Act 2001 to carry out such activities.

### Annex 2 – Conditions consistent with the operating schedule

- 1. There shall be no food consumption on site, all food shall be takeaway to ensure there are no gatherings.
- 2. Night security shall be on site for night shifts.
- 3. No children shall be served without adult supervision.

### Annex 3 – Conditions attached after hearing by the licensing authority

- 1. To carry out regular inspections of the area for litter throughout the trading day and at the end of the trading day and to collect and dispose of any litter found on Northern Square in the vicinity of the Unit which has been produced by the units trade .
- 2. SIA staff to be employed between 23:00 02:00 and to wear hi-vis armbands.
