We currently have an SIA Night Security from 11pm onwards, they control the crowd. Our CCTV also act as a deterrent. We've been trading nealy a year and haven't had any nuisances in our business

Notes for Guidance

This application cannot be used to vary the licence so as to extend the period for which the licence has effect or to vary substantially the premises to which it relates. If you wish to make that type of change to the premises licence, you should make a new premises licence application under section 17 of the Licensing Act 2003.

1. You do not have to pay a fee if the only purpose of the variation for which you are applying is to avoid becoming liable to the late night levy.
