

I am Police Constable 17659 Isherwood of the Greater Manchester Police, Licensing Officer for the City of Manchester Division, currently based in the Licensing Team at Manchester Town Hall Extension.

Part of my remit as licensing officer is to oversee all of the licensed premises on the City of Manchester Division. The objective of the role is to promote and maintain the 4 licensing objectives at licensed premises, those being the Prevention of Crime and Disorder, Public Safety, Prevention of Public Nuisance and the Protection of Children from Harm.

Club Bloom

The premises are situated on Bloom Street in the Village area of Manchester and the premises licence was issued on 31/08/2005. The Premises Licence Holder (PLH) Lapwine Limited and the Designated Premises Supervisor (DPS) is Joe Maybury who has held this position since January 2018.

Incidents

Greater Manchester Police have had a look back over the past 12 months at violence, threat and sexual type crimes that have been recorded against these premises and there is a total of 38. A brief precis of each of these is as follows:

At 0530 hours on Thursday 12th August 2021 a male was assaulted by unknown persons at the premises leaving him with a fractured eye socket, puncture to his tongue and bruising to his body. Police were called to the incident. A crime for Section 18 Malicious wounding was recorded but the offenders were never traced. This crime report can be found at page 7 of the bundle.

At 0430 hours on Saturday 21st August 2021 security at the premises had cause to eject a customer who was causing issues within the premises. This customer has then proceeded to punch one of the security staff causing no visible injury and police were called to the incident. A crime for Common Assault was recorded but the victim did not wish police to pursue the matter. This crime report can be found at page 8 of the bundle.

At 0500 hours on Sunday 22nd August 2021 security at the premises had cause to eject a male from the premises due to his level of intoxication and his aggressive manner. Once outside he has been arguing with the security and has pushed a female member of the public, so the door staff have detained the male and the police were called to the incident. A crime for Affray was recorded but the female told the door staff that she did not want to pursue the matter and left the location prior to the arrival of the police. The crime was subsequently closed due to lack of a formal complaint. This crime report can be found at page 9 of the bundle.

At 0300 hours on Tuesday 7th September 2021 a female customer and her friends walked out of the premises to use the smoking area. A member of security has sworn at them aggressively telling them to hurry up and has also filmed them on his phone. This cause alarm and distress to the female customer and a crime for Public Order was recorded. Police were called to the incident, but the victim stated that she didn't want to take the matter any further and simply wanted the crime recording. This crime report can be found at page 10 of the bundle.

At 0430 hours on Saturday 18th September 2021 a member of security refused entry to a male due to his demeanour and the male has then attempted to punch the victim and was detained. Police were called to the incident. A crime for Common Assault was recorded but the victim did not wish to pursue the matter and the crime has been filed. This crime report can be found at page 11 of the bundle.

At 0428 hours on Tuesday 26th October 2021 the victim, a male customer, was sat in the premises with an unknown male. This unknown male has then put his tongue down the victim's throat without consent causing the victim distress. A crime for sexual assault was recorded. Police were called to the incident, but the offender had left and could not be identified. This crime report can be found at page 12 of the bundle.

At 0537 hours on Friday 5th November 2021 a group of males were involved in an altercation outside the premises and a female has intervened to try and break it up. One of these males has then pushed her causing her to fall to the ground where she became unresponsive. An ambulance was called, and the victim was treated before going on her way. Police attended the incident and spoke to the victim who stated that she didn't wish to pursue the matter. A crime for Common assault was recorded and filed. This crime report can be found at page 13 of the bundle.

At 0515 hours on Sunday 7th November 2021 a male was refused entry to the premises by security and states that he was assaulted by one of the security staff. Police were called and security were spoken to and stated that a group of males were refused entry to the premises due to their lairy behaviour. The victim was contacted by telephone but would not support the investigation. A crime for Common Assault was recorded and filed. This crime report can be found at page 14 of the bundle.

At 0354 hours on Friday 12th November 2021 a male victim was punched by an unknown offender inside the premises causing a cut to his nose, scratches on his neck and a sore head. A crime for ABH was recorded but the victim did not wish to take the matter any further, so the crime was filed. This crime report can be found at page 15 of the bundle.

At 0815 hours on Saturday 20th November 2021 police were called to a fight outside premises. Two males who were ejected from the premises began to fight outside the venue. The victim who is a doorman tried to intervene and a result got bit by the offender on his index finger causing a small cut. The offender was initially detained and arrested for this however upon speaking to the victim he did not wish to support a prosecution due to minor injuries. A crime for ABH and a crime for Affray were recorded and filed. These crime reports can be found at pages 16-17 of the bundle.

At 0400 hours on Sunday 21st November 2021 a female was ejected from the premises by security and stated that she had her face pushed into the ground by a female security officer. A crime for Common Assault was recorded and after CCTV was later checked it was finalised as a lawful ejection, but the reason that the female was ejected in the first place was due to taking drugs in the toilets, which is a concern. This crime report can be found at page 18 of the bundle.

At 0438 hours on Monday 6th December 2021 a male customer was ejected from the premises and has sustained a cut to his ear and stated that security threatened him with a stick. Police were called to the incident, but the victim had made off. A crime for ABH was recorded but the victim would not support a prosecution, so the crime was filed. This crime report can be found at page 19 of the bundle.

At 0300 hours on Saturday 11th December 2021 the victim, a male customer, was waiting outside the toilets inside the premises and an unknown male has confronted him and engaged him in conversation. The unknown male has then gone into the toilets before coming back out and repeatedly punching the victim in the face causing bruising. A crime for ABH was recorded but the offender was never traced, and the crime was finalised. This crime report can be found at page 21 of the bundle.

At 0400 hours on Saturday 11th December 2021 a female customer was dancing in the premises and a male offender has begun dancing close to her and has then touched her breasts and vagina over her clothing and rubbed himself up against her without consent. Other customers have witnessed this, and one has taken hold of the offender and taken him to the front door and informed security what has happened and asked them to ring the police. However, the male has been allowed to walk away. A passing police patrol was alerted and spoke to the victim and a crime for Sexual Assault was recorded. The offender was never traced, and the crime was filed. This crime report can be found at page 22 of the bundle.

At 0249 hours on Thursday 6th January 2022 a female was inside the female toilets when a male has entered the toilets and touched her on her breasts above her clothing and tried to put his hand down her top. Police were called to the incident and a crime for Sexual Assault was recorded. The offender was not traced so the crime was filed. This crime report can be found at page 23 of the bundle.

At 0100 hours on Saturday 8th January 2022 a female customer and her boyfriend were involved in an altercation with a group of males which resulted in her boyfriend being punched in the face and her being inadvertently hit in the face whilst trying to split up the fighting. This resulted in her receiving a cut to her mouth. Police attended the incident, but the group of males had since made off. A crime for ABH and a crime for Common assault were recorded. The offenders could not be traced, and the crimes have been filed. These crime reports can be found at pages 24-25 of the bundle.

At 0012 hours on Saturday 15th January 2022 a male contacted GMP and stated that his friend had had his ID taken off him by security at the premises and when his friend challenged this the security called him a "Faggot". A crime for Public Order was recorded and closed pending contact from the male who the alleged comments were made to. This crime report can be found at page 26 of the bundle.

At 0500 hours on Saturday 22nd January 2022 the victim and his partner were in the venue and the premises were in the process of asking customers to leave as they were closing. The victim and his partner remained in the premises and were approached by security and a verbal altercation has ensued. The victim has then been forcibly ejected from the premises and during this he has been struck to the face by security resulting in facial injuries and a blooded nose. A report of crime for ABH has been recorded and, as a result of enquiries, some members of the security have been interviewed under caution and a charging decision from the CPS is being awaited. The matter has also been referred to the SIA. This crime report can be found at page 27 of the bundle.

At 0200 hours on Monday 24th January 2022 a male customer was dancing in the premises when he was approached by a female who is known to him who proceeds to punch him in the face causing swelling and bleeding to his lip, whilst threatening to kill him. A crime for ABH was recorded but due to the subsequent lack of co-operation from the victim the crime has been filed. This crime report can be found at page 28 of the bundle.

At 0630 hours on Sunday 6th March 2022 a female customer and her friend were in the premises when they were approached by an unknown male who has proceeded to punch both of them in the face causing her friend to receive a cut under her eyebrow which required gluing. A report of crime for GBH has been recorded

but no offender has been identified so the crime has been filed. This crime report can be found at page 29 of the bundle.

At 0630 on Sunday 6th March 2022 the victim was inside the premises which he saw his partner being assaulted by a group of males. His partner was pushed to the ground and kicked. He went to the aid of his partner and the males then turned on him. They pushed him to the floor and began kicking and punching him resulting in him sustaining a bloody nose, scratches to his face and neck and a lump on his head. 2 crimes for ABH were recorded but both the victims did not wish to pursue the matter, so they have been filed. These crime reports can be found at pages 30-31 of the bundle.

At 0500 hours on Sunday 13th March 2022 a female customer was leaving the premises when she was approached by another female who punched her in the face before making off. A crime for ABH was recorded but the offender was not located so has been filed. This crime report can be found at page 32 of the bundle.

At 2340 hours on Sunday 3rd April 2022 the victim, who is a member of security was punched in the face by a female customer. The female was detained by security and subsequently arrested by police and later received a caution for the offence. A crime for Common Assault was recorded. This crime report can be found at page 33 of the bundle.

At 0400 hours on Saturday 23rd April 2022 security at the premises saw a male offender assault another unknown male in the premises. The offender was then ejected by security. A crime from Common assault was recorded but as the victim was never traced it has been filed. This crime report can be found at page 34 of the bundle.

At 0455 hours on Saturday 7th May 2022 security staff had cause to ask a female customer to leave. She refused and began to shout at the security, so they took hold of her and removed her by force from the premises. The female has then slapped one of them across the face causing no visible injuries. A crime for Common assault was recorded but the security did not wish to pursue the matter, so it has been filed. This crime report can be found at page 35 of the bundle.

At 0420 hours on Friday 20th May 2022 a male was arguing with security at the premises when he has been hit by an unknown person and knocked to the ground causing cuts to his hands. A crime for ABH was recorded and has been filed due to the offender not being identified. This crime report can be found at page 36 of the bundle.

At 0330 hours on Sunday 29th May 2022 a male was walking past the premises when he has seen a group of males fighting in the queue for the premises. He has gone over to try and help break it up and one of the males called him a "fucking faggot" which caused him alarm and distress. A crime for Public Order was recorded but due the offender not being traced has been filed. This crime report can be found at page 37 of the bundle.

At 0425 Hours on Sunday 29th May 2022 security had cause to refuse 2 female customers entry to the premises due to their level of intoxication. These females have then began hitting the security staff and have been detained. Police were called and the security staff stated that they did not wish to pursue a criminal investigation and wanted the females removing form the area. A crime for Common Assault was recorded and filed. This crime report can be found at page 38 of the bundle.

At 0459 Hours on Monday 30th May 2022 a male customer was in the premises when an unknown offender has approached him and made homophobic comments towards him, causing him alarm and distress. A Crime for Public Order was recorded but due to the offender not being identified it has been filed. This crime report can be found at page 39 of the bundle.

At 0500 hours on Friday 3rd June 2022 the victim, a male customer was in the smoking area of the premises when he got in a verbal altercation with another unknown male customer. This unknown male shoved the

victim, and a tussle has ensued resulting in the security staff approaching them to split them up. One member of security has then proceeded to kick and punch the victim repeatedly causing him to briefly lose consciousness and he sustained a broken nose and other facial injuries. Enquiries into this offence are still ongoing and the incident has been referred to the SIA. Crimes for Wounding with Intent and Common Assault have been recorded. These crime reports can be found at pages 40-41 of the bundle.

At 0410 hours on Saturday 4th June 2022 a female was searched prior to entry to the premises and a small quantity of cannabis was removed from her bag. An argument between security and herself has then taken pace and the female states that the security swore at her, spat at her and pushed her in the chest. Enquiries into this report are still ongoing and a crime for Common Assault has been recorded. This crime report can be found at page 42 of the bundle.

At 0130 hours on Friday 17th June 2022 the victim who is non-binary, but for the purposes of crime recording has been classified as male, was forced into a toilet cubicle at the premises and then forced to perform oral sex on the offender before being raped. The offender has been identified and arrested and enquiries are ongoing at this time. 2 crimes for Rape have been recorded and are still being investigated. These crime reports can be found at pages 43-44 of the bundle.

Finally, we have the crime which resulted in the Summary Review process being instigated which occurred in the early hours of Wednesday 29th June 2022. This is the crime in which the female victim was raped in the male toilets by a 14-year-old boy who had been allowed access into the premises without any age verification checks being carried out. The boy is seen to fraternise with members of the security and even accept a cigarette from one of them and shadow box with another, before raping the victim. The security staff initially place the boy in a fenced off smoking area whilst they talk to the manager, but the boy is allowed to walk away a short time later. A crime for Rape has been recorded and the boy has since been arrested and enquiries are continuing. This crime report can be found at page 45 of the bundle. There is some CCTV footage of the male and some body cam footage which GMP will be showing at the full review hearing.

Interim Steps Hearing

On Wednesday 29th June 2022 PC 15092 Stuart Hammersley applied for a Summary Review of the Premises Licence on the grounds that the Premises were associated with Serious Crime. The certificate was signed by Superintendent Downey.

The Interim Steps hearing took place on Friday 1st July 2022 remotely and GMP outlined our concerns regarding the incident. We asked the committee to suspend the Premises Licence pending the outcome of the full review hearing and, after deliberation; the committee took the decision to suspend the Premises Licence pending the full review hearing on Monday 25th July 2022.

2nd Interim Steps Hearing

Following an appeal against the interim suspension from the PLH, a second Interim Steps hearing took place on Wednesday 13th July 2022 at the Royal Exchange and the same concerns were outlined to the committee and CCTV footage was shown. GMP asked committee to uphold the suspension, and, after deliberation, this decision was upheld.

Conclusion

Having reviewed the number of violent, sexual and threat crimes that have occurred over the previous 12 months and the level of violence used in a number of them, coupled with the shocking nature of the most serious crime in which a female was raped by a 14-year-old boy, GMP do not have confidence that the operators can run this premises safely. We are seriously concerned that to allow the premises to continue as a licensed premises is highly likely to see further serious crimes occurring and further harm caused to customers.

The premises licence already has numerous, strong conditions and it is worth noting that the door company was only changed in January of this year after concerns regarding the previous company, so it is apparent that this is not a satisfactory solution.

During the second Interim Steps hearing the PLH proposed, as one of the alternatives to suspension, replacing the security provider with a company called i Guard. One of the conditions on the premises licence is that security must be provided by a company who have Approved Contractor Status and according to the SIA website i Guard do not hold this accreditation so would not be able to provide security at this premises. Another company called Industry Security UK Ltd was also represented at the hearing and this company is SIA accredited, so they would be able to provide security, but not subcontract the work to a non-SIA accredited company.

GMP believe the premises unfortunately attracts some clientele who seek to cause harm and fear to others, and it has become a premises that many people gravitate towards when other premises they have been in for several hours have closed. This means that their levels of intoxication are often already very high when they go there and GMP believe that this contributes significantly to the issues arising there. Therefore, due to these serious concerns, GMP asks committee to Revoke the Premises Licence.
