Unfortunately, it is as a last resort that we must lodge this application to review the premise licence for Flamingo Restaurant and Bar. The current licence holder has shown on a number of occasions over the past five months that they are unable to promote the licensing objectives through the running of the business. Furthermore, we have no confidence, at this stage, that the licence holder and Designated Premises Supervisor would be proficient in assuring us of any improvements to ensure compliance.

In February 2022 the premises licence was granted to Mr Samsom Kahsay for the use of a restaurant and bar. However, a mere 2 months later, whilst on proactive monitoring in the area in April 2022 the premises was found to be operating as a 'Shisha Bar'.

Following a full licence inspection, breaches of conditions were identified, and steps agreed to rectify this. During this inspection breaches of the Health Act was also discussed with Mr Kahsay and was made clear that this must seize with immediate effect. Unfortunately, a matter of weeks later The Licensing and Out of Hours Team began to receive noise complaints regarding the premises.

Several visits, both proactive and call out responses have been made to the premises between May and September 2022 regarding noise break out, dispersal concerns, breaches of The Health Act and opening beyond their permitted hours. Despite the intervention and support of both Manchester City Council's Licensing Out of Hours Team the premises is still unable or unwilling to comply with its licence. The Licensing and out of hours team still continue to receive noise complaints regarding loud music from the premises and to date have 10 complainants.

A Pre Review meeting was held with Mr Kahsay in conjunction with Greater Manchetser Police to make clear our concerns with the management of the premises and setting out our expectations in being able to uphold the licensing objectives moving forward. During this meeting Mr Kahsay offered little by the way of resolution and when pushed on the noncompliance responded that he knew what his licence outlined in terms of timings granted and conditions and that he himself trained staff but could not provide an adequate response for why the premises licence had not been complied with on multiple occasions, to which continues. During the meeting Mr Kahsay also disclosed a number of things that officers from Manchester City Council's Licensing and out of hours team and Greater Manchester Police found concerning and it was agreed that the pre review would seize due to lack of confidence. Officers made it clear that there was little if not anything that would satisfy their concerns and address the noncompliance that could be put in place in the form of an action plan.

CCTV footage was requested from Mr Kahsay on 25<sup>th</sup> August following a breach of permitted opening hours on 21<sup>st</sup> August. Despite several visits and requests this still had not been provided to officers and is in clear breach of the premises licence of the following conditions:

- A CCTV camera system capable of providing evidential quality images in all lighting conditions shall be used. Images will be retained for a period of at least 28 days and be made available to Police Officers on reasonable written request for evidential purposes, in accordance with the relevant data protection legislation (currently GDPR 2018).
- 2. The CCTV recording equipment shall be kept in a secure environment under the control of the premises licence holder (PLH) and/or another named responsible individual.

<ol><li>There shall be sufficient members of trained staff available to be able to download or view CCTV evidence with the minimum of delay at the reasona- ble request of an authorised officer.</li></ol>
In addition to the ongoing noise complaints and out of hours breaches, Mr Kahsay has now been warned on multiple occasions both verbally and in writing with regards to his repeated failure to comply with The Health Act. Officers have witnessed these breaches during call outs to the premises despite Mr Kahsay displaying "No Smoking signs" within the premises.
Licensing Out of Hours feel that there is no further support that we can extend at this point. We have attended the premises on ten occasions and are yet to see a visit that complies with their licence or regulations at the time of visit. Furthermore, the severity of what is occurring at the premise is escalating. The function of licensing is not to respond to harm once it has occurred but to make rational judgements to avert risk. We would recommend that the licence is revoked.
