Please accept this as formal notification of the Greater Manchester Police support of the Review of the Premises Licence of Flamingo Restaurant and Bar. GMP is firmly of the opinion that these premises are undermining the Licensing Objectives of the Prevention of Crime and Disorder and the Prevention of Public Nuisance.

Greater Manchester Police fully support the application by the Manchester City Council Licensing and Out of Hours team (MCC LOOH) to review the Premises Licence of Flamingo Bar and Restaurant, 6 Honey Street, Manchester.

Since the Premises Licence was granted in January 2022 there have been incidents that have resulted in Crimes which have occurred at the premises hours after the premises should have closed.

At 0436 hours on Sunday 3rd April 2022 GMP were contacted via mobile phone by a member of security at the premises who stated that they were having issues with a group of 10-12 people who were trying to get back into the premises. They stated that he thought that the crowd had taken exception to the fact that he and his colleague are white.

At 0455 hours police officers arrived at the premises and it was established that the security had told the group of males that they had to leave as the premises was closing and the group had been unhappy about it and tried to force their way back in. This made the security staff scared for their safety hence the call to GMP.

As a result of this incident a crime for Racially Aggravated Public Order has been submitted but to date none of the offenders have been traced and the crime has been closed.

At 0425 hours on Saturday 18th June 2022 GMP were contacted by a female who asked for the police but wouldn't say what for before screaming and clearing the line. The call taker could hear footsteps and noted that the caller appeared to be calling from outside. The call taker attempted to ring the caller back but the caller did not answer. The mobile phone number used was linked to an address and initially the incident was recorded at that address.

Later that morning the caller was able to be contacted and informed officers that she had been assaulted by her ex-partner in Flamingo shortly before she made the initial call because he had seen her with someone else. She stated that as a result of the assault she sustained a black eye and other bruising.

As a result of this incident a crime for ABH was submitted but after reviewing the CCTV the crime was closed as it was clear that the alleged victim was just as much to blame as the alleged aggressor.

The fact that these incidents occurred over 2 hours after the premises should have closed shows what a flagrant disregard the operators have for the hours attached to their Premises licence.

If the premises had been closed at the time it should have been closed then neither of these incidents would have been reported and police officers would not have had to dedicate time and resources to deal with them.

On Tuesday 6th September I attended a pre-review meeting at Manchester Town Hall with officers from the MCC

LOOH team and the PLH/DPS from the premises and during the meeting it became worryingly clear that the PLH/DPS had a very limited understanding of the licensing objectives and couldn't explain why the premises had				
still been open 2 hours after it should have closed. As such GMP do not believe that the PLH/DPS should be allowed to continue to hold a premises licence and we				
support the recommendation form MCC LOOH that the licence should be revoked.

I write further to your notification on 26 September 2022 relating to the above property.

The property does not have planning permission to be used as a shisha bar/restaurant. In addition, the extension to the rear they have built to facilitate this use is also unauthorised. It is highly unlikely we would support a retrospective application for the retention of the existing use or the extension, as built.

Also, colleagues in Building Control have advised that the extension to the rear is not structurally sound. It is built from combustible material within 1 metre of the boundary, which is therefore unsafe.
